For example, if a motion was passed saying that the Council had to commit to reducing greenhouse gas emissions by a certain amount, then it would have to do so. However, motions can be reviewed and changed, overtaken by events and cannot bind anyone other than the Council.

<p>This Council believes that football clubs are vital community assets, and are more than just ordinary businesses. Communities, and fans, have strong interests in clubs.</p> <p>This Council urges the football authorities, all elected representatives, Government, members of the House of Lords, all political parties and community activists to campaign to promote fan and community ownership and control of football clubs at all levels.</p> <p>This Council also encourages the reform of football governance rules to encourage fan and community ownership and control to achieve financially-sustainable clubs, rather than the failed so-called “benefactor model” that has led to administration or liquidation of clubs.</p> <p>Supporters Direct has helped supporters to secure influence and ownership of sports clubs, but due to funding cuts in 2011, it is suffering potential funding shortfalls. This Council urges the Government, football authorities and funding bodies to urgently find sustainable models of funding for Supporters Direct.</p> <p>This Council welcomes financial fair play initiatives by UEFA, the Football League and Football Conference that help sustain football clubs in the interests of the community by controlling debt and risk. This Council urges the Premier League to do the same.</p> <p>This Council believes player pay is at unsustainable levels, meaning investment in clubs and communities suffers. This Council therefore urges the football authorities, at all levels of the game, to place a limit on total spending on player transfers and wages. This limit would be a sustainable percentage (e.g. 60%) of the total revenue of each club in a financial year.</p>

This Council opposes:</p> <ul style="list-style-type: none"> ▪ The Secretary of State's proposals for the Planning Inspectorate to have powers to override agreements between Councils and developers over the number of affordable housing units allocated to planning applications. ▪ The Secretary of State's proposals for planning permission – currently required for extensions of more than three or four metres from the rear wall of any home – to only be needed for those reaching beyond 8m for detached homes and 6m for others. ▪ The Secretary of State's proposals for the Planning Inspectorate to take planning powers away from local authorities deemed to be slow or of making poor quality planning decisions in determining applications. ▪ The Secretary of State's proposals for the review of Building Regulations that will harm standards on energy efficiency, accessible access, noise, vibration, fire safety, security, ventilation, drainage and waste. <p>This Council urges the Government to listen to the concerns being expressed by the cross-party Local Government Association.</p> <p>This Council resolves to formally write to the Secretary of State for Communities and Local Government, outlining this Council's opposition to the plans.</p> <p>That Officers respond to the consultation on extending permitted development rights for Homeowners and Businesses in consultation with the Cabinet Member and Chair of the Planning and Rights of Way Panel.</p>

<p>A number of construction companies have been challenged about supporting the existence of and subscribing to construction industry 'blacklists', which detail covertly gathered information on construction trade unionism, militant tendencies, poor timekeeping, trouble making, etc. Blacklisting is an unacceptable practice and cannot be condoned. The GMB union is leading a national campaign aimed at forcing those who have been involved in blacklisting to apologise to those who have been affected by it.</p> <p>It is understood that the construction industry blacklist was collated by the Consulting Association (a private consultancy) and was then provided at a cost to construction companies as they sought to recruit/avoid new workers. The Information Commissioner has investigated and taken action against the Consulting Association for this practice. Furthermore, the Information Commissioner has taken enforcement action against a number of construction companies based on the evidence recovered from the Consulting Association.</p> <p>Owing to the concentration of construction activity in and around large cities, many of those alleged to have been discriminated against live in the country's major cities, and undoubtedly this practice has disadvantaged residents of Southampton.</p> <p>Given the known impact on residents of the Southampton area reflected in the Deputation made to the Council, this Council deplores the use of blacklisting. The Council resolves to support the GMB campaign, and will seek written assurances from its partners and suppliers that they do not use blacklisting.</p>

This Council Notes that there is little evidence to show that the Health and Social Care Act 2012 will improve the efficiency, effectiveness or value-for-money of the National Health Service. There is no credible evidence that the open competition under the Any Qualified Provider system, as promoted by the National Health Service (Procurement, Patient Choice and Competition Regulations 2013) - Statutory Instrument 257 2013, will improve the NHS. There is great alarm amongst NHS staff, patients and public - that the Act and open competition will HARM the NHS, placing almost £16m of cost on Southampton's NHS. Accordingly this Council resolves that this is an unnecessary reorganisation that the NHS does not need when it is already under huge pressures, as shown by the Francis Report, and can ill afford. It resolves to write to the Secretary of State and the Shadow Secretary of State with the outcome of this motion and it resolves to write to the Chairs of the Health and Well-Being Board and the Health Overview and Scrutiny Panel with the same.

Council condemns these reforms as unfair and counterproductive, bringing an unnecessary strain onto already squeezed resources as well as voluntary organisations who are already struggling with capacity.

Therefore, Full Council resolves to write to the Secretary of State for Work and Pensions as well as our local MPs setting out our concerns. Council also calls on the Executive to note and act upon the recommendations of the welfare reform scrutiny inquiry.

One primary reason for that substantially greater survival rate is that in Norway training in cardiopulmonary resuscitation [CPR] is compulsory in all secondary schools. This means that many more bystanders have the knowledge to assist in an emergency prior to the arrival of the emergency services.</p> <p>CPR training is simple and takes less than 30 minutes. The British Heart Foundation [BHF] has launching its ‘Nation of Lifesavers’ campaign to make CPR training a part of the curriculum in every secondary school and college. Free training kits are available and no direct teacher involvement is required, the training being essentially led by a video presentation. There is thus no financial resource requirement from the school’s budget, only a single half hour out of teaching time per year.</p> <p>Council therefore RESOLVES to support the British Heart Foundation’s ‘Nation of Lifesavers’ campaign by encouraging all secondary schools and colleges within Southampton to implement the BHF’s campaign by including CPR training within the curriculum.</p> <p>Council recognises the need to train people – particularly young people - in the skills needed to step in and help in an emergency. This crisis is getting worse as a direct consequence of increased demand for Council-commissioned care services due to an ageing population and the negative impact of welfare reforms on vulnerable working age adults and their families. The problem is further compounded by the year-on-year Government reductions in Council finances since 2010 – with places like Southampton, hit particularly hard.

This Council accepts that local authority social care services up and down the country have reached a tipping point with some County Councils – like Northamptonshire, Somerset and West Sussex – facing bankruptcy. Moreover the social care funding crisis also threatens our valued NHS as we celebrate its 70th anniversary. For too long have governments – of all colours – put off meaningful action to address the chronic underfunding of our social care system and we look forward later this year to receiving a (thrice delayed) Government Green Paper on adult social care. We applaud the Local Government Association initiative in producing its own Green Paper for adult social care and wellbeing 'The Lives We Want to Lead' and the local response to this by the City's Health & Wellbeing Board and other partners

This Council urges the Government to commit to long-term funding for adult social care services along the same lines as for the NHS – i.e. free at the point of need and funded through general taxation. In recognition that a commitment of this magnitude may take time to fully implement, we call on the Government to avert the pending crisis in adult social care (requiring £3.56 billion more by 2025 just to stand still) by ensuring an immediate injection of an extra £2 billion to England's local authorities in the autumn statement specifically for health and social care. This Council urges the City's three MPs to make urgent representations to the ministers of state for care and public health (both Hampshire MPs) to ensure that Southampton receives a fair funding deal from Government in order to deliver its statutory care and health responsibilities.

This is bad for them in the short and long term and our children deserve the best possible start in life.
