SUMMARY

The purpose of this report is to set out proposed changes to the Budget and Policy Framework Procedure Rules which form part of the Constitution.

The changes take into account the recent changes made to Scrutiny within the Council and the fact that the Council now has a party with an overall majority which will impact on the way in which the budget is prepared by the Executive compared to previous years.

REASONS FOR REPORT RECOMMENDATIONS

1. The Budget and Policy Framework Procedure Rules (B&PF) is a key document in the Council's Constitution which regulates the governance arrangements applicable to the Policy framework plans and their approval,

and the setting of the Council's budget. It is appropriate to keep this under review.

2. The Solicitor to the Council and Executive Director of Resources have been consulted during the preparation of this report.

ALTERNATIVE OPTIONS CONSIDERED AND REJECTED

3. Various options and models can be applied to the B&PF taking into account the circumstances within the Council and the most appropriate arrangements recommended by the Monitoring Officer and the Section 151 Officer.

DETAIL

- 4. The Budget and Policy Framework Procedure Rules (B&PF) form part of the Constitution and set out the way in which the Executive and the Council must act and the steps both must take in developing the annual Budget and key policy framework documents during the year.
- 5. The B&PF is reviewed and amended as part of the review of the Constitution annually at the AGM, and also when appropriate to reflect as appropriate the fact that different processes are necessary given the changing political balance of the Council.
- 6. Following the elections in May and the fact that there is now a majority party within the Council for the first time in many years, the B&PF has been reviewed by the Section 151 Officer following consultation with the Cabinet Member for Resources and an amended version is put forward for approval at Appendix 1.
- 7. The key changes that are reflected in the revised version are:
 - Changes to the budget process to take account of the new role of Scrutiny as approved at Council in May
 - Deletion of the requirement to agree the budget process with all Resources Spokespersons
 - Deletion of the requirement to produce and publish an Officer Forecast
 - Introduction to replace the removal of the officer forecast from the process - of early publication of the Executive's major Budgetary Proposals
- 8. These changes will help to streamline the budget process and move it towards one which is led by the executive, who legally have the obligation of recommending a budget to Full Council, allowing for consultation and feedback as appropriate.
