SUMMARY

The Council, as Licensing Authority, needs to put in place a detailed scheme of delegation in order to discharge its duties and powers under the Gambling Act 2005 in an effective and professional manner. An initial scheme based on the Government's basic model was agreed by full Council on 15th November 2006. Further regulations and guidance have been received since that date which requires further honing of the scheme.

RECOMMENDATIONS:

(i) That the Committee resolve to adopt the Scheme of Delegation in respect of matters under the Gambling Act 2005 as attached at Annex 1 with immediate effect

REASONS FOR REPORT RECOMMENDATIONS

2. There has been no formal consultation. The proposal is based on both Statutory Guidance received from the Department of Culture, Media and Sport (DCMS) and after discussions with colleagues in other Licensing Authorities and external solicitors.

3. The Committee could decide not to adopt the proposals in which case each and every time a matter falling under that area requires determination a committee meeting will need to be convened. It is not considered that this is either a cost effective or practical option. All contentious matters will still be considered by the committee save in respect of vexatious, frivolous or irrelevant representations which will fall to the Solicitor to the Council to consider as with the Licensing Act. To date under that Act no contentious matters have had to be determined.

This has been developed further in light of more information which is available, and secondary legislation being promulgated.
