#### 47. APOLOGIES AND CHANGES IN PANEL MEMBERSHIP

# 49. FORWARD PLAN

**RESOLVED** that the Committee made the following recommendations to the:

- that the Government's Small Business Guarantee Scheme be offered and promoted as widely as possible to encourage its take-up by local businesses;
- that short term relief for businesses from business rates be considered:
- that the expansion of the local banking partnership be considered;
- that the possibility for the Authority to assist in the completion of more new homes within the City be investigated; and
- that the Authority explore the opportunity to make use of vacant properties in the City.

# 50. <u>SAFE CITY PARTNERSHIP, STRATEGIC ASSESSMENT AND PARTNERSHIP PLAN 2009-2012</u>

#### **RESOLVED**

- (i) that investigations should be carried out to find out what action other local authorities, such as Nottingham City Council, have successfully taken to reduce the incidence of alcohol related anti-social behaviour within their areas;
- (ii) that the enforcement opportunities be explored for Trading Standards and the Licensing Department with reference to the Licensing Act 2003 to constrain the sale of alcohol;
- that there should be a focused alcohol awareness education programme for secondary school pupils, targeted at children who are at risk of alcohol misuse or offending; and
- (iv) that details be forwarded to Members of the Overview and Scrutiny Management Committee of actions contained within the Children and Young People's Plan, such as the provision of nurture groups, which will support children and families who are considered to be at risk from alcohol misuse or other related "hidden harms".

#### 51. GENERAL FUND REVENUE AND CAPITAL BUDGETS AND COUNCIL TAX

(iv) that the funding opportunities available within the market place for fixed term, low rate borrowing be fully investigated by the Council.

- (i) that the support of the Primary Care Trust be sought in carrying out a health monitoring exercise in Southampton schools;
- (ii) that the draft Children's and Young People's Plan should include under priority 2, in the section "What we want to achieve" the need to improve the skills and understanding of parents, carers and professionals working with children of the parenting process;

- (iii) that the reference to "new ways of working" under priority 10 in the Children and Young People's Plan be clarified;
- (iv) that the Executive publish a list of key priorities within the plan; and
- (v) that the actions required to respond to the recent Ofsted Annual Performance Assessment (APA) should be reflected within the targets and performance measures included within the final version of the Children's and Young People's Plan.
- (vi) that the results of the APA should form the basis of a future scrutiny inquiry to replace the proposed investigation into the transfer of Learning and Skills Council funding for 16-18 year olds to the Council within the current inquiry programme, with Councillor Stevens drafting outline Terms of Reference for this review.
