### **Disclosure of Interests**

Members are required to disclose, in accordance with the Members' Code of Conduct, *both* the existence *and* nature of any "personal" or "prejudicial" interests they may have in relation to matters for consideration on this Agenda.

### Personal Interests

A Member must regard himself or herself as having a personal interest in any matter

- if the matter relates to an interest in the Member's register of interests; or (i)
- (ii) if a decision upon a matter might reasonably be regarded as affecting to a greater extent than other Council Tax payers, ratepayers and inhabitants of the District, the wellbeing or financial position of himself or herself, a relative or a friend or:-
  - (a) any employment or business carried on by such person;
  - (b) any person who employs or has appointed such a person, any firm in which such a person is a partner, or any company of which such a person is a director:
  - (c) any corporate body in which such a person has a beneficial interest in a class of securities exceeding the nominal value of £5,000; or
  - (d) any body listed in Article 14(a) to (e) in which such a person holds a position of general control or management.

A Member must disclose a personal interest.

### **Prejudicial Interests**

Having identified a personal interest, a Member must consider whether a member of the public with knowledge of the relevant facts would reasonably think that the interest was so significant and particular that it could prejudice that Member's judgement of the public interest. If that is the case, the interest must be regarded as "prejudicial" and the Member must disclose the interest and withdraw from the meeting room during discussion on the item.

It should be noted that a prejudicial interest may apply to part or the whole of an item.

Where there are a series of inter-related financial or resource matters, with a limited resource available, under consideration a prejudicial interest in one matter relating to that resource may lead to a member being excluded from considering the other matters relating to that same limited resource.

There are some limited exceptions.

<u>Note:</u> Members are encouraged to seek advice from the Monitoring Officer or his staff in Democratic Services if they have any problems or concerns in relation to the above.

### **Principles of Decision Making**

All decisions of the Council will be made in accordance with the following principles:-

- proportionality (i.e. the action must be proportionate to the desired outcome);
- due consultation and the taking of professional advice from officers;
- respect for human rights;
- a presumption in favour of openness, accountability and transparency;
- setting out what options have been considered;
- setting out reasons for the decision; and
- clarity of aims and desired outcomes.

In exercising discretion, the decision maker must:

- understand the law that regulates the decision making power and gives effect to it. The decision-maker must direct itself properly in law;
- take into account all relevant matters (those matters which the law requires the authority as a matter of legal obligation to take into account);
- leave out of account irrelevant considerations;
- act for a proper purpose, exercising its powers for the public good;
- not reach a decision which no authority acting reasonably could reach, (also known as the "rationality" or "taking leave of your senses" principle);
- comply with the rule that local government finance is to be conducted on an annual basis. Save to the extent authorised by Parliament, 'live now, pay later' and forward funding are unlawful; and
- act with procedural propriety in accordance with the rules of fairness.

### 33. <u>APPLICATION TO VARY A PREMISES LICENCE AT WESTGATE HALL,</u> <u>WESTGATE STREET, SOUTHAMPTON SO14 2AY</u>

The Sub-Committee considered the report of the Solicitor to the Council detailing an application to vary a premises licence in respect of Westgate Hall, Westgate Street, Southampton SO14 2AY. (Copy of report circulated with agenda and appended to signed minutes).

Ms Cassy, Dr Hale and Mr Comben (Local Residents) were present and, with the consent of the Chair, addressed the meeting.

The Sub-Committee considered the decision in confidential session in accordance with Licensing Act 2003 (Hearings) Regulations 2005.

The Sub-Committee noted the following amendment to the operating schedule submitted by the applicant at the hearing: Section O (Hours premises are open) - amended to Monday to Sunday 09:00 to 23:00.

**RESOLVED** that the application to vary a premises licence in respect of Westgate Hall, Westgate Street, Southampton SO14 2AY be granted as set out in the report, subject to the mandatory conditions contained within the Licensing Act 2003 and such conditions relating to the statutory licensing objectives as are deemed necessary and consistent with the operating schedule subject to the following amendments:-

- the permitted hours of operation in respect of Section A (Performance of plays), Section B (Exhibition of films), Section E (Performance of live music), Section F (Recorded music), Section G (Performance of dance), Section H (Anything of a similar description to that falling within E, F or G), Section I (Provision of facilities for making music) and Section J (Provision of facilities for dancing), Section K (Provision of facilities for entertainment of a similar description to that falling within I or J), Section) be 09:00 to 22:30;
- (ii) the permitted hours of operation in respect of Section M (supply of alcohol) be 10:30 to 22:00 Monday to Sunday; and
- (iii) the permitted hours of operation in respect of Section O (Hours premises are open) be amended to Monday to Sunday 09:00 to 22:30.

### **REASONS FOR DECISION**

After careful consideration of all representations made, both written and oral, giving due regard to the Licensing Act 2003, the Licensing Objectives, statutory guidance and the adopted Statement of Licensing Policy, with particular regard to the potential for noise nuisance resultant from the extension of hours for the provision of regulated entertainment, the introduction of the sale of alcohol and the provision of facilities for dancing; the Sub-Committee was satisfied that the proposed licensable activities would lead to an increase in public nuisance if the application were granted as applied for.

The Sub-Committee had particularly noted the close proximity of residents and the potential for disturbance from those entering and leaving the premises in order to smoke and generally access the premises and was satisfied in the light of residential objections that the premises were located within a predominantly residential area.

Human Rights legislation had been taken into account whilst making the decision and it was felt that the licence as granted represented a fair balance between the applicant and interested parties.

### Legal Implications

 The Licensing Act 2003 specifically restricts the grounds on which the Council, as Licensing Authority (LA), may refuse an application for a new Premises Licence, or impose conditions. Where relevant representations are made, the LA may refuse on the grounds that the licensing objectives are not met or the operating schedule is inadequate. Equally, conditions may be imposed where relevant and necessary. The LA may also refuse an application in part and thereby only permit some of the licensable activities sought.

- 2. The decision making committee, in considering an application, must have regard to the adopted Statement of Licensing Policy and any relevant representations made by those directly affected.
- 3. An applicant for a new Premises Licence whose application has been refused, or who is aggrieved by conditions imposed, may appeal against the decision to the Magistrates' Court.
- 4. In considering this application the committee will sit in a quasi-judicial capacity and is thus obliged to consider applications in accordance with both the Licensing Act 2003 (Hearings) Regulations 2005, and amending secondary legislation and the rules of natural justice. The practical effect of this is that the committee must makes its decision based on evidence submitted in accordance with the legislation and give adequate reasons for reaching it's decision.

The committee must also have regard to:-

5. Crime and Disorder Act 1998

Section 17 of the Crime and Disorder Act 1998 places the Council under a duty to exercise its various functions with due regard to the likely effect of the exercise of those functions on, and the need to do all that it reasonably can to prevent, crime and disorder in its area.

6. Human Rights Act 1998

The Act requires UK legislation to be interpreted in a manner consistent with the European Convention on Human Rights. It is unlawful for the Council to act in a way that is incompatible (or fail to act in a way that is compatible) with the rights protected by the Act. Any action undertaken by the Council that could have an effect upon another persons Human Rights must be taken having regard to the principle of Proportionality - the need to balance the rights of the individual with the rights of the community as a whole. Any action taken by the Council which affect another's rights must be no more onerous than is necessary in a democratic society. The matter set out in this report must be considered in light of the above obligations.



The Chief Constable has delegated authority to all Operational Command Unit Commanders within Hampshire Constabulary in respect of his responsibilities under the Licensing Act 2003. The OCU Commander, Chief Superintendant Greening has further delegated this responsibility to the Licensing Sergeant for Southampton.

The police are objecting to this application. For the reasons outlined below I am of the opinion that the proposed measures are not currently adequate or specific in their detail and would undermine the prevention of crime and disorder in the licensing objective.

The current operating schedule states that a CCTV system with a recording facility will be in place. The photos of the layout, which have been provided by the applicant are not current. The shop has been gutted in readiness for a complete refit. The floor plan is basic and I am unable to determine if the proposed CCTV would be suitable. The applicant states the CCTV system will record 24 hours a day and a library which can be made available to the police if required. This document is not clearly defined as being part of the operating schedule and is less than specific.

I require more detail to adequately address the prevention of crime and disorder licensing objective and suggest that the CCTV system fitted should satisfy the following condition considered as such by SCC namely –

"A CCTV system shall be installed and maintained in the licensed premises to the satisfaction of the Licensing Authority and Hampshire Constabulary. As a minimum, it shall enable surveillance of both external and internal areas of the premises including entrances and exits. Recordings from the system shall be of a quality acceptable as evidence in a court of law and shall be securely retained at the licensed premises for a minimum period of 30 days after the recording, and shall be surrendered to Hampshire Constabulary or the Licensing Authority immediately on request."

The applicant is applying to operate a "night hatch facility" between 2300 hrs and 0600 hrs". To conform with other 24hrs garages within the city, we should standardize the wording as -

"The entrance door to the shop will be closed to customers between the hours of 2300 and 0600. Any sales between these hours will be made through the night pay window."



We feel that such an application is unacceptable and is highly likely to cause further disruption and disturbance to our neighbourhood. We are extremely concerned that these premises will attract individuals and groups en route from a social event who may already have consumed alcohol leading to an increased possibility of anti social behaviour. We are already subject to large groups gathering on the forecourt of the garage late at night and have witnessed fights breaking out and the police being called on numerous occasions.

In addition, we have a public house located very near the service station with an extended licence for alcohol and music. The old Shell petrol station (now Texaco) in Portsmouth Road has applied for a 24 hour licence to sell alcohol.

I would like to object for several reasons. The site is almost central to 4 first schools: Ludlow, Woolston, St Monica and Newtown Road. There is a comprehensive 5 minutes walk away, and another secondary school further up Portsmouth Road. This site has always been a well known place for youngsters to buy cigarettes, and I fear that the same may become true for alcohol. These garage premises have been the place of much police activity after late hours drunken behaviour from passing pedestrians. Within a five minute walk of these premises are 2 shops that sell alcohol between their opening hours of 8am to 8pm, which is already sufficient for the area.

The garage is situated on a very busy main road. I anticipate drunken behaviour can only cause more accidents.

The garage is surrounded by residential premises and appears to be a totally unsuitable site for any alcoholic sales, or indeed any all night opening. When I moved here the garage was not open for 24 hours in the day. I'm really upset by the fact that garages appear to be able to change their opening hours, without having to apply for a licence.

I doubt if the police authorities would encourage the sale of alcohol from this shop.

On a personal note I am constantly annoyed by late night revellers who stop and party on the forecourt. During the summer months this continues into the early hours of most weekends. I'm aware that the council run an out of hours noise nuisance phone number, but I'm sure they are already overworked. I would like to comment on the above application, which would lead to the potential sale of alcohol around the clock at the Texaco filling station in Portsmouth Road, Woolston.

While it is encouraging for the business to have a makeover, and to seek to increase its product line, I would urge the licensing committee to consider the views of residents nearby before granting an application.

Members may wish to note that Woolston is a residential area and not the kind of neighbourhood where a 24-hour supply of alcohol would be expected. The garage also stands next to a busy road, so it might not be the best place for people who have had 'one too many' to go and buy 'one for the road' as this would be a more dangerous place than most for people under the influence of excess alcohol. Especially if they're driving...

The garage's commitment to put full ID checking in place is to be commended, and they should be able to stock products to help the business thrive. However, on the grounds of public safety and possible disturbance to nearby residents, the potential sale of alcohol 24 hours a day, seven days a week, is perhaps a step too far.

If the committee is still minded to approve the licensing application, then they may also wish to consider if keeping sales to more conventional licensing hours (ie ceasing at 11pm or on Sundays at 10.30pm) would be more appropriate.

In respect of the above application, my wife and myself wish to register our objections to it being granted. Our reasons are listed below.

1. Alcoholic and other Drinks

The effects of excessive alcohol intake are well known and undeniable. Bottles and cans will be strewn on streets, pavements and in private properties (gardens) In the case of bottles these will invariably be broken – causing hazards to pedestrians, vehicle drivers, and in gardens pets and other animals.

2. Food

Unfinished food together with wrappings, will be strewn on streets, pavements and private properties attracting animals and insects, resulting in an increased risk of disease. There will also be a risk of pedestrians slipping and/or falling and injuring themselves – which could well result in legal action against the garage owners and/or Southampton City Council.

3. School

Approximately a quarter of a mile is an Academy School (Woolston). Knowledge that food and drinks can be obtained continuously throughout the school day will not only act as a magnet for the pupils but will further increase the risk of litter and associated problems – as detailed above.

4. Noise

Those under the influence of alcohol invariably talk noisily and are more likely to be raucous in their behavior. Almost without exception on a Friday and Saturday night we can hear people walking? home from (town?) being very noisy, singing and shouting. Invariably, the following morning remains can be found of unfinished food dumped on the pavement together with wrappings, bottles and cans. An additional source of alcohol en-route can only aggravate the situation.

In connection with this point almost opposite the garage is a public house. Although we hear the music from the bands they hire; generally the clients leave reasonably quietly and in a reasonable manner. We assume that the tenants/owners of the public house are fully aware of this application and will be forwarding their own objections/comments.

5. Police

Should this application be granted we consider that it will only be a matter of time before the Police become involved in an "incident". As the Police are already looking at government cut backs, I would presume that that the last thing they wanted was another source of possible additional work.

#### 6. Appearance

Are those making the application willing to "clean up" not only their own forecourt, but also the adjacent streets, pavements and where necessary private property. We seriously doubt it.

We already experience drunken brawls, fights and trespassing on our property after the Swan Public House closes. The Public House was granted an extension to its licence by the council some months ago.

The trespassing was early July which was reported to Hampshire Police. A group of drunks were climbing on our hedge and rolling on it. There have been numerous brawls. I recall the end of June paramedics being called out because a man was attacked with a broken bottle by another. With incidents like this and granting a 24 hour licence to the garage will only escalate the problems we already **have** to live with.

We are constantly picking up bottles and litter from our path and believe me when I say our lives will become intolerable if this is granted.

I wish to register my objections to the proposal for a licence to be granted for the sale of alcohol 24 hours a day, 7 days a week and for the sale of refreshment between 11pm and 5am.

- 1. There is no need for another outlet for the sale of alcohol, and with this proposed licence being for 24 hours a day, there will be a number of problems. Unfortunately many people do not seem to know when they have drunk enough and there will be the problems with noise, cans being thrown around and bottles being thrown about and smashed. There will then be problems for residents, pedestrians, vehicle drivers and pets.
- 2. Food. There is a very high chance that leftover food will be strewn about on the streets, pavements and in nearby gardens. As there is a very high likelihood that food will be vomited over pavements, the road and into nearby gardens the will cause other problems. Will the owners/managers of this outlet be clearing up the mess or will polystyrene containers and wrappers be left to blow about and make the area look very tacky.
- 3. Noise will be a problem as it is unlikely that the probable consumers will be aware of how much noise carries at night and how close residential properties are to this business, and will they really care. There is enough noise from The Swan public house when they have their bands playing. I can hear this in my house/garden now. Do I want more?



- 4. In view of proposed cuts in public services, and in particular the police, I cannot imagine they will welcome yet another outlet selling alcohol 24 hours a day, with all the problems that can come with it, e.g. vandalism, fights, assaults, etc.
- 5. As the Oasis Academy is just a short distance away I can see that this is going to be a magnet for the pupils. No doubt they will say that they only want 'soft drinks', but what a temptation to try and buy alcohol when on the site. Will the owners/managers carry out the terms of the licence and not sell to people who are under age or will the temptation be too great. I know that checks are sometimes carried out to make sure this does not happen, but there is always someone who is "daft" enough to buy alcohol for them.

As there has been problems at the business in the past requiring police involvement, I'm not at all happy about a business on this site. Even now me and a number of friends and neighbours will not buy petrol there unless we use cash, never cards, and will only use the petrol station if we absolutely have to.

# Is it too much to ask that a residential area should stay just that, and that we can live our lives in peace and quiet?

Please consider all these points very carefully before making a considered decision.

We wish to lodge an objection to the above application on the following grounds.

First, we cannot see any way that this application would benefit the local community.

If, as we assume they would have done, Global Fuel (UK) had carried out a thorough market research, they would have found that this is a largely residential area with mainly family homes, schools and a number of Residential Care Homes in the immediate vicinity of the Petrol Station application under consideration – not the sort of community which is likely to want, need or expect a 24 hour supply of alcohol, seven days a week. Most of the family homes have one or more adult in employment and many have school aged children all of whom have the right to expect a peaceful and uninterrupted night's sleep, if they are to perform effectively and safely during the day at work and school. This proposal could deny them that right.

We already suffer almost constant disturbance at week-ends (from Thursday through to Monday a.m. sometimes up to 4:00 a.m.) from people somewhat the worse-forwear from alcohol, having left the pubs and clubs of the City Centre, and filtering their way home via Woolston. This application is likely to extend this throughout the week, with the Petrol station acting as a magnet for those in search of yet more alcohol.

Second, safety. The location is next to a busy road. The people, mentioned above, who may already have had more than enough alcohol, will be congregating outside the premises and possibly spilling onto the road. Also, as possibly, the only premises in the area offering the all-night sale of alcohol, it may attract other people (e.g. drivers) from further afield. With more traffic entering/leaving the premises and people congregating in and around the forecourt, the potential for accident is significant. It will also increase the noise and disturbance, with cars coming and going; car doors slamming; engines revving. If the statistics are correct, it will do nothing to reduce the incidents of driving while under the influence of drink & drugs.

Third, vandalism. The people mentioned in the previous paragraph have been responsible for a considerable amount of damage to properties along Portsmouth Road, including our property which has suffered extensive damage to the perimeter wall and more recently a beer bottle thrown through the greenhouse. With all-night sales of alcohol and food until 5:00 a.m. instead of making their way home, these

people may be encouraged to loiter, increasing the likelihood of disturbance and more vandalism.

The property adjacent to and associated with the Petrol Station (occupied by the previous owner/manager) was the subject of continual attack, by, one assumes, disgruntled customers or those responsible for the vandalism previously mentioned. This property is an eyesore in that the windows to the front of the property are constantly being broken and the police are often in attendance. Will Global Fuel (UK) be liable for damage caused to our property by their customers?

Fourth, littering. With the availability of extra alcohol and late-night food, the likelihood is that both will be consumed "on-the-hoof" with the packaging discarded wherever the consumers happened to have reached when they have finished, or had their fill. We already spend much of our week-end mornings picking up half empty beer cans and bottles dropped into our front garden. Will Global Fuel (UK) provide litter clearing teams as we believe fast-food outlets in the City Centre are expected to do?

We strongly believe that granting of this licence would lead to an increase in public nuisance, crime and disorder and would do nothing to enhance public safety.

In conclusion, we believe that granting of this premises licence would be in breach of our rights under the Human Rights Act 1998, 1<sup>st</sup> Protocol, Article 1: Protection of Property "The right to the peaceful enjoyment of your property"

My name is Leonard Young and I live at 213 Portsmouth Road, directly opposite the petrol station. I would like to object to the application on the grounds of the prevention of public nuisance.

I am 82 years old and I have lived at the address for over 40 years. I have suffered from cancer, blindness and the death of my wife. I would like a peaceful life in my house. It was a pleasant location but I have experienced a specific increase in the level of noise and disturbance since the Swan public house was granted a late licence. I frequently hear noise, fights and arguments late into the night, as people leave the pub. They urinate in my front garden and I have has to chase away drunken couples from my premises. I would like to object to the above application for 24hr alcohol licence at 170 Woolston Road.

The basis of objection is:-

- 1) I have had several instances of vandalism and criminal damage at my property already. These instances have been carried out by people walking along the pavement and are what could be described as mindless acts of vandalism. They include the destruction of wall mounted statues and the breaking and theft of wall lights on three occasions. The cost of this has been substantial. On all occasions this has been reported to the police whose response has been totally inadequate; either not turning up, or arriving several days later. If this licence is granted the area will generate more such acts which the council is not currently able to fund the policing for prevention of. Future proposed cost cutting will naturally affect the existing situation adversely.
- 2) The street lighting in the area is currently inadequate and if more vehicle and pedestrian traffic is generated for the reason of people buying alcohol 24hrs then the lighting must be appropriately improved to provide proper visibility and deterrent to would-be wrong doers.
- 3) Late night vehicle and pedestrian traffic will encroach significantly on the peace of the area.
- 4) The cost of the necessary steps (lighting, policing, cctv coverage etc,) to ensure the safety and security of local residents will be significant. Current proposed cost cutting of services is already a major concern in this area as services are not adequate as they stand.
- 5) Having such 24hr availability of alcohol will attract the wrong type of people to the area, which is essentially a quiet residential community and should remain as such.
- 6) Late night drinking and access to alcohol is available in the city and I question the need to have such availability at the proposed site.

In summary I oppose the application most strongly and ask that it is rejected.

- There already exist an adequate number of retail outlets for alcohol in the Bitterne, Woolston, Sholing area, many of which are open into the late evening.
- The sale of alcohol through the night at a filling station is not conducive to keeping our roads free of "drink drivers".
- Woolston Service Station is located in an area which is primarily residential and an all night retail outlet will lead to added disturbance for folk sleeping in their own homes.
- Currently there is some disturbance resulting from the noise made by folk going home after closing time at the Public House a few metres along the road from the Service Station, but this is accepted as the Public House was there and trading when we moved into this house 34 years ago, and it operates reasonable opening hours.
