The minimum number of appointed Members required to be in attendance to hold the meeting is 3.

#### **Disclosure of Interests**

Members are required to disclose, in accordance with the Members' Code of Conduct, **both** the existence **and** nature of any "personal" or "prejudicial" interests they may have in relation to matters for consideration on this Agenda.

#### **Personal Interests**

A Member must regard himself or herself as having a personal interest in any matter

- (i) if the matter relates to an interest in the Member's register of interests; or
- (ii) if a decision upon a matter might reasonably be regarded as affecting to a greater extent than other Council Tax payers, ratepayers and inhabitants of the District, the wellbeing or financial position of himself or herself, a relative or a friend or:-
  - (a) any employment or business carried on by such person;
  - (b) any person who employs or has appointed such a person, any firm in which such a person is a partner, or any company of which such a person is a director:
  - (c) any corporate body in which such a person has a beneficial interest in a class of securities exceeding the nominal value of £5,000; or
  - (d) any body listed in Article 14(a) to (e) in which such a person holds a position of general control or management.

A Member must disclose a personal interest.

## **Prejudicial Interests**

Having identified a personal interest, a Member must consider whether a member of the public with knowledge of the relevant facts would reasonably think that the interest was so significant and particular that it could prejudice that Member's judgement of the public interest. If that is the case, the interest must be regarded as "prejudicial" and the Member must disclose the interest and withdraw from the meeting room during discussion on the item.

It should be noted that a prejudicial interest may apply to part or the whole of an item.

Where there are a series of inter-related financial or resource matters, with a limited resource available, under consideration a prejudicial interest in one matter relating to that resource may lead to a member being excluded from considering the other matters relating to that same limited resource.

There are some limited exceptions.

<u>Note:</u> Members are encouraged to seek advice from the Monitoring Officer or his staff in Democratic Services if they have any problems or concerns in relation to the above.

## **Principles of Decision Making**

All decisions of the Council will be made in accordance with the following principles:-

- proportionality (i.e. the action must be proportionate to the desired outcome);
- due consultation and the taking of professional advice from officers;
- respect for human rights;
- a presumption in favour of openness, accountability and transparency;
- setting out what options have been considered;
- · setting out reasons for the decision; and
- clarity of aims and desired outcomes.

In exercising discretion, the decision maker must:

- understand the law that regulates the decision making power and gives effect to it. The decision-maker must direct itself properly in law;
- take into account all relevant matters (those matters which the law requires the authority as a matter of legal obligation to take into account);
- leave out of account irrelevant considerations;
- act for a proper purpose, exercising its powers for the public good;
- not reach a decision which no authority acting reasonably could reach, (also known as the "rationality" or "taking leave of your senses" principle);
- comply with the rule that local government finance is to be conducted on an annual basis. Save to the extent authorised by Parliament, 'live now, pay later' and forward funding are unlawful; and
- act with procedural propriety in accordance with the rules of fairness.

## Legal Implications

- 1. Part 3 of the Licensing Act 2003 provides that a responsible authority of a resident or business in the vicinity (interested party) may apply for review of a premises licence.
- 2. The grounds of review applications must relate to one or more of the licensing objectives.
- In such circumstances, the applicant for the review must serve a copy of the review application on the holder of the premises licences, the City Council and each of the responsible authorities.
- 4. On receipt of the application for review, the officers will consider its validity, under delegated powers. Reasons for rejection, in whole or in part, include:
  - that the grounds for review are not relevant to one of more of the licensing objectives and;
  - (in the case of an application not made by a responsible authority), that the application is frivolous, vexatious or repetitious.
- 5. The City Council must, within one day of receiving the application for review, display a prescribed notice of the review application on the outside or adjacent the premises; the notice must remain on display for 28 days and any interested party in the vicinity or the responsible authorities may make representations in that period.
- 6. Unless the applicant, licence holder, interested parties and responsible authorities agree that a hearing is unnecessary, the City Council is then required to hold a

- 7. The sub-committee, in considering the application for review, must have regard to the adopted Statement of Licensing Policy and evidence before it at the hearing.
- 8. The Licensing Act 2003 provides that, in determining an application for review, the sub-committee may take any (or none) of the following steps, as it considers necessary:
  - modify the conditions of the licence;
  - exclude a licensable activity from the scope of the licence;
  - remove the designated premises supervisor;
  - suspend the licence for a period not exceeding three months;
  - revoke the licence.
- 9. The Licensing Act 2003 makes provision for appeal to the Southampton Magistrates' Court against the sub-committee's decision in relation to an application for review.
- 10. In considering this application the sub-committee will sit in a quasi-judicial capacity and is thus obliged to consider applications in accordance with both the Licensing Act 2003 (Hearings) Regulations 2005, and amending secondary legislation and the rules of natural justice. The practical effect of this is that the sub-committee must makes its decision based on evidence submitted in accordance with the legislation and give adequate reasons for reaching its decision.
- 11. Copies of the application for review and the Police objection are annexed to this report.
- 12. The sub-committee must also have regard to:-
- 13. Crime and Disorder Act 1998

Section 17 of the Crime and Disorder Act 1998 places the Council under a duty to exercise its various functions with due regard to the likely effect of the exercise of those functions on, and the need to do all that it reasonably can to prevent, crime and disorder in its area.

## 14. Human Rights Act 1998

The Act requires UK legislation to be interpreted in a manner consistent with the European Convention on Human Rights. It is unlawful for the Council to act in a way that is incompatible (or fail to act in a way that is compatible) with the rights protected by the Act. Any action undertaken by the Council that could have an effect upon another person's Human Rights must be taken having regard to the principle of proportionality - the need to balance the rights of the individual with the rights of the community as a whole. Any action taken by the Council which affect another's rights must be no more onerous than is necessary in a democratic society. The matters set out in this report must be considered in light of the above obligations.



The Prevention of Crime and Disorder

Public Safety

Protection of children from harm

On 12<sup>th</sup> July 2010 counterfeit vodka was found at London Off Licence 2, 27 St Catherines Rd. Southampton.

Counterfeit vodka has increasingly been found by Trading Standards Officers around the country. It is often produced from industrial alcohol which is imported into the UK. It is diluted and packed in bottles which are copies of a variety of brands. Clearly controls over the quality of the product are not as strict as would be found at a distillery producing the genuine product, and issues have been reported regarding excessive levels of methanol being present, which is poisonous.

Paragraph 11.26 of the October 2010 Amended Guidance Issued Under Section 182 of the Licensing Act 2003 states that "there is certain criminal activity that may arise in connection with licensed premises, which the Secretary of State considers should be treated particularly seriously." Which includes "the use of the licensed premises for the sale of smuggled tobacco and alcohol". It is highly unlikely that duty would have been paid on the counterfeit vodka.

It is considered that the holder of the premises licence has not fufilled the duty under the Licensing Act 2003 to prevent crime and disorder and to protect public safety. We are therefore applying to review the licence.

In the supporting information we give more details and state the conditions we would wish to see added to the licence in order to promote the above licensing objective.

Please provide as much information as possible to support the application (please read guidance note 2)

On 12th July 2010 I conducted a routine inspection at London Off Licence 2, 27 St Catherines Rd, Southampton. During the inspection I examined a 70cl bottle of Glen's brand vodka. The vodka contained white floating particles, the labels were not straight and were peeling from the bottle. A label adjacent to the bottle stated that it had been reduced in price, from £11.49 to £9.99. I believed that the vodka might be counterfeit so I took it as a sample (sample reference 012071). The public analyst subsequently confirmed that it was not genuine Glen's Vodka (Certificate of Analysis exhibit LM/1). I also have a statement from Tom Taylor, Quality Manager of Glen Catrine Bonded Warehouse, who confirms that, from the markings on the bottle sampled, the Glen's Vodka is counterfeit. A case of 6x70cl Glen's vodka which appeared genuine was also found during the inspection, along with a Batleys Cash & carry receipt, dated 19<sup>th</sup> June 2010, which itemised a case of 6 x 70cl Glen's vodka.

On 1<sup>st</sup> November 2010 I conducted a recorded interview with Imam Ekinci, the Premises Licence Holder at London Off Licence 2. His son, Ozkur Ekinci, who is a director of Rinkhill Ltd, the company which trades as London Off Licence 2 and the Designated Premises Supervisor, was also present.

During interview Imam stated that drinks are only purchased from three wholesalers: Bookers, Eastenders Cash & Carry and Batleys Cash & Carry. It is extremely unlikely that major wholesalers would sell counterfeit vodka. Many traders who I speak to claim to have been offered cheap alcohol and cigarettes by itinerant traders, "white van man", and I suspect that Imam Ekinci purchased the counterfeit vodka from such a trader, whilst also buying genuine product from wholesalers. Initially the Ekincis claimed that the counterfeit Glen's vodka had been found behind a roof tile in their storeroom, and had been there when they purchased the shop. They subsequently said that they had obtained it from another store that they own, George's, and that the stock had been purchased from the previous owner of Georges. They said that they had reduced the Glen's vodka to £9.99 because they had been unable to sell it, however I believe that they were able to offer it at this low price because they had purchased the counterfeit vodka at a lower price than they would usually pay. The Batleys receipt examined during the inspection indicated that they had continued to purchase genuine Glen's: businesses do not generally make repeat purchases of goods that do not sell.

Incidents of poisoning following consumption of counterfeit vodka have been reported occurring across the UK. It is not acceptable that a premises licenced by this Authority should become a market place for such goods. I would therefore request that the following conditions are imposed on the premises licence to promote the licensing objectives:

- "The Premises Licence Holder must keep complete records, such as invoices, receipts and delivery notes, relating to alcohol and cigarettes obtained by him for sale from his shop. Records must include the name, address and telephone number of the supplier, the date of supply, the products supplied, and their prices. Where items have been delivered to his shop by a vehicle details of the vehicle registration, the name of the delivery person and contact details including the name, address and telephone number for the business must be kept. These details must be available on request to Responsible Authorities within 24 hours. The Premises Licence Holder must be able to identify who supplied alcohol and cigarettes present at his premises "

Rinkhill Ltd has previously received a Simple Caution regarding the sale of alcohol to a 14 year old girl which occurred at London Off Licence 2 on 21<sup>st</sup> August 2009, so I would also request that the following conditions are imposed on the premises licence so as to assist the licence holder and designated premises supervisor in the effective management of the premises and to promote the licensing objectives.

- "The holder of the premises licence shall ensure that every individual who appears to be under 25 years of age seeking to purchase or be supplied with alcohol at or from the premises shall produce means of identification acceptable to the Licensing Authority proving that individual to be 18 years of age or older. If the person seeking alcohol is unable to produce acceptable means of identification, no sale or supply of alcohol will be made to or for that person. Notices regarding the store's "Challenge 25" policy must be displayed"
- "All staff who sell alcohol will be trained to NCPLH (National Certificate of Personal Licence Holder) level. All sales of alcohol must be directly supervised and authorised by a Personal Licence Holder until such staff have achieved training to NCPLH level."
- "That staff are trained regarding appropriate precautions to prevent the sale of alcohol to persons under the age of 18; that records are kept of such training, which are signed and dated by the member of staff who has received the training; that staff receive refresher training every six months as a minimum and that records, signed and dated by the member of staff, are kept of this refresher training. Records of training will be available for inspection by Hampshire Constabulary, the Licensing Authority, Trading Standards and other Responsible Authorities on request."
- "The holder of the premises licence shall keep a written record, namely a refusals book, of those incidents where a person who a member of staff believes to be under the age of 18, and is unable to produce acceptable means of identification proving that they are of 18 years or more, attempts to purchase alcohol and is refused. The record shall include details, in English, of the date, time, a brief description, including estimated age, of the person who attempted to purchase the alcohol, the type of alcohol and the name of the person who refused the sale. Staff shall be trained in the use of the refusals book and it should be kept in a readily accessible place known by all members of staff. The record will be regularly checked by the premises licence holder or the designated premises supervisor to ensure that all staff are completing records and, and this person will sign and date the record as evidence that they have checked it. The refusals book will be available for inspection by Hampshire Constabulary, the Licensing Authority, Trading Standards and other Responsible Authorities on request."
- "A CCTV system shall be installed and maintained in the licensed premises to the satisfaction of the Licensing Authority, Hampshire Constabulary and Trading Standards. As a minimum, it shall enable surveillance of both external and internal areas of the premises including entrances and exits. Recordings from the system shall be of a quality acceptable as evidence in a court of law and shall be securely retained at the licensed premises for a minimum period of 30 days after the recording, and shall be surrendered to Hampshire Constabulary, the Licensing Authority, or Trading Standards immediately on request. The Premises Licence Holder and staff must be capable of operating the CCTV system".
- I would also ask that the licence is suspended for a period of 3 months, both as a deterrent and to give the Premises Licence Holder a period of time in which to put the above conditions into effect.

For information during the interview, which occurred on 1 <sup>st</sup> November 2010, Imam Ekinci stated that he is also the owner of Georges Off Licence, 6 Athelstan Rd, Southampton. His son, Ozgur Ekinci, is the Premises Licence Holder at Georges, and is Designated Premises Supervisor at London Off Licence 2 and Georges: there is a clear link between the two shops. On 4 <sup>th</sup> November I visited Georges and found bottles of counterfeit Glens, and a bottle of non uk duty paid Lithuanian Vodka displayed for sale. I had given advice to Imam and Ozgur Ekinci during interview regarding detection of counterfeit spirits, however he failed to heed this advice.	, 5

I am Thomas Keith Taylor and I have been employed by Glen Catrine Bonded Warehouse Ltd, 7 Laigh Road, Catrine, Ayrshire, KA5 6SQ as Quality Manager for Eighteen years. In this capacity, I am familiar with the design, appearance, composition and quality of all genuine Glen Catrine products and I am authorised to speak on behalf of the company in relation to such matters. I can confirm that Glen's Vodka is a vodka brand for which Glen Catrine Bonded Warehouse Ltd owns the Trade Mark Number E3231107 and the brand was introduced in April 2003. I produce a copy of the Trademark Certificate and identify it as TKT/1. No other person, other than an agent authorised by our company, has permission to manufacture, produce or distribute any items bearing our trademark. On 16th July 2010, I received an E-mail from Lucas Marshall of Southampton Trading Standards Department informing me of a seizure that had been made by his department of a 70cl bottle that was labelled Glen's Vodka and was suspected of being counterfeit. The seizure was from the premises London Off-Licence 2, 27 St. Catherines Road, Southampton, SO18 1LL. From the information provided in the E-mail, I came to the conclusion that the bottle was counterfeit. My reasons for determining that this was not a genuine bottle of Glen's Vodka were as follows:- Previously, for genuine Glen's Vodka 70cl, our company only used a bottle supplied by Allied Glass Containers which can be identified by a small AGC logo on the base of the bottle. The following information was also embossed in the glass around 5mm from the base - 70cl 58mm > G1 2173. Since October 2009, our company has

only used a bespoke bottle supplied by Allied Glass Containers which has the AGC logo, 2589.
and G.C.B.W. embossed in the base. The E-mail from Lucas Marshall stated that the bottle used
for the counterfeit product had the following information embossed in the glass – 700ml $\ni$ 66mm
1445. Our company does not, and has never used this bottle for Glen's Vodka. There was no lot
code on the counterfeit bottle. On genuine bottles, a lot code is etched into the glass or printed by
ink-jet on the bottle to allow traceabilty of where and when the bottle was filled. I can confirm
that London Off-Licence 2, 27 St. Catherines Road, Southampton, SO18 1LL is not authorised in
any way by our company to sell or offer for sale goods which bear the Glen's Vodka trade mark
other than as displayed on genuine Glen's Vodka product. Counterfeiting is extremely
detrimental to the brand image of our company's product and also to the consumer who has no
guarantees of the quality or safety of the product they have purchased.


