- (ii) if a decision upon a matter might reasonably be regarded as affecting to a greater extent than other Council Tax payers, ratepayers and inhabitants of the District, the wellbeing or financial position of himself or herself, a relative or a friend or:-
 - (a) any employment or business carried on by such person;
 - (b) any person who employs or has appointed such a person, any firm in which such a person is a partner, or any company of which such a person is a director:
 - (c) any corporate body in which such a person has a beneficial interest in a class of securities exceeding the nominal value of £5,000; or
 - (d) any body listed in Article 14(a) to (e) in which such a person holds a position of general control or management.

A Member must disclose a personal interest.

Prejudicial Interests

Having identified a personal interest, a Member must consider whether a member of the public with knowledge of the relevant facts would reasonably think that the interest was so significant and particular that it could prejudice that Member's judgement of the public interest. If that is the case, the interest must be regarded as "prejudicial" and the Member must disclose the interest and withdraw from the meeting room during discussion on the item.

It should be noted that a prejudicial interest may apply to part or the whole of an item.

Where there are a series of inter-related financial or resource matters, with a limited resource available, under consideration a prejudicial interest in one matter relating to that resource may lead to a member being excluded from considering the other matters relating to that same limited resource.

There are some limited exceptions.

<u>Note:</u> Members are encouraged to seek advice from the Monitoring Officer or his staff in Democratic Services if they have any problems or concerns in relation to the above.

Principles of Decision Making

All decisions of the Council will be made in accordance with the following principles:-

- proportionality (i.e. the action must be proportionate to the desired outcome);
- due consultation and the taking of professional advice from officers;
- respect for human rights;
- a presumption in favour of openness, accountability and transparency;
- setting out what options have been considered;
- setting out reasons for the decision; and
- clarity of aims and desired outcomes.

In exercising discretion, the decision maker must:

- understand the law that regulates the decision making power and gives effect to it. The decision-maker must direct itself properly in law;
- take into account all relevant matters (those matters which the law requires the authority as a matter of legal obligation to take into account);
- leave out of account irrelevant considerations;
- act for a proper purpose, exercising its powers for the public good;
- not reach a decision which no authority acting reasonably could reach, (also known as the "rationality" or "taking leave of your senses" principle);
- comply with the rule that local government finance is to be conducted on an annual basis. Save to the extent authorised by Parliament, 'live now, pay later' and forward funding are unlawful; and
- act with procedural propriety in accordance with the rules of fairness.

Legal Implications

- 1. Part 3 of the Licensing Act 2003 provides that a responsible authority of a resident or business in the vicinity (interested party) may apply for review of a premises licence.
- 2. The grounds of review applications must relate to one or more of the licensing objectives.
- 3. In such circumstances, the applicant for the review must serve a copy of the review application on the holder of the premises licences, the City Council and each of the responsible authorities.
- 4. On receipt of the application for review, the officers will consider its validity, under delegated powers. Reasons for rejection, in whole or in part, include:
 - that the grounds for review are not relevant to one of more of the licensing objectives and;
 - (in the case of an application not made by a responsible authority), that the application is frivolous, vexatious or repetitious.
- 5. The City Council must, within one day of receiving the application for review, display a prescribed notice of the review application on the outside or adjacent the premises; the notice must remain on display for 28 days and any interested party in the vicinity

- 6. Unless the applicant, licence holder, interested parties and responsible authorities agree that a hearing is unnecessary, the City Council is then required to hold a hearing to consider the review.
- 7. The sub-committee, in considering the application for review, must have regard to the adopted Statement of Licensing Policy and evidence before it at the hearing.
- 8. The Licensing Act 2003 provides that, in determining an application for review, the sub-committee may take any (or none) of the following steps, as it considers necessary:
 - modify the conditions of the licence;
 - exclude a licensable activity from the scope of the licence;
 - remove the designated premises supervisor;
 - suspend the licence for a period not exceeding three months;
 - revoke the licence.
- 9. The Licensing Act 2003 makes provision for appeal to the Southampton Magistrates' Court against the sub-committee's decision in relation to an application for review.
- 10. In considering this application the sub-committee will sit in a quasi-judicial capacity and is thus obliged to consider applications in accordance with both the Licensing Act 2003 (Hearings) Regulations 2005, and amending secondary legislation and the rules of natural justice. The practical effect of this is that the sub-committee must makes its decision based on evidence submitted in accordance with the legislation and give adequate reasons for reaching its decision.
- 11. Copies of the application for review and the Police objection are annexed to this report.
- 12. The sub-committee must also have regard to:-
- 13. Crime and Disorder Act 1998

Section 17 of the Crime and Disorder Act 1998 places the Council under a duty to exercise its various functions with due regard to the likely effect of the exercise of those functions on, and the need to do all that it reasonably can to prevent, crime and disorder in its area.

14. Human Rights Act 1998

The Act requires UK legislation to be interpreted in a manner consistent with the European Convention on Human Rights. It is unlawful for the Council to act in a way that is incompatible (or fail to act in a way that is compatible) with the rights protected by the Act. Any action undertaken by the Council that could have an effect upon another person's Human Rights must be taken having regard to the principle of proportionality - the need to balance the rights of the individual with the rights of the community as a whole. Any action taken by the Council which affect another's rights must be no more onerous than is necessary in a democratic society. The matters set out in this report must be considered in light of the above obligations.

The Prevention of Crime and Disorder

The Prevention of Public Nuisance

The Protection of Children from Harm

Southampton Trading Standards Service carries out routine test purchasing exercises at off licensed premises within Southampton to ensure alcohol is not being sold to young people under the age of 18.

On 13th December 2010 a 16 year old girl acting under the instructions of an Inspector of Weights and Measures purchased alcohol from Rafiques, 51 Derby Road, Southampton.

On 21st January 2011 a 17 year old boy acting under the instructions of a Police Officer purchased alcohol from Rafiques.

It is considered that the holder of the premises licence has not fufilled the duty under the Licensing Act 2003 to prevent crime and disorder and public nuisance, and to protect children from harm. We are therefore applying to review the licence.

In the supporting information we give more details and state the conditions we would wish to see added to the licence in order to promote the above licensing objectives.



Please provide as much information as possible to support the application (please read guidance note 2)

On 13th December 2010 a 16 year old girl acting under the instructions of an Inspector of Weights and Measures purchased alcohol, namely 2 cans of Fosters Lager and one bottle of Zywiec beer, from Rafiques, 51 Derby Road, Southampton. I witnessed the sale. The seller was Rizwana Parveen. I asked to see the store's refusals record. She claimed that the store did not have one and that she did not write English well. She subsequently accepted an £80 Penalty Notice for Disorder.

On 22nd December 2010 PC Jonathan Harris and I met with Aftab Rafique, the premises licence holder, and advised him at length regarding appropriate precautions to take to prevent further sales of alcohol to children.

On 21st January 2011 a 17 year old boy, acting under the instructions of PC 20920 Prior, purchased alcohol, namely a bottle of Budweiser beer, at Rafigues.

On 3rd February I conducted an audio recorded interview with Aftab Rafique. Whilst he did have some systems in place to prevent under age sales, they were not being effectively implemented, perhaps due to a lack of supervision or complacency: there was a Challenge 25 policy, however the two under age sales indicate that it was not being consistently operated; there was a refusals record, however it was not routinely used by staff, or checked by Mr Rafigue, prior to the sales taking place.

Trading Standards Officers are not confident that reasonable precautions are being taken at Rafiques to prevent the sale of alcohol to persons under the age of 18 and would therefore request that the following conditions are imposed on the premises licence so as to assist the licence holder and the designated premises supervisor in the effective management of the premises, and to promote the licensing objectives:

- "The holder of the premises licence shall ensure that every individual who appears to be under 25 years of age seeking to purchase or be supplied with alcohol at or from the premises shall produce means of identification acceptable to the Licensing Authority proving that individual to be 18 years of age or older. If the person seeking alcohol is unable to produce acceptable means of identification, no sale or supply of alcohol will be made to or for that person. Notices regarding the store's "Challenge 25" policy must be displayed"

- "All staff who sell alcohol will be trained to NCPLH (National Certificate of Personal Licence Holder) level. All sales of alcohol must be directly supervised and authorised by a Personal Licence Holder until such staff have achieved training to NCPLH level."

- "That staff are trained regarding appropriate precautions to prevent the sale of alcohol to persons under the age of 18; that records are kept of such training, which are signed and dated by the member of staff who has received the training; that staff receive refresher training every six months as a minimum and that records, signed and dated by the member of staff, are kept of this refresher training. Records of training will be available for inspection by Hampshire Constabulary, the Licensing Authority, Trading Standards and other Responsible Authorities on request."

- "The holder of the premises licence shall keep a written record, namely a refusals book, of those incidents where a person who a member of staff believes to be under the age of 18, and is unable to produce acceptable means of identification proving that they are of 18 years or more, attempts to purchase alcohol and is refused. The record shall include details, in English, of the date, time, a brief description, including estimated age, of the person who attempted to purchase the alcohol, the type of alcohol and the name of the person who refused the sale. Staff shall be trained in the use of the refusals book and it should be kept in a readily accessible place known by all members of staff. The record will be regularly checked by the premises licence holder or the designated premises supervisor to ensure that all staff are completing records and, and this person will sign and date the record as evidence that they have checked it. The refusals book will be available for inspection by Hampshire Constabulary, the Licensing Authority, Trading Standards and other relevant authorities on request."

- "The holder of the premises licence must ensure that all alcohol is marked in a way that will identify its place of purchase for a period to be agreed with the police and Trading Standards which shall not be less than 3 months."

- "A CCTV system shall be installed and maintained in the licensed premises to the satisfaction of the Licensing Authority, Hampshire Constabulary and Trading Standards. As a minimum, it shall enable surveillance of both external and internal areas of the premises including entrances and exits. Recordings from the system shall be of a quality acceptable as evidence in a court of law and shall be securely retained at the licensed premises for a minimum period of 30 days after the recording, and shall be surrendered to Hampshire Constabulary, the Licensing Authority, or Trading Standards immediately on request."

- I would also ask that the licence is suspended for a period of one month, both as a deterrent and to give the Premises Licence Holder a period of time in which to put the above conditions into effect.

For information Mr Rafique has previously accepted a caution regarding sale of alcohol to an 15 child, which took place on 28th September 2006.

I am PC 24288 HARRIS, employed by Hampshire constabulary and currently stationed at Southampton Central police station.

On Monday 13 December 2010, I was involved in a joint test purchase operation with Trading Standards. At around 18:30 hours, I attended RAFIQUES (off licence) at 51 DERBY ROAD. The test purchaser, who was only 16 years of age, entered the premise and was shortly followed by Lucas MARSHALL who is a Southampton City Council Trading Standards officer. Both had only been in the store for a matter of minutes when I saw the test purchaser exit, carrying a bag which contained 2 cans of FOSTERS lager and one bottle of ZYWIEC beer. MARSHALL exited just behind the test purchaser and he told me that a female of Asian ethnicity had sold the alcohol which he had witnessed.

I then entered the store with MARSHALL and we both introduced ourselves to the female cashier who was later

entified as Rizwana PARVEEN 08/12/1974. She was informed that she had committed an offence contrary to S146 of the Licensing Act 2003 by selling alcohol to a person under the age of 18. I then informed PARVEEN that the way I intended on dealing with the offence was by the issuing of a penalty notice for disorder or she could opt to have the case heard at court. PARVEEN stated that she would prefer the penalty notice. Regretfully, I was not in possession of a penalty notice at the time so I agreed to meet PARVEEN at work the following day. Before leaving the address, I informed PARVEEN "I AM REPORTING YOU FOR THE OFFENCE OF SELLING ALCOHOL TO A PERSON UNDER THE AGE OF 18". I then cautioned her to which she made no reply. I returned to the same address at 13:00 hours the following day and PND 2024456 was issued.

I am PC 20920 PRIOR currently serving for Hampshire Constabulary at Southampton Central Police Station.

On Friday the 21st January 2011 I was in charge of an underage sales operation in Southampton. We had two volunteers for the operation as it was covering off-licences, pubs and clubs during the evening. With regards to the off-licence the policy is that one plain clothes officers enters the store and shortly afterwards the test purchaser enters and attempts to buy alcohol, if successful in a sale the test purchaser hands the alcohol to the plain clothes officer and uniformed officers are called in to deal with the situation. The plain clothed officer explains who made the sale, hands over what was sold and then exits the premise. At around 1915 hours Rafiques Off-Licence on Derby Road was visited and PC 3094 Melhuish was the plain clothed officer who entered the store and has provided a statement in relation to that and PC 2193 Sullivan who was my uniformed colleague for the operation has provided a statement regarding the seizure of the alcohol brought. The male was asked questions about what training he had received and didn't give an answer despite being asked a number of times.



On entering the premise at around 1920 hours I approached PC 3094 MELHUISH who identified to me the shop assistant that she had seen to sell alcohol to the test purchaser who was 17 years old. She handed me the bottle of Budweiser which I passed to PC SULLIVAN to seize whilst I issued the fixed penalty notice. I approached the shop assistant who I now know to be Muhammad FEROZ (24/08/75) OF 7 Graham Road, Southampton.

I stated to this male that he had committed an offence by serving a person under the age of 18 and I cautioned him and explained that he was not under arrest and did not have to stay with me. He stated that the male he had served had been in a number of times before and had shown ID and gave a matching description of the test purchasers. I explained that the male was 17 years old and was not from the area. 1 explained that I was going to issue him with a £80 penalty notice and filled out the form which has a URN of 2024166 6. 



Legal Implications

- 1. Part 3 of the Licensing Act 2003 provides that a responsible authority of a resident or business in the vicinity (interested party) may apply for review of a premises licence.
- 2. The grounds of review applications must relate to one or more of the licensing objectives.
- 3. In such circumstances, the applicant for the review must serve a copy of the review application on the holder of the premises licences, the City Council and each of the responsible authorities.
- 4. On receipt of the application for review, the officers will consider its validity, under delegated powers. Reasons for rejection, in whole or in part, include:
 - that the grounds for review are not relevant to one of more of the licensing objectives and;
 - (in the case of an application not made by a responsible authority), that the application is frivolous, vexatious or repetitious.
- 5. The City Council must, within one day of receiving the application for review, display a prescribed notice of the review application on the outside or adjacent the premises; the notice must remain on display for 28 days and any interested party in the vicinity or the responsible authorities may make representations in that period.
- 6. Unless the applicant, licence holder, interested parties and responsible authorities agree that a hearing is unnecessary, the City Council is then required to hold a hearing to consider the review.
- 7. The sub-committee, in considering the application for review, must have regard to the adopted Statement of Licensing Policy and evidence before it at the hearing.
- 8. The Licensing Act 2003 provides that, in determining an application for review, the sub-committee may take any (or none) of the following steps, as it considers necessary:
 - modify the conditions of the licence;
 - exclude a licensable activity from the scope of the licence;
 - remove the designated premises supervisor;
 - suspend the licence for a period not exceeding three months;
 - revoke the licence.
- 9. The Licensing Act 2003 makes provision for appeal to the Southampton Magistrates' Court against the sub-committee's decision in relation to an application for review.
- 10. In considering this application the sub-committee will sit in a quasi-judicial capacity and is thus obliged to consider applications in accordance with both the Licensing Act 2003 (Hearings) Regulations 2005, and amending secondary legislation and the rules of natural justice. The practical effect of this is that the sub-committee must makes its decision based on evidence submitted in accordance with the legislation and give adequate reasons for reaching its decision.
- 11. Copies of the application for review and the Police objection are annexed to this report.
- 12. The sub-committee must also have regard to:-
- 13. Crime and Disorder Act 1998

Section 17 of the Crime and Disorder Act 1998 places the Council under a duty to exercise its various functions with due regard to the likely effect of the exercise of those functions on, and the need to do all that it reasonably can to prevent, crime and disorder in its area.

14. Human Rights Act 1998

The Act requires UK legislation to be interpreted in a manner consistent with the European Convention on Human Rights. It is unlawful for the Council to act in a way that is incompatible (or fail to act in a way that is compatible) with the rights protected by the Act. Any action undertaken by the Council that could have an effect upon another person's Human Rights must be taken having regard to the principle of proportionality - the need to balance the rights of the individual with the rights of the community as a whole. Any action taken by the Council which affect another's rights must be no more onerous than is necessary in a democratic society. The matters set out in this report must be considered in light of the above obligations.

On behalf of Hampshire Constabulary, I submit the following application for Clowns Wine Bar 114-118 Bevois Valley Road, Southampton, in order to review their license.

The premise in question is situation in a cumulative impact zone in which you as a council have recognised and implemented into your policy. The cumulative impact policy was introduced by you because of the key findings and recommendations of the police's report. It identified that there were three areas in which there is a record of violent offending that is disproportionately high in terms of the city as a whole. It identified the following-

• The peak times for violence are in keeping with peak times for the night-time economy

• Each of these locations record an above average level of offences flagged as having been influenced by alcohol.

• In terms of offences where a premise is directly involved, all three locations record multiple offences.

• The overall trend with regard to these offences is either steady or upward.

• Both the Above Bar and Bedford Place/London Road areas also record a disproportionately high level of criminal damage.

Following this report, Southampton City Council took the responsible action of implementing a policy covering the three areas of concern to be used as a tool to control violent crime and alcohol related offending. As I am sure your aware your own statement of licensing policy states that under the Licensing Act 2003 you have a duty to promote the four licensing objectives which are-

- The prevention of crime and disorder
- Public safety
- The prevention of public nuisance and

• The protection of children from harm

This review is brought by Hampshire Constabulary as a responsible authority under the Licensing Act 2003, because of a series of failures in the management, of which impact on two of the licensing objectives as highlighted above.

On the basis of the evidence outlined below, Hampshire Constabulary would wish to achieve the following:

1) CCTV conditions added to the licence to include:

(i) The premises shall have sufficient cameras located within the premises to cover all public areas including outside of the premises covering the entrance and exit. The system should be able to cope with strobe lighting and all levels of illumination throughout the premises as well as outside areas.

(ii)The CCTV system must be operating at all times whilst the premises are open for licensable activity.

(iii) All equipment shall have a constant and accurate time and date generation.

(iv) There shall be sufficient members of trained staff available during operating hours to be able to provide viewable copies at the request of the Police or authorised officer. Any images recovered must be in a format that can be readily taken away and viewed on any computer operating on any windows based program acceptable to the police, or DVD player. This will be without the requirement for additional software to be installed.

(v) Records must be made on a weekly basis and kept for inspection to show that the system is functioning correctly and that data is being securely retained.

(vi) CCTV warning signs to be fitted in public places.

(vii) Recordings to be kept for a minimum of 28 days.



(viii) The DPS or premises manager must be able to demonstrate that the CCTV system has measures to prevent recordings being tampered with, i.e. password protected

(ix) All systems, signage, hardware and procedures are to be installed and implemented to the reasonable satisfaction of Hampshire Constabulary.

2) Incident book and refusals condition added to the licence to include:

An incident book will be provided and maintained at the premises and there will be a daily debrief of door staff at the close of business to the reasonable satisfaction of Hampshire Constabulary. The incident book will remain on the premises at all times and will be available to police upon request. This will include a refusals log which will evidence persons refused entry to the venue and refused to be served alcohol.

3) Introduce and implement a responsible drinking policy at premises that all staff must be trained in to the satisfaction of Hampshire constabulary.

4) The designated premise supervisor to complete level 2 National certificate for designated premise supervisor

In summary, the Police evidence to support these points is as follows:-

PC 24288 HARRIS and PS 3555 MARSHMAN held a meeting with the licensee's son and wife on 22 November 2010. The licensee owns both Clowns Wine Bar and Jesters nightclub and as premises are linked internally, I will mention both throughout this review paperwork. The son is the designated premise supervisor of Jesters, although he does appear to run both premises. The licensee states himself, he is semi retired. During the meeting a number of concerns were highlighted which included the following:-

1) There was only 1 camera covering the bar area inside Clowns

2) 2 cameras were faulty inside Jesters and did not show anything. Camera 8 which was a top view of the garden area and camera 10 which covers the long bar.

3) CCTV system could only retain recorded footage for 9 days.

4) CCTV could not be copied as the memory stick connection was faulty.

The use of a diarised incident book was also discussed and although they were in possession of one, it was not being used. The designated premise supervisor said that they had used it before, when people came round and checked, but then they had not been checked for a while so stopped using it. We explained how we would like the incident book to be used and the designated premise supervisor advised that he would get someone in to look at the CCTV system.

Following this meeting, a letter was sent addressed to both licensed premises on 3 December 2010. This letter explained that we were most concerned with the problems with the CCTV system. We stated it was an extremely important area to have a fully operational system and showed a failure in promoting the licensing objectives. We also advised we would expect our concerns to be addressed and requested an update within 14 days of receipt of the letter.



No update was received regarding the CCTV system and on 31st December 2010, a serious incident occurred in Clowns Wine Bar. The offender, who was unprovoked, pushed a male in a group. This lead to punches being thrown and the offender fell to ground knocking over a stool. He has then picked up the stool and threw it at the group, hitting a male in his forehead. This left a very deep gash in the aggrieves forehead, which required 9 stitches and could leave him with permanent disfigurement. The offender is currently on bail, as we are waiting on a medical statement, which will confirm if this assault is the more serious of grievous bodily harm. In interview, the offender has stated that he had drunk a lot of alcohol and claimed it had affected his memory. He had drunk before he went out and then whilst inside Clowns. He states that he bought a "quadvod" in Clowns, which is a pint containing 4 shots of vodka and lemonade mixer.

On the 5th January 2011, the investigating officer for the assault requested CCTV from the designated premise supervisor for Jesters. Although the actual incident was not covered by a camera in Clowns wine bar, due to the seriousness of the assault, the crown prosecution service requested all CCTV from inside the premise, 30 minutes either side of the incident.

On the 7th January 2011, PC 24288 Harris and PC 24084 Channell attended Clowns and Jesters and spoke with the designated premise supervisor. We were advised that no amendments had been made to the CCTV system. Now that it was the New Year, they were planning to do the necessary upgrades and have someone look at the system the following Monday. PC 24288 HARRIS reminded the designated premise supervisor that all CCTV had been requested by the investigating officer, which had not been completed at the time. This was because the memory stick connection was still faulty, although he intended on taking it to a specialist shop the following day. During the visit, the incident book was also checked. It was being used, but the entry in relation to the serious assault was only 4 lines long. The designated premise supervisor was told that we would expect a much more detailed entry for a serious incident and this had previously been explained. They were also asked if they sold "quadvods" and we were advised that it was not something that they advertised and they do not sell 4 shots, but it would not stop people from buying 2 lots of double shots and then putting them in a pint glass.

On the 8th January 2010, PC 24288 HARRIS received an email from PC 3745 David King who is the Safer Neighbourhood Officer for the Bevois Valley area and investigating officer for the assault. He had attended Clowns and spoke with the designated premise supervisor who he said advised him that both hard drives at the premise were not working on New Years Eve and therefore no footage could be provided. It is apparent that the system had not been checked up until this time and because of this a potentially serious case could be lost at court.

PC 24288 HARRIS spoke with the designated premise supervisor over the telephone on 12th January 2011, in relation to the email that he had received from PC 3745 King. The designated premise supervisor advised that he was not completely without a hard drive and it would still hold footage for 8 days. He had one hard drive out of 4 running and had ordered 3 new ones to replace the faulty drives. Police were further advised that an electrician would be attending the following week to provide a quote for new cameras and



then they would update us.

Police had not heard from the designated premise supervisor by Friday 14th January 2011 so a telephone call was made to him. As there was no reply, a call was subsequently made to the licensee. The problems with the CCTV were discussed and he advised that replacement hard drives had been ordered and cameras had been bought to cover Clowns bar and he believed his son, the designated premise supervisor had this all in hand.

The new CCTV system in Clowns Bar was also reviewed during the visit. There were 4 new cameras installed as part of a new system, as the camera that was in there previously, was linked into the same system as Jesters. Initially, the designated premise supervisor was not able to gain access to the system, as he did not remember the password. A telephone call to the person who set up the system was then made which solved this problem. Although the cameras were of good quality and provided good coverage of the bar, the designated premise supervisor had no idea how long footage could be saved for and he did not know the frames per second of recorded footage. There were no discs to copy footage so we were not able to check the quality of the playback. At the time of our visit, the system had recorded 4 days of footage which equated to 39% of the total hard drive memory. It certainly did not appear as though the system would be capable of recording 28 days of footage. The designated premise supervisor advised an electrician would be coming out the following week although he could not say which day. We were also informed at this time that there were now 4 cameras inside Jesters that were faulty and we had not been made aware of this until this time. It would seem that a relaxed approach has been adopted by management with regards to CCTV, which has been evidenced above.

Due to the failings with the premise initially updating its CCTV and the problems with the premise producing CCTV footage for a serious incident, police felt it necessary for CCTV conditions to be added to the licence of Clowns Bar. This would ensure they have a CCTV system to the satisfaction of Hampshire constabulary and ensure they are able to provide CCTV promptly. PS 3555 Marshman and PC 24288 Harris attended Clowns Bar on 24th January 2011 to discuss this. The licensee, his wife and his son were present. We discussed the concerns over the sell of "quadvods" and the licensee initially said something similar to "when we sold them". He then said it was something that was never promoted or actively sold as a "quadvod" although it did not stop students from buying two doubles and then putting them together. PS Marshman did challenge this comment and suggested as a responsible licensee, he should be challenging this type of behaviour and preventing it from happening in his venue. The licensee did accept that the perception of a "quadvod" or 4 shots of vodka is particularly poor. As previously stated, the offender of the last serious assault stated in interview that he had drunk a quadvod in Clowns.

Both the licensee and designated premise supervisor have said that they have never promoted or actively sold "quadvods", however, the drink is clearly known to be sold from Clowns / Jesters and this is reflected in the student's comments on various social network sites dating back to 2006 and most recently, January 2011. There is a user review on the website beerintheevening.com, dated 31 July 2006. In this review the user states that Clowns and Jesters is the best place to go in your fresher's year. It is described as the cheapest and most cheerful place to go and home to the legendary quadvod. The



perception of the premise is concerning, as the author states if you wear baggy trousers they will soak up much of the sick, urine and booze that forms a lovely layer on the floor.

On Facebook there is a page entitled 'Quad vod' and is linked to Clowns and Jesters and goes back over a year ago. There is a comment made on this in which the author states you can buy mixer jugs. A jug of vodka orange contains 16 shots and nearly three cartons of orange. All this for £10.00.

In another example on Facebook, The author states Monday at Jesters and Clowns are a student night. Drinks include £3 a bottle of wine, 50p per shot, snakebite pint and £2 for guod-vod and mixer.

On the Official Southampton Student Discount Information page on Facebook, Jesters on a Monday, the author advises it is 50p a pint, £2.50 a quad vod and entrance is £4 - and states they are mental nights.

Body warn video footage was obtained outside Jesters and Clowns in the early hours of Saturday 12 February 2010 by PC 2193 Sullivan. It shows a female who had collapsed on the pavement, due to the amount of alcohol she had consumed. The footage shows her laying on cold, wet floor being attended to by ambulance crew and street pastors. The 18 year old female has a friend with her who also appears quite drunk who manages to advise they had both been inside Jesters and Clowns. The designated premise supervisor is spoken to. He does not recognise the collapsed female, but recalled seeing her friend inside his venue.

It is evident from the information above that the management is not taking its responsibilities seriously when selling alcohol, which undermines the licensing objectives of preventing crime and disorder and public safety.

The management have allowed CCTV to fall into disrepair and is only now being rectified due to direct police intervention. Even though parts of the CCTV system have been replaced, they are still unable to operate it in a satisfactory manner. Recorded footage at this time can still not be produced and they are unable to confirm the length of time the system can retain recorded footage. Therefore, were requesting this review to address these issues.

Today i attended Jesters/clowns with PS MARSHMAN in order to conduct a licensing visit.

Bevois Valley in general was discussed and the fact that there is a large number of drunk/vulnerable people found in the area. DPS (Constant) was advised that there would be more police presence in the area and that we would look to capture evidence of where the drunk people are coming from.

Door staff are taught in house and SIA registered. They are employed every night they are open. Licensing link is used and it was suggested if someone is ejected that police are contacted to consider S27 dispersal.

There is a diarised incident book, but **Cartilly** admitted that this is not really used as no one has been checking it. It was suggested that any incidents are recorded and in the event of no incidents that this was marked clearly and countersigned by him. A refusals tally was also suggested.


There are a number of drinks promotions on a Monday night including 50p shots $\& \pm 1.50$ mixers. Concerns were expressed over this and should incidents occur on a Monday, questions would be asked. **Concerns** was advised to risk assess and consider the licensing objectives in relation to the promotions.

CCTV is old and the quality is fairly poor. There is only 1 camera in Clowns Bar and two cameras are not working in Jesters including garden (view from above) and dance floor. There is one other camera on the dance floor, but the quality is very poor and the strobe lighting clearly effected it. The camera located outside the premise was poor. The reg on a licence plate cannot even be made out. Most remaining areas inside are covered but again the quality is not great.

The CCTV system can only hold footage at present for 9 days and it was suggested that it should hold footage for a minimum of 28 days. The facility where a memory card can be inserted is also broken and although stated he could provide police with a copy of cctv, this would only be after recording the footage onto his iphone. It was explained that this was not good enough.

Dear Sir,

Following our meeting at Clowns Wine Bar on 22 November 2010, I would like to confirm our discussions and bring to your attention our concerns over procedures you currently operate within your business.

As a responsible licensee, you should be promoting the four licensing objectives- they are:

- 1) the prevention of crime and disorder
- 2) public safety
- 3) the prevention of public nuisance
- 4) the protection of children from harm

Having reviewed your CCTV system, we were most concerned that camera 8 (dance floor) and camera 12 (garden top view) were not in operation. If a serious incident was to occur in your venue in one of these areas, you would not be able to provide police with any evidence. We expect your system to be able to retain footage for a minimum of 28 days and that staff are able to produce footage to police upon request. I understand that your systems facility to copy downloaded footage is currently broken, and although you stated you could copy it to a mobile phone, this is not acceptable. Clearly, it is an extremely important area to have a fully operational system and shows a failure in promoting the licensing objectives. I understand that you will have a CCTV company in to look at your system and I would expect our concerns to be addressed.

You have a diarised incident book, but this was not being used. I explained that we expect you to record details of incidents and sign the entry at the end of each day. Even if no incidents occur, this should be marked in the book. In order to promote the licensing objectives and to demonstrate good practice, we recommend that you have a refusals tally which would show persons refused alcohol, persons underage and non students. Having discussed this with you, you advised that you would start to operate this procedure.

We also discussed your cheap drinks promotions on a Monday night. Although you do not have reported incidents, it does concern us that you are selling full strength shots at 50p. You need to risk assess your drinks promotions and consider how these relate to the licensing objectives. If incidents were to occur on a Monday night, this would be considered a failing under the licensing objectives and we would request for your promotions to be stopped.

Hopefully we can work together regarding these issues which will highlight your commitment to supporting the four licensing objectives.

Please can you contact me within 14 days of this letter to update me regarding your CCTV system.



Tonight i attended Clowns with PC CHANNELL and we spoke with DPS

was asked about his CCTV and what actions had been taken to improve it since our last meeting. At this time, nothing has been done to improve the system. Stated that they could not afford to pay for it last year, but as it is the start of the term, he intended on having the issues looked at on Monday. I raised the issue with the hard drive again as at present it only holds footage for 14 days. I informed him we would like 28 days. He will look into a new hard drive.

The memory stick connection is still faulty and said he has not been able to produce the footage for the most recent GBH. Not that the incident was covered, as there is no camera in the area where it occurred, but any CCTV of the offender being at the premise has been requested by the OIC. I was not aware on the last occasion we visited, but the bar goes around the far side to where our meeting was held and this is where the assault occurred. I informed that there needs to be coverage of this area. The system that they have will only allow 16 cameras which they have and sature to loose one from downstairs. Was told that we would not want any less coverage, but i suggested that perhaps as there were two cameras in the garden, a wide angle lens could be put on it and the other camera placed in the bar. He suggested the use of a diy camera kit and i said this would not be acceptable. Will now contact a CCTV engineer asap to discuss options and update me by the end of next week 14/01/10.

An incident book has been introduced and is being used. There were entries for last year and most were adequate. For the GBH that occurred on 31/12/10 i would expect more detail as there were only around 4 lines. Swas told that we would expect much more detail when its a serious incident or when door staff have got hands on and forcibly removed someone from the venue. It was not being signed off and i have reiterated that this should be done.

was asked about the selling of "quad-vods" as the d/p for the GBH stated he had brought one at Clowns bar as well as pre loading on alcohol before going out. He said that they do not advertise it and do not sell 4 shots. He explained that some people might by two lots of two shots and then put them into a pint

Quadvods - first of all said something similar to "when we sold them" and then said that it was something that was never promoted or actively sold as a "quadvod". However, he said it does not stop students from buying two doubles and then putting them together. PS MARSHAN challenged him on this comment and suggested that as a responsible licensee he could be saying to people that he does not want this going on in his venue. The also stated that the shots are only 25cl and not 35cl like they are in the centre of town. His son also commented that 4 shots is no stronger that 1 pint of lager. If did take on board that the perception of a quadvod is bad.

CCTV - An additional CCTV system has been installed in Clowns. There are now 4 cameras providing good coverage and the cameras appear to provide good pictures. However, camera 1 needs adjusting, as from viewing recorded footage it had dropped and because of this, its coverage has subsequently been reduced at this time. This camera now covers the area where the assault that took place on 31/12/10. Further, was initially unable to gain access to the system as he could not remember the password. He also did not know how long the system would be capable of recording footage for or what frames per second it recorded at. From searching the system he did find some data that suggested it was 25 frames per second, but this is to be confirmed when recorded footage is available. He did not have any discs to be able to record footage at the time. At the moment 4 days of recording has taken up 39% of the total hard drive memory. It certainly would not appear to cover anywhere near to 28 days, but this may be because the motion sensors were not working. The has advised that he has spoken to his electrician and he will be coming out next week although he could not say which day. He will also be looking at 2 more cameras in Jesters as 4 cameras are now out in total. We have asked that he confirms all of the above when we visit next week.

was asked if he would consider having conditions added to his licence for CCTV, but outright refused. He stated that he has never had conditions on his licence, he has always tried to work with police and the CCTV work we requested has now been completed so why would conditions need to be added.

We explained that despite our visit last November, no amendments were made to the CCTV system. They then had the serious assault in December and no CCTV was available. There was then a break down in communication, the beat officer was being told that he would get CCTV footage from inside the premise from the night the incident occurred, he was then told that there was no footage as the hard drives had gone down and when i contacted was told that 3 out of 4 hard drives was down so only 8 days of footage was being recorded.

would not agree to conditions and even suggested he would go through the courts to prevent it. He also had an issue with an Inspector Taylor who he had dealings with 15 years ago and said he tried to do the same to them back then with his regime. Added that once we leave licensing there would be nothing stopping a new regime from putting more things on his licence. We added that this cannot be done without evidence and good reason.

Legal Implications

- 1. Part 3 of the Licensing Act 2003 provides that a responsible authority of a resident or business in the vicinity (interested party) may apply for review of a premises licence.
- 2. The grounds of review applications must relate to one or more of the licensing objectives.
- 3. In such circumstances, the applicant for the review must serve a copy of the review application on the holder of the premises licences, the City Council and each of the responsible authorities.
- 4. On receipt of the application for review, the officers will consider its validity, under delegated powers. Reasons for rejection, in whole or in part, include:
 - that the grounds for review are not relevant to one of more of the licensing objectives and;
 - (in the case of an application not made by a responsible authority), that the application is frivolous, vexatious or repetitious.
- 5. The City Council must, within one day of receiving the application for review, display a prescribed notice of the review application on the outside or adjacent the premises; the notice must remain on display for 28 days and any interested party in the vicinity or the responsible authorities may make representations in that period.

- 6. Unless the applicant, licence holder, interested parties and responsible authorities agree that a hearing is unnecessary, the City Council is then required to hold a hearing to consider the review.
- 7. The sub-committee, in considering the application for review, must have regard to the adopted Statement of Licensing Policy and evidence before it at the hearing.
- 8. The Licensing Act 2003 provides that, in determining an application for review, the sub-committee may take any (or none) of the following steps, as it considers necessary:
 - modify the conditions of the licence;
 - exclude a licensable activity from the scope of the licence;
 - remove the designated premises supervisor;
 - suspend the licence for a period not exceeding three months;
 - revoke the licence.
- 9. The Licensing Act 2003 makes provision for appeal to the Southampton Magistrates' Court against the sub-committee's decision in relation to an application for review.
- 10. In considering this application the sub-committee will sit in a quasi-judicial capacity and is thus obliged to consider applications in accordance with both the Licensing Act 2003 (Hearings) Regulations 2005, and amending secondary legislation and the rules of natural justice. The practical effect of this is that the sub-committee must makes its decision based on evidence submitted in accordance with the legislation and give adequate reasons for reaching its decision.
- 11. Copies of the application for review and the Police objection are annexed to this report.
- 12. The sub-committee must also have regard to:-
- 13. Crime and Disorder Act 1998

Section 17 of the Crime and Disorder Act 1998 places the Council under a duty to exercise its various functions with due regard to the likely effect of the exercise of those functions on, and the need to do all that it reasonably can to prevent, crime and disorder in its area.

14. Human Rights Act 1998

The Act requires UK legislation to be interpreted in a manner consistent with the European Convention on Human Rights. It is unlawful for the Council to act in a way that is incompatible (or fail to act in a way that is compatible) with the rights protected by the Act. Any action undertaken by the Council that could have an effect upon another person's Human Rights must be taken having regard to the principle of proportionality - the need to balance the rights of the individual with the rights of the community as a whole. Any action taken by the Council which affect another's rights must be no more onerous than is necessary in a democratic society. The matters set out in this report must be considered in light of the above obligations.

Please state the grounds for review which must be based on one or more of the licensing objectives together with supporting information:

This review is brought by Hampshire Constabulary as a responsible authority under the Licensing Act 2003, in light of recent test purchase failures at The Royal Oak public house. We believe that these failures can be directly linked to the poor staff training currently delivered at the venue.

Hampshire Constabulary request that the following conditions be applied to the current licence to prevent any future failures. We also request that the venue be subject to a period of closure as a deterrent but also to ensure that any conditions that are applied to the licence, could be properly implemented to support the four licensing objectives.

The conditions that Hampshire Constabulary would seek to have added to the current licence are:

1) Challenge 25 - There will be a Challenge 25 policy operated at the premise. Challenge 25 meaning that the holder of the premises licence shall ensure that every individual who appears to be under 25 years of age seeking to purchase or be supplied with alcohol at or from the premises shall produce means of identification acceptable to the licensing authority proving that individual to be 18 years of age or older. If the person seeking alcohol is unable to produce acceptable means of identification, no sale or supply of alcohol will be made to or for that person.

2) All staff who sell alcohol will be trained to NCPLH (National Certificate of Personal License Holder) level. All sales of alcohol must be directly supervised and authorised by a personal licence holder until such staff have achieved training to NCPLH level.

3) Staff are trained regarding appropriate precautions to prevent the sale of alcohol to persons under the age of 18; that records are kept of such training, which are signed and dated by the member of staff who has received the training; that staff receive refresher training every six months as a minimum and that records are signed and dated by the member of staff and records are kept of this refresher training. Records will be available for inspection by Hampshire Constabulary and the Licensing Authority.

4) For the Designated Premises Supervisors to be trained to BIIAB Level 2.

5) The premise holder or his nominated representative will maintain membership of any existing Barwatch scheme, or join any future scheme, which is not currently in existence and approved/supported by the local police. He/she will ensure co-operation with the relevant scheme, abide by any rules and ensure meetings are regularly attended.

6) An incident book will be provided and maintained at the premises and there will be a daily debrief of door staff at the close of business to the reasonable satisfaction of Hampshire Constabulary. The incident book will remain on the premises at all times and will be available to police upon request.

7) CCTV - The premises shall have sufficient cameras located within the premises to cover all public areas including outside of the premises covering the entrance and exit. The system should be able to cope with strobe lighting and all levels of illumination throughout the premises as well as outside areas.

The CCTV system must be operating at all times whilst the premises are open for licensable activity.

All equipment shall have a constant and accurate time and date generation.

There shall be sufficient members of trained staff available during operating hours to be able to provide viewable copies at the request of the Police or authorised officer. Any images recovered must be in a format that can be readily taken away and viewed on any computer operating on any Windows based program acceptable to the police, or DVD player. This will be without the requirement for additional software to be installed.

Records must be made on a weekly basis and kept for inspection to show that the system is functioning correctly and that data is being securely retained.

CCTV warning signs to be fitted in public places.

Recordings to be kept for a minimum of 28 days.

The DPS or premises manager must be able to demonstrate that the CCTV system has measured to prevent recordings being tampered with, i.e. password protected.

All systems, signage, hardware and procedures are to be installed and implemented to the reasonable satisfaction of Hampshire Constabulary and approved in writing.

As stated above the venue has failed two test purchases by selling alcohol to juveniles, which does not support 1 of the licensing objectives - the protection of children from harm. The following information provides further details on the failures.

On 13/11/2010 a staff member sold 2 bottles of WKD blue to 2 test purchasers. She was issued with a fixed penalty notice for the offence in the presence of the Designated Premises Supervisor. The staff member was retained as staff by the venue as she was described as a good employee and hard worker. This staff member had received her initial staff training on 31/01/2010 (approximately 10 months earlier) and there was no record of her having received any further training since this date.

On 19/11/2010 a meeting was held at the premise between the police and the DPS to discuss the first test purchase failure. During this meeting it was agreed that to avoid any future failings the DPS would be implementing the following:

1) Identification would be requested from everyone due to being a student-based venue.

2) If any further staff fail a test purchase, they will be dismissed.
3) Staff will be trained about asking customers for identification and if they encountered a large group they will inform the DPS so that he can carry out the checks instead.
4)Test Inn and Heineken Brewery will be assisting in reviewing the current training package.

During this meeting the police also suggested that the DPS could implement Challenge 25 and maintain an incident/refusals book in order to try and prevent his staff from serving alcohol to underage persons again in the future.

Second test purchase failure:

On 21/01/2011 another staff member sold a bottle of Becks and a Smirnoff Ice to 2 test purchasers. This staff member was issued with a fixed penalty notice for the offence and was later dismissed by the venue. This staff member had received her training on 18/01/2011 - just 3 days earlier. This therefore shows that the staff training provided by the venue was inadequate, otherwise this staff member would have undoubtedly asked for ID according to what was agreed at the previous meeting.

A further meeting was held at The Royal Oak on 04/02/11 following this second failure. This was held with the DPS and a representative of Trust Inns.

During this meeting the DPS was asked about any changes he had made since the last meeting with the police. He had not implemented a Challenge 25 police or introduced a refusals book. There had not been any improvement in the training package and there were no regular training records for any staff. No assistance had been sought from Test Inn/Heineken Brewery with regards to this. They did dismiss the second member of staff that failed the test purchase.

The 2 failures show that there is insufficient staff training provided at the venue. There is no evidence that the first staff member to fail the test purchase had received any further training since her initial training in January 2010 - almost a year before she failed the test purchase. The second staff member to fail had only received her training three days prior to her test purchase failure so any training she had received should have been perfectly fresh in her mind. It is clear that staff training needs to be vastly improved from the current system in order for the venue to support the licensing objectives and prevent any future sales of alcohol to children.

The DPS was asked about current staff training and he provided a small four page leaflet. This leaflet consists of a cover page, information on the two inside pages and then a signature strip on the last page. He stated that the training consists of staff reading the leaflet and then signing on the back to say that they have read it.

Further to any improvements made to the current staff training, it is clear that the current DPS would also benefit from further training - the suggested BIIAB Level 2 National Certificate for Designated Premises Supervisors.

Dear Sir.

Following our recent meeting regarding a test purchase failure at Royal Oak, I am writing to confirm what was discussed and agreed. Hampshire Constabulary are extremely concerned by the significant failings of your premise, which resulted in a 16 year old and a 17 year old female being served alcohol. This is in direct breach of licensing objectives.

As a responsible licensee, you should be aware of your obligation to promote the four licensing objectives -

- 1) the prevention of crime and disorder
- 2) public safety
- 3) the prevention of public nuisance
- 4) the protection of children from harm

During the meeting, we discussed the consideration of implementing new measures to prevent further incidents occurring, which could be perceived as undermining or breaching the four licensing objectives.

Since the test purchase failure, you have taken a number of actions to minimise the possibility of future incidents.

I can confirm that it was agreed that:

- 1. You stated you have a student based venue and to avoid any future failings, you have asked all bar staff to request identification from everyone.
- 2. You have informed all staff that should any fail a test purchase in future, they will be dismissed. On this occasion, the member of staff that served alcohol to persons underage has been retained, as you indicated she is generally a good employee and hard worker.

- 3. Staff will be trained about asking customers for identification. If they encounter a large group, you have advised them to inform you so that you can carry out the identification checks yourself.
- 4. Test Inn and Heineken Brewery will be assisting you in reviewing your current training package.

During our meeting the following was also suggested to further assist you

- 1. Challenge 25 policy to be adhered to by bar staff. Posters to be displayed on premises informing customers of Challenge 25 policy.
- 2. A diarised incident book to be maintained by door staff and management. A refusals tally to be included for all staff and each day signed off by manager.

At present your business has very little in the way of conditions upon its license. I would have little choice but to seek to have conditions added via a review of your licence should further incidents occur and these issues were not addressed.

Hopefully we can work together regarding these issues which will highlight your commitment to supporting the four licensing objectives.

I look forward to hearing from you in the near future.

What is the BIIAB Level 2 National Certificate for Designated Premises Supervisors?

The BIIAB Level 2 NCDPS was developed in conjunction with local government, the police and the industry, to support the new post of designated premises supervisor created by the Licensing Act 2003.

It is designed to provide designated premises supervisors with an understanding of their role and the responsibilities both within the Licensing Act 2003, and other regulatory issues in addition to those covered in the Act. The qualification also addresses the practical day-to-day issues involved in running a licensed premises.

Who is the qualification for?

The BIIAB Level 2 NCDPS is a nationally recognised qualification for both existing designated premises supervisors, and those who may be required to take up this post in the future, working in any type of licensed premises including:

- pubs and bars
- hotels and restaurants
- off-licences, supermarkets and convenience stores
- sports and social clubs
- nightclubs and entertainment establishments
- and any other venue or site where alcohol is sold.

What does the qualification cover?

The BIIAB Level 2 NCDPS covers the following topics:

- the roles and responsibilities of the designated premises supervisor
- the licensable activities carried out in licensed premises
- the requirements of legislation and best practice to support the four licensing objectives
- how to conduct a risk assessment, and how it is used to underpin the operating schedule
- the relationship between the operating schedule and management controls.
