- **Recommendation 3,** second sentence to read "Consideration should be given to support al children, and especially those with the most complex needs through a multi-agency approach, as well as involvement with the Learning Disabilities Partnership Board, to include all key services...."
- **Recommendation 6,** to read "SCC, in partnership with others,....." **Recommendation 3**, **second** row to read ".....including areas such as ADHD, which although categorised as a medical condition is included within the SEN definition".

Additional information to be added to Recommendations
