Terms of Reference

The Sub-Committee deals with licences for which the Council is responsible under the Licensing Act 2003 and Gambling Act 2005, including:-

- Determination of applications for review of premises licences and club premises certificates;
- Determination of representations to applications for premises licences and club premises certificates, variations and various permits;
- Determination of police objections to applications for:
 - Variation of designated premises supervisors
 - Transfer of premises licences
 - Personal licences for the sale of alcohol
- Determination of objections to temporary event notices.

Relevant Representations

Those who have made relevant representations may address the meeting about the matter in which they have an interest. New matters, not raised within a written representation, can not be relied upon at the hearing. When dealing with Licensing Act matters the Sub-Committee must only take into account the following statutory Licensing Objectives:-

- prevention of crime and disorder
- public safety
- prevention of public nuisance
- protection of children from harm

Likewise, when dealing with Gambling Act matters the Sub Committee must only take into account the statutory Licensing Objectives below:-

- Preventing gambling from being a source of crime or disorder, being associated with crime or disorder or being used to support crime
- Ensuring that gambling is conducted in a fair and open way, and
- Protecting children and other vulnerable persons from being harmed or exploited by gambling

The Southampton City Council Strategy (2016-2020) is a key document and sets out the four key outcomes that make up our vision.

Quorum 3

The minimum number of appointed Members required to be in attendance to hold the meeting is 3.

DISCLOSURE OF INTERESTS

Members are required to disclose, in accordance with the Members' Code of Conduct, both the existence and nature of any "Disclosable Pecuniary Interest" or "Other Interest" they may have in relation to matters for consideration on this Agenda.

DISCLOSABLE PECUNIARY INTERESTS

A Member must regard himself or herself as having a Disclosable Pecuniary Interest in any matter that they or their spouse, partner, a person they are living with as husband or wife, or a person with whom they are living as if they were a civil partner in relation to:

- (i) Any employment, office, trade, profession or vocation carried on for profit or gain.
- (ii) Sponsorship:

Any payment or provision of any other financial benefit (other than from Southampton City Council) made or provided within the relevant period in respect of any expense incurred by you in carrying out duties as a member, or towards your election expenses. This includes any payment or financial benefit from a trade union within the meaning of the Trade Union and Labour Relations (Consolidation) Act 1992.

- (iii) Any contract which is made between you / your spouse etc (or a body in which the you / your spouse etc has a beneficial interest) and Southampton City Council under which goods or services are to be provided or works are to be executed, and which has not been fully discharged.
- (iv) Any beneficial interest in land which is within the area of Southampton.
- (v) Any license (held alone or jointly with others) to occupy land in the area of Southampton for a month or longer.
- (vi) Any tenancy where (to your knowledge) the landlord is Southampton City Council and the tenant is a body in which you / your spouse etc has a beneficial interests.
- (vii) Any beneficial interest in securities of a body where that body (to your knowledge) has a place of business or land in the area of Southampton, and either:
 - a) the total nominal value of the securities exceeds £25,000 or one hundredth of the total issued share capital of that body, or
 - b) if the share capital of that body is of more than one class, the total nominal value of the shares of any one class in which you / your spouse etc has a beneficial interest that exceeds one hundredth of the total issued share capital of that class.

Other Interests

A Member must regard himself or herself as having an 'Other Interest' in any membership of, or occupation of a position of general control or management in:

Any body to which they have been appointed or nominated by Southampton City Council

Any public authority or body exercising functions of a public nature

Any body directed to charitable purposes

Any body whose principal purpose includes the influence of public opinion or policy

Principles of Decision Making

All decisions of the Council will be made in accordance with the following principles:-

- proportionality (i.e. the action must be proportionate to the desired outcome);
- due consultation and the taking of professional advice from officers;
- respect for human rights;
- a presumption in favour of openness, accountability and transparency;
- setting out what options have been considered;
- · setting out reasons for the decision; and
- clarity of aims and desired outcomes.

In exercising discretion, the decision maker must:

- understand the law that regulates the decision making power and gives effect to it.
 The decision-maker must direct itself properly in law;
- take into account all relevant matters (those matters which the law requires the authority as a matter of legal obligation to take into account);
- leave out of account irrelevant considerations;
- act for a proper purpose, exercising its powers for the public good;
- not reach a decision which no authority acting reasonably could reach, (also known as the "rationality" or "taking leave of your senses" principle);
- comply with the rule that local government finance is to be conducted on an annual basis. Save to the extent authorised by Parliament, 'live now, pay later' and forward funding are unlawful; and
- act with procedural propriety in accordance with the rules of fairness.

29. EXCLUSION OF THE PRESS AND PUBLIC

The Sub-Committee accepted legal advice that the agenda item be amended to read as follows:

Legal Implications

- 1. The legislation specifically restricts the grounds on which the sub-committee may refuse an application for grant of a premises licence, or impose conditions. The legislation provides for a presumption of grant of an application for a premises licence, subject to the determination of the application with a view to promoting the licensing objectives in the overall interests of the local community. In doing so the sub-committee must give appropriate weight to:
 - the steps that are appropriate to promote the licensing objectives;
 - the representations (including supporting information) presented by all the parties;
 - its own statement of licensing policy
 - the Statutory Guidance
- 2. An application may be refused in part and thereby only permit some of the licensable activities sought.
- 3. An applicant for grant of a premises licence whose application has been refused, or who is aggrieved by conditions imposed, may appeal against the decision to the Magistrates' Court. Any other person, who made a valid representation, may appeal to the Magistrates' Court against the decision to grant the application or against any conditions imposed.
- 4. In considering this application the sub-committee will sit in a quasi-judicial capacity and is thus obliged to consider the application in accordance, in particular, with both the Licensing Act 2003 (Hearings) Regulations 2005 (as amended) and the rules of natural justice. The practical effect of this is that the sub-committee must makes its decision based on evidence submitted in accordance with the legislation and give adequate reasons for reaching its decision.
- 5. The sub-committee must also have regard to:
 - The Crime and Disorder Act 1998
 Section 17 of the Crime and Disorder Act 1998 places the sub-committee under a duty to exercise its various functions with due regard to the likely effect of the exercise of those functions on, and the need to do all that it reasonably can to prevent, crime and disorder in its area.
 - The Human Rights Act 1998
 The Act requires UK legislation to be interpreted in a manner consistent with the European Convention on Human Rights. It is unlawful for the sub-committee to act in a way that is incompatible (or fail to act in a way that is compatible) with the rights protected by the Act. Any action undertaken by the sub-committee that could have an effect upon another person's Human Rights must be taken having regard to the principle of proportionality the need to balance the rights of the individual with the rights of the community as a whole. Any action taken by the sub-committee which affect another's rights must be no more onerous than is necessary in a democratic society. The matters set out in this report must be considered in light of the above obligations.



As local residents adjacent to Portswood Broadway, we wish to object to the application at present before the Licensing committee.

It would be one more licensed premises in what is essentially a small local shopping centre in the middle of a residential area. There are already 25 licensed premises in the district centre, and there are already three public houses, the Mitre, Wild Lime and Tram Stop in the same area, with others in the neighbouring vicinity.

Such a proliferation of licensed premises in the middle of a residential area provides the risk of people being attracted to the area from outside, and the consequent risk of antisocial behaviour.

Already we suffer from discarded drink cans and bottles being regularly left in the road and in our garden, and there are more people visible in the streets adjoining the shops drinking alcohol.

The proposed live music (let alone the recorded music) would provide a noise nuisance both to the precinct and to adjoining residential property (including the proposed flats above the premises).

The request to sell alcohol between 7am to 11pm, 7 days a week is excessive. No other pub in the area is licensed to sell alcohol so early. We already have a problem with day time drinkers, who sit on the wall in Westridge Road, opposite the proposed pub. The long hours would encourage more anti- social behaviour. I write to object to this application for the following reasons:.

- 1. Portswood District Centre (DC) is a small shopping centre- only 200 metres long-in the middle of a densely populated residential area. There are already more than 25 licensed premises in the DC (including 3 public houses- The Mitre and Wild Lime and the micropub Tramstop Bar)), plus 2 public houses (the Gordon Arms and The Richmond) and at least 4 other licensed premises just outside it, at the southern end.. There is a particularly high concentration of off-licences in this part of the DC, (between Westridge Road and the Victory church) where there are already three off licences. The addition of yet another licensed premises-the fourth pub in the DC- would be excessive.
- 2. The hours sought for the sale of alcohol- 7 am to 11pm-16 hours a day, 7 days a week—would be too long and commence too early, particularly on Sunday. No other pub in the DC is licensed to sell alcohol as early as 7am.
- 3. The addition of yet another licensed premise in the DC, with such long hours would attract people from outside the area, making it a centre for the consumption of alcohol, and an increasing danger of drunkenness and rowdiness in the DC.
- 4. This, in turn would lead to an increased risk of:
- a) Noise and disturbance and b) Anti-social behaviour c) Litter and d) even Crime (e.g. damage to cars)
- --- in the DC, with people congregating, on the corner, outside the premises,
 ---- and on their way home through the nearby residential roads, late at night,
 after closing time, when the only police cover is centrally monitored (local police
 now cover for the whole City, rather than the local area, so there is no specific police
 cover in the area).

- 5. a) The applicant's current <u>planning application for external awnings over the pavement, suggests that there would be drinking outside, which would add to the noise and disturbance.</u>
- b) The proposed live music would also add to the noise and disturbance, especially when the windows were open.
- 6. Local residents, especially in the proposed new flats above the premises and above the shops opposite, and in the adjacent and nearby residential roads would be adversely affected by all of 4) and 5) above. The DC is situated in the middle of a densely populated residential area. In addition, Portswood Residents Gardens Conservation Area (comprising Highfield Lane, Abbotts Way, Russell Place and Brookvale Road), whose key feature is that of a 'quiet residential area' is within 100 metres of the premises, and whose roads lie on the way back to the University.
- 7. I live in Russell Place, and my back garden is about 100 m away from these premises.
- a) We are increasingly disturbed by <u>noise</u>, <u>late at night</u>, from the DC, especially in the summer months, when the windows are open. An additional outlet here, selling alcohol, for such long hours, would add to this.
- b) We already suffer from <u>litter in Russell Place</u>, and regularly collect empty cans and bottles. An additional outlet selling alcohol on and off the premises would add to this.
- 8. The opening hours sought (7am to 11pm) are the same as for the sale of alcohol. The latter should be one half hour shorter, to allow for 'drinking up' time.
- I, therefore, ask that this application is refused. I should be obliged if you would take these comments into account when considering this application.

Application for a premises licence for the sale of alcohol "on" and "off" the premises between 7 am till 11pm on 7 days a week Monday to Sunday with both recorded music from 7 am to 11pm and also live music 12 midday till 11 pm 7 days a week Monday to Sunday. Opening hours 7 am till 11 pm on 7 days a week.

I object to this application for the following reasons:-

- (1) Site. The Crafty Fox is situated in the Portswood District Centre (DC) which comprises just a single row of retail premises on either side of the 200 metre long The Broadway, which is closely surrounded by densely populated residential houses, the proximity of which makes the residents particularly susceptible to noise and disturbance arising from the DC.
- (2) Further increase in the existing excessive number of licensed premises in the DC. There already exists an excessive number of outlets providing alcohol.; another will only aggravate the situation. If granted are will be more than 22 in number, situated over a distance of 200 metres. It will be a "micro-pub" and there are already two public houses (The Mitre & The Wild Lime) together with The Tram Stop Bar within the DC, with two more pubs, The Richmond and Gordon Arms on the Portswood Road within 50 metres of the DC.
- (3) The DC will become a city "hub" for drinking. The number of existing outlets for alcohol is already far greater than that required for local residents. This "micro-pub" will only further increase this excessive supply. It will therefore attract drinkers from outside the area for the concentration is greater than anywhere else apart from the centre of the City.
- (4) Increased drinking due to increased supply will lead to increased drunkenness with increased noisiness & drunkenness.
- (5) The hours of opening too long and too early. The proposed hours of opening 7am till 11 pm-namely 16 hours a day every day (including Sundays) are too long. The early opening at 7 am is far too early and will encourage drunkeness by breakfast time and present an unacceptable example to children going to school.
- (6)Provision of piped music and "live" music. The prolonged hours of provision of piped music and live music will cause excessive noise and disturbance.
- (7) The proposed erection of 5 awnings. These awnings, which will over-hang the outside pavement, can have no other use than to provide protection for outside drinking either standing or more likely sitting at tables. This will cause excessive noise and obstruction to pedestrians.

Increased noise, increased alcohol consumption, with consequent drunkenness, rowdiness, anti-social behaviour, excessive litter, bottles etc. and even criminal damage to property These will result as consequencies arising from the items cited in headings (3,4,5,6,7). (The consequencies have been itemized here to avoid repetition). The problems will arise within the District Centre itself affecting local residents in the Portswood Road and also in our surrounding streets as revelers make their way home through our streets so disturbing sleep etc.

It is for these reasons that I object to this application and ask for it to be refused. Thank you.

I strongly object to the above application because of the significant harm to the amenity of local residents; the impact on Portswood District Centre; the undesirability and harmful precedent of extended opening hours, and the cumulative effects of large numbers of licensed premises in the area.

Portswood District Centre lies in a predominantly residential area and already has a very large number of premises for drinking alcohol and socialising. This small shopping centre already has over 25 licensed premises, including two pubs, a micropub, cafes, restaurants and take-aways, and several off-licenses. There are also two more pubs just outside the centre. There are large numbers of dwellings in the immediate vicinity of the application site, including dwellings in Portswood Road, Westridge Road and proposed flats over the pub itself and flats over the shops opposite. The wider surrounding area is also residential.

This proposal for yet another pub would be excessive for such a small district centre. The concentration of licensed premises in such a small area will attract customers from further afield and make it a major centre in the city to consume alcohol, destroying its atmosphere as a local shopping and service centre and harming the amenities of nearby residents.

The proposed hours of opening are excessive – 16 hours a day, starting at 7am and until 11am, and for every day of the week, including Sundays – and longer than those of other licensed premises in the area..

The cumulative effect of an additional licensed premises plus the proposal for long and very late opening hours seven days a week would be very likely to lead to <u>adverse effects on local residents which would be completely unacceptable.</u> Harmful effects on nearby residents would include:

- noise and disturbance from customers congregating outside in the street, particularly
 late at night when such venues act as a focal point for rowdy elements, and from
 customers walking home through nearby streets late at night. These would be very
 intrusive for residents in the vicinity, especially on Sundays and in the summer
 months when windows are open
- additional noise and disturbance from the proposed live music
- an increase in unruly, anti-social behaviour from which the neighbourhood already suffers - litter, graffiti, breaking the branches of street trees, damage to parked cars etc. - both within the District Centre and in surrounding residential areas

- the cumulative effects of this proposal on top of the large number of existing pubs, take-aways and music venues in Portswood, Highfield and Bevois Valley which harm residential amenity
- if the proposal were to be allowed, it would set an undesirable precedent and other venues in the District Centre would seek later hours than have been allowed by in the past, especially on Sundays.

It is simply not reasonable to allow yet another drinking and music establishment located close to homes, particularly one open from early morning until late at night for seven days a week. Portswood District Centre should be a local shopping and service centre for surrounding neighbourhoods, not one of the eating, drinking and music hot-spots of the night-time economy. Areas such as the Civic Centre and waterfront are much better suited to this role.

I therefore ask that the application should be refused.

The hours sought would be too long and commence too early, particularly on Sunday. No other pub in the District Centre is licensed to sell alcohol as early as 7am.

This premises being open for such long hours would attract people from outside the area, making it a centre for the consumption of alcohol, and an increasing danger of drunkenness and rowdiness

Which would lead to an increased risk of:

Noise and disturbance, anti- social behaviour. Litter and Crime in the District Centre, with people congregating, on the corner, outside the premises, and on their way home through the nearby residential roads, late at night

The addition of yet another licensed premises-the fourth pub in the DC- would be excessive.

The applicant's planning application for external awnings over the pavement, suggests that there would be drinking outside, which would add to the noise and disturbance. Also the proposed live music would also add to the noise and disturbance, especially when the windows were open.
