	<ul> <li>Published rate levels, how we pay providers, and why rates are higher than we normally expect based on the published rates, including the response of the market at higher rate levels. The market as a whole is now responding to changes to the national minimum wage and other increases and expecting all rates to uplift to reflect this. Although we do not have an exact figure to work on for these other changes, I think it is important that the JCB (and yourself) have an understanding of the negotiations we undertake with homes and the potential financial impact for the future.</li> <li>Future commissioning intentions and a plan for engaging with the market, including on commencing seeking agreements to guarantee access to care places at agreed prices. This is not a decision but we are seeking agreement to map out an approach to the market that will better enable us to access and understand price arrangements.</li> </ul>
