

# Legal Implications

- The Licensing Act 2003 specifically restricts the grounds on which the Council, as Licensing Authority (LA), may refuse an application for a major variation of a Premises Licence, or impose conditions. Where relevant representations are made, the LA may refuse on the grounds that the licensing objectives are not met or the operating schedule is inadequate. Equally, conditions may be imposed where relevant and necessary. The LA may also refuse an application in part and thereby only permit some of the licensable activities sought.
- 2. The decision making committee, in considering an application, must have regard to the adopted Statement of Licensing Policy and any relevant representations made by those directly affected.
- 3. An applicant for a variation, whose application has been refused, or who is aggrieved by conditions imposed, may appeal against the decision to the Magistrates' Court.

4. In considering this application the committee will sit in a quasi-judicial capacity and is thus obliged to consider applications in accordance with both the Licensing Act 2003 (Hearings) Regulations 2005, and amending secondary legislation and the rules of natural justice. The practical effect of this is that the committee must makes its decision based on evidence submitted in accordance with the legislation and give adequate reasons for reaching it's decision.

The committee must also have regard to:-

#### 5. Crime and Disorder Act 1998

Section 17 of the Crime and Disorder Act 1998 places the Council under a duty to exercise its various functions with due regard to the likely effect of the exercise of those functions on, and the need to do all that it reasonably can to prevent, crime and disorder in its area.

#### 6. Human Rights Act 1998

The Act requires UK legislation to be interpreted in a manner consistent with the European Convention on Human Rights. It is unlawful for the Council to act in a way that is incompatible (or fail to act in a way that is compatible) with the rights protected by the Act. Any action undertaken by the Council that could have an effect upon another persons Human Rights must be taken having regard to the principle of Proportionality - the need to balance the rights of the individual with the rights of the community as a whole. Any action taken by the Council which affect another's rights must be no more onerous than is necessary in a democratic society. The matter set out in this report must be considered in light of the above obligations.

Re:Change in Licensing Hours iro Talking Heads.

We would like to object to the increase in opening hours for the following reasons,

Noise from people drinking and smoking outside the front

Doors open until all hours with loud music coming from within

Loud music is bad enough until 2.00am let alone 3.00am

Every Monday we now have the bikers drinking on the front reving their machines and the noise can be deafening

People leaving at all hours shouting swearing car doors banging, cars parked on double yellow lines outside the front

The thumping beat of the music which keeps you up when you have to get up at 5.30am for work Rowdy behaviour and arguments after people have consumed to much alcohol

This is a residential area, when the 2.00am licence was granted it had been agreed that the doors and windows would remain shut at all times when bands where playing to soften the level of noise and that there would be no drinking or tables on the front.

Since the new landlord has taken over he has shown no respect for the residents there is load music most evenings table and chairs on the front people smoking and drinking out there. The only reason we found out about this application was after we spoke to the licencing department about another matter regarding the pub. He has not to date put a notice in the window or in the echo regarding the changes we check on a daily basis for any changes when we collect our newspaper. He has also put the changes in opening hours up already before his licence has been granted or is this just a forgone conclusion. We hope you consider our reasons before making a decision.
