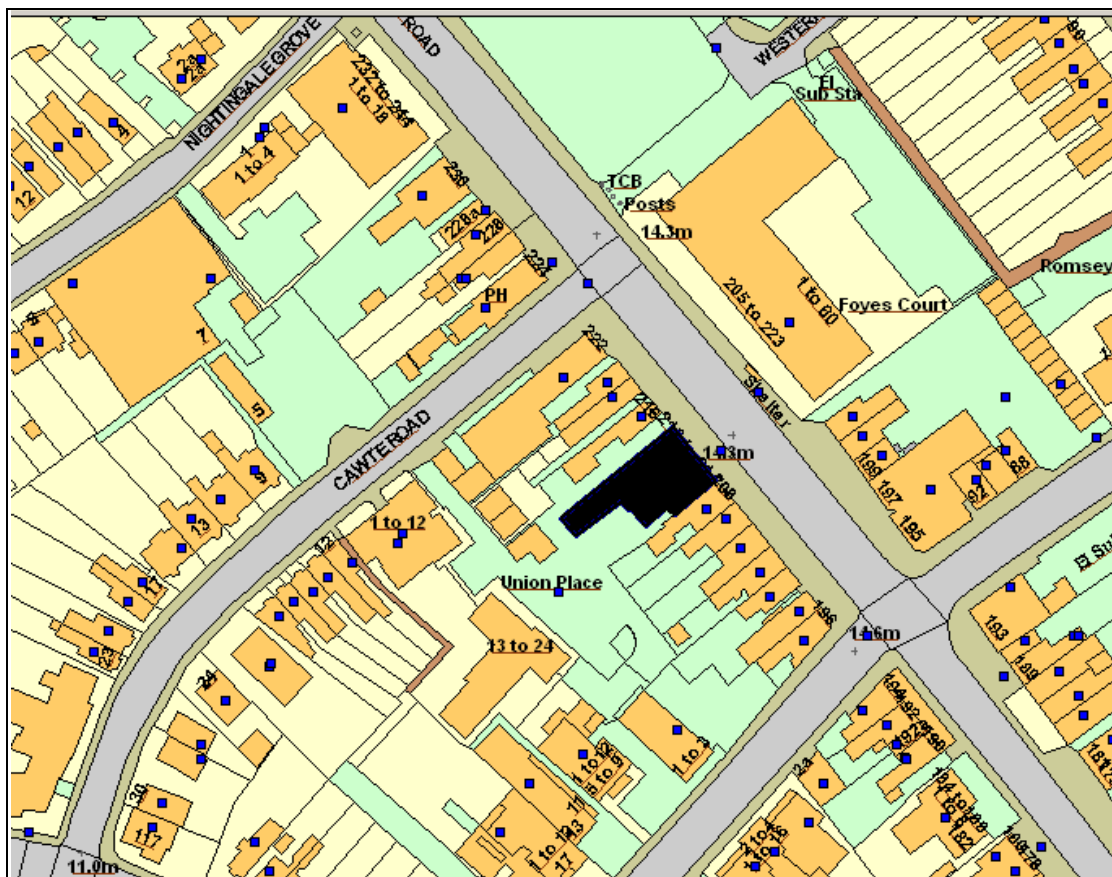

Legal Implications

1. The Licensing Act 2003 specifically restricts the grounds on which the Council, as Licensing Authority (LA), may refuse an application for a new Premises Licence, or impose conditions. Where relevant representations are made, the LA may refuse on the grounds that the licensing objectives are not met or the operating schedule is inadequate. Equally, conditions may be imposed where relevant and necessary. The LA may also refuse an application in part and thereby only permit some of the licensable activities sought.
2. The decision making committee, in considering an application, must have regard to the adopted Statement of Licensing Policy and any relevant representations made by those directly affected.
3. An applicant for a new Premises Licence whose application has been refused, or who is aggrieved by conditions imposed, may appeal against the decision to the Magistrates' Court.
4. In considering this application the committee will sit in a quasi-judicial capacity and is thus obliged to consider applications in accordance with both the Licensing Act 2003 (Hearings) Regulations 2005, and amending secondary legislation and the rules of natural justice. The practical effect of this is that the committee must make its decision based on evidence submitted in accordance with the legislation and give adequate reasons for reaching its decision.

The committee must also have regard to:-

5. *Crime and Disorder Act 1998*
Section 17 of the Crime and Disorder Act 1998 places the Council under a duty to exercise its various functions with due regard to the likely effect of the exercise of those functions on, and the need to do all that it reasonably can to prevent, crime and disorder in its area.
6. *Human Rights Act 1998*
The Act requires UK legislation to be interpreted in a manner consistent with the European Convention on Human Rights. It is unlawful for the Council to act in a way that is incompatible (or fail to act in a way that is compatible) with the rights protected by the Act. Any action undertaken by the Council that could have an effect upon another person's Human Rights must be taken having regard to the principle of Proportionality - the need to balance the rights of the individual with the rights of the community as a whole. Any action taken by the Council which affects another's rights must be no more onerous than is necessary in a democratic society. The matter set out in this report must be considered in light of the above obligations.

Nothing beyond existing Health and Safety/Fire Safety etc requirements and the existing rules, regulations and responsibilities of a Licensee. The premises will promote the licensing objectives in accordance with Section 182 guidance.
All members of staff will be formally trained in their roles and responsibilities

b) The prevention of crime and disorder

A 5 camera multiplex CCTV system will be in operation with due warning signs displayed to the public of it's use within the shop. One interior camera is positioned to focus on the doorway and 1 exterior camera will help with the prevention and detection of crime and help with the protection of customers' and staff safety. Recording data will be timed and dated and have a minimum 31 days records. The Police and Local Authority Officers may have access to the system at any reasonable time and downloadable recordings on request. A refusal register is to be kept to record any incidents.

c) Public safety

Fire safety equipment includes alarms and 2 fire extinguishers which are regularly maintained. All electrical equipment is safety checked (pat tested). Fire exit signs are displayed and the staff instructed in emergency evacuation procedures.

d) The prevention of public nuisance

A litter bin is provided at the front of the shop and emptied regularly.
The front pavement is swept daily or more frequently if littered.

e) The protection of children from harm

A maximum of 2 unaccompanied children allowed in the shop at any one time.
Challenge 25 and "Pass" approved Notices displayed requesting valid proof of age for any age restricted products. "No I.D - No Sale". All staff are trained to serve alcohol and age sensitive products under the guidance of the DPS.

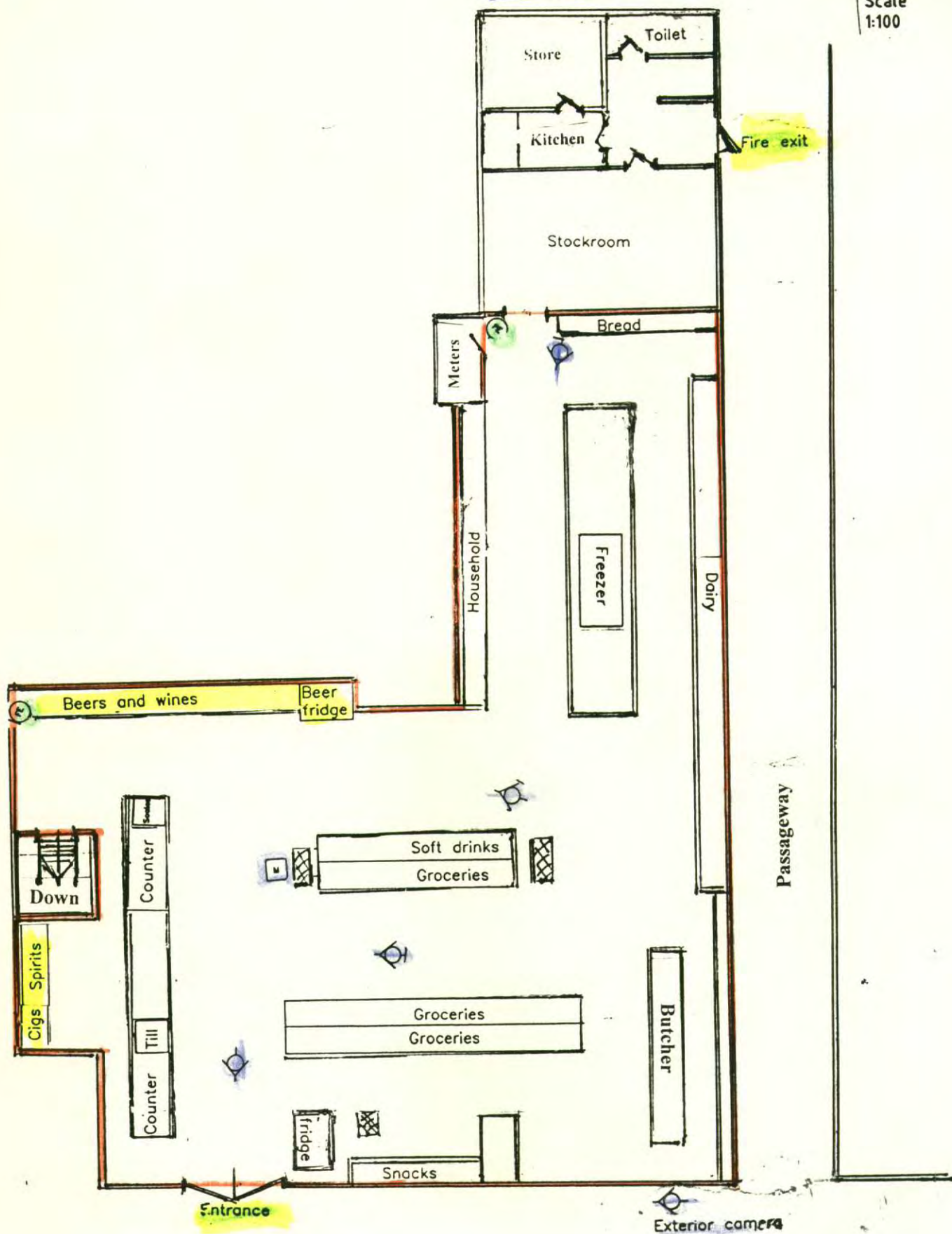

On behalf of the Chief Officer of Police, I am writing to lodge an objection to the above application on the following grounds:

- 1) The Prevention of Crime and Disorder
- 2) Public Safety
- 3) The Prevention of Public Nuisance
- 4) Protection of Children from Harm

Hampshire Constabulary believe that the evidence provided below supports their view that the issuing of a premises licence would significantly undermine the licensing objectives.

World Shop is situated along Shirley Road, Southampton, near to the junction of Howard Road and Payne's Road. This is an area locally known as Foyes Corner. This main road consists of both commercial and residential properties. The commercial outlets offer different services including food, alcohol, pharmacy services and hardware goods. The roads running behind Shirley Road are predominantly residential. Running alongside the residential boundaries are alleyways and car parking areas. Also located opposite World Store is a junior school, St Marks Junior School.

Hampshire Constabulary regularly consult with the local community and residents in the PACT (Police and Community Together) meetings, at which local policing priorities are set. The current priority in this particular area is the issue surrounding vagrants sleeping, drinking alcohol in the street and urinating in and around the area of Shirley Road. Street drinkers and the homeless are attracted to the area due to the number of alleyways and car parks which are out of view from police. This allows the congregation of groups, who not only leave litter and debris, but also use these areas to urinate and defecate. The offense caused by public areas being used as toilets is not confined to the alleyways and car parks. There have been a number of reports where people have urinated in local businesses, and in front of elderly pedestrians (Annex A, numbers 58, 59, 68, 53, 226, 238).

This is not only offensive and intimidating, but the availability of alcohol contributes to all the licensing objectives being undermined.

Some groups do not hide away to congregate, instead remaining in full sight, on private driveways, refusing to leave when asked by the home owner. Hampshire Constabulary also receive requests for assistance when the home owners feel too intimidated by the group. This is highlighted in Annex A, with reports in May 2012. (numbers 5, 7, 67)

Residents of Stafford Road, located behind Foyes Corner, report similar issues. On 26th July 2012, and again on 11th August 2012, a resident of Stafford Road reported that a group were loitering in a

car park to the rear of the property, being very loud and causing a general nuisance. These reports show that the licensing objectives of the prevention of public nuisance and crime and disorder are being undermined.

Businesses along Shirley Road also contact Hampshire Constabulary, reporting drinkers congregating outside their premises. On 2nd October 2012, there is a report from an insurance company, where the informant reports four males urinating outside the building while customers are using the store. On 25th October 2012, a cake store reported that staff and customers were intimidated by a group of males drinking immediately outside the store. Century Bingo Club are regular callers, reporting incidents including groups drinking on their steps, urinating in the car park, and congregating in the fire exit areas, causing issues with public safety and nuisance. These reports are shown in Annex A.

St Marks Junior School, Stafford Road, is not immune to the problems suffered in the local area. Being alongside Shirley Road, staff also report issues to Hampshire Constabulary. Notably, in July 2012, the school reported that a male was sniffing gas, was drunk and had his 'flies undone'. This was reported at 15:01 hours, when children would be leaving the school. On 6th September 2012, the school reported that a male, in drink, was asleep in the car park. This male was moved off by police, but remained in the area, with police receiving a further call about his behaviour later in the afternoon from another resident. The school and parents have made further reports to police in September relating to drunken people in the area of the school. This shows that the availability of alcohol off-sales in the area are putting children at risk of emotional, mental or physical harm. Hampshire Constabulary believe that this application will not be able to support the objective to prevent children from harm, as the application only focuses on the sale of alcohol from the store to underage children.

Hampshire Constabulary have been working with other agencies, including Social and Private landlords, Southampton City Council, The Street Prevention and Homeless team, to tackle the issue. Beggars have been reported for summons where appropriate. The Designated Public Place Order (DPPO) is utilised, whereby alcohol and containers are confiscated from people drinking alcohol in public and disposed of. Despite this work, the issue still remains in the area and impacts significantly on the lives of the members of public.

A schedule has been submitted which outlines a number of conditions World Shop is willing to run by. However, Hampshire Constabulary believe that the opening of an additional licenced premises in this area will exacerbate the issues already experienced by the community, thus undermining the licensing objectives.

Hampshire Constabulary believe that an additional premises at this location would lead to an exacerbation of the problems already encountered by the community. However, should it be decided that a licence ought to be granted then the following conditions would be requested:

1) CCTV

The premises shall have sufficient cameras located within the premises to cover all public areas including outside of the premises covering the entrance and exit. The system will be able to cope with strobe lighting (where used) and all levels of illumination throughout the premises as well as outside areas.

CCTV warning signs to be fitted in public places.

The CCTV system must be operating at all times whilst the premises are open for licensable activity. All equipment shall have a constant and accurate time and date generation.

The recording system will be able to capture a minimum of 4 frames per second and all recorded footage must be securely retained for a minimum of 28 days.

Records must be made on a weekly basis and kept for inspection to show that the system is functioning correctly and that data is being securely retained.

The DPS or premises manager must be able to demonstrate that the CCTV system has measures to prevent recordings being tampered with, i.e. password protected.

There shall be sufficient members of trained staff at the premises during operating hours to be able to provide viewable copies immediately to police on request when investigating allegations of offences or criminal activity. Any images recovered must be in a viewable format on either disc or VHS. Footage supplied in a digital format on CD or DVD will also have a copy of the CCTV system software enabled on the disc to allow playback.

In the event of technical failure of the CCTV equipment the Premises Licence holder/DPS MUST report the failure to the Hampshire Western Police Licensing Unit within 24 hours.

2) Incident book

An incident book will be provided and maintained at the premises. It will remain on the premises at all times and will be available to police for inspection upon request.

Any incidents that include physical altercation or disorder, physical ejection, injury, id seizure or drug misuse will be recorded in the incident book. The entry is to include an account of the incident and the identity of all person(s) involved (or descriptions of those involved if identity is not known). Should there be any physical interaction by members of staff and the public the entry will include

what physical action occurred between each party. The entry shall be timed, dated and signed by the author.

If the member of staff creating the entry has difficulties reading or writing then the entry may be written by another staff member. This should however be read back to the person creating the entry and counter signed by the person who wrote the entry.

At the close of business on each day the incident book will be checked by the manager on duty where any entries will be reviewed and signed. If incidents have occurred the duty manager will de-brief door staff at the close of business. Should there be no incidents then this will also be recorded at the close of business in the incident book.

3) Refusals book

A written log shall be kept of all refusals including refusals to sell alcohol. The Premises Licence Holder shall ensure that the refusals log is checked, signed and dated on a weekly basis by the store manager/manageress.

The refusals log will be kept and maintained at the premises and will be available for inspection immediately upon request by Hampshire Constabulary and any responsible authority.

The record of refusals will be retained for 12 months.

For clubs include- Identification seizures should also be recorded.

4) Challenge 25

There will be a Challenge 25 policy operating at the premises. Challenge 25 means that the holder of the premises licence shall ensure that every individual, who visually appears to be under 25 years of age and is seeking to purchase or be supplied with alcohol at the premises or from the premises, shall produce identification proving that individual to be 18 years of age or older.

Acceptable identification for the purposes of age verification will include a driving licence, passport or photographic identification bearing the "PASS" logo and the persons date of birth.

If the person seeking alcohol is unable to produce acceptable means of identification, no sale or supply of alcohol will be made to or for that person.

'Challenge 25' posters shall be displayed in prominent positions at the premises.

5) Training-

Staff will be trained regarding appropriate precautions to prevent the sale of alcohol to persons under the age of 18, the signs and symptoms of drunk persons and the refusal of sale due to intoxication. Records will be kept of such training which must be signed and dated by the member of staff who has

received that training.

All staff will receive refresher training every six months as a minimum and records are to be kept of this refresher training which should be signed and dated by the member of staff who received that training.

In addition to their training a written test related to the training given will be conducted before the staff member is permitted to sell or authorise alcohol. The test will consist of a minimum of ten questions of which the pass rate is 80%. Anyone who fails to reach the prescribed pass rate will be retrained and re-tested. Anyone not attaining the pass rate will not be permitted to sell or authorise the sale of alcohol until the pass rate is attained. There will be a minimum of two sets of questions to be used in the training which will be rotated upon each subsequent six month training session.

All training records will be made immediately available for inspection by Hampshire Constabulary and any responsible Authority upon request. Training records will be kept for a minimum period of two years. Training records will be kept on the licensed premises to which they relate to.

I am the above mentioned police officer and am currently based at Shirley Police Station, 390 Shirley High Street, Southampton, SO15 3JG.

At present I fulfil the role of an Engagement Police Officer which is a police officer who has a specific responsibility for an area and their primary role is to address the concerns of the community. An Engagement Officer is the conduit between the community and the front line policing effort in Southampton. My area of responsibility includes Shirley Road and Shirley High Street in Southampton and I have been working in this role for about 18 months. Every 3 months we have meetings with members of the community to set policing priorities. One of the priorities for this area is street drinking and related Anti-Social behaviour.

One of the area's that have been highlighted, by the community, to the police is a location 150 Shirley Road up to about 250 Shirley Road, Shirley, Southampton. This location is often referred to as Foyes Corner. This is close to the road junction of Paynes Road, Shirley Road and Howard Road. There are a number of commercial premises along this stretch of road which are inter-dispersed with retail outlets selling food, alcohol to hardware goods. There are also a number of residential premises that are dotted along this main road and also back on to the shops and commercial premises. Behind the commercial and retail premises there are parking area's which are out of view from the main road and off these parking area's there are alleyways that lead on to residential roads. These alleyways are also secluded and run alongside residential boundaries. World Store is situated along this stretch of road with an address of 210 Shirley Road, Southampton.

The following issues have been encountered in the area referred to above:

The Store is at of the Shirley Road that has a current problem with street drinking.

The street drinking is persistent and has given rise to a lot of Anti-Social behaviour in the local area.

The street litter has accumulated at the rear of the premises which back on to premises indicated above.

There is a local parking area servicing local businesses directly behind the premises and one over the Road behind the Co-operative store on Shirley Road. These area's attract street drinkers as they are not in direct view of the police however they are rowdy and unsightly for local residents whose premises over look and back on to the car parks.

The police receive numerous calls from the people working at these premises about feeling intimidated by the drunken group who hang around drinking.

The working professionals encounter these people when they leave work.

The groups that congregate not only leave street litter but also leave human waste products which are offensive to those who are permitted to use the local car parks.

There is an alley way that leads from the rear parking area out on Stafford Road and therefore the street drinking and related Anti-social behaviour spreads into the local residential community and is disruptive to local residents. The alleyway is also littered with street litter and human waste products which is not only offensive but provides a health and safety risk to local residents.

Efforts to keep the area clean have been made by the police in conjunction with the council however there are limited resources to attend the area regularly and therefore the unsightly debris is left lying around for long periods of time.

Other options of gating the area and a long term solution have been explored by the council however, there is some dispute about who owns the land and the council no longer supported gated projects as they are difficult and costly to manage. Therefore, the only solution to the problem of litter and Anti-social behaviour is enforcement by the Police and the City Council. There is already a problem and therefore we would not want to compound it by another premises opening.

There are already a number of premises selling alcohol in the area and a further premise will add to the already high concentration of licensed premises in the area and could well attract more people to engage in Street drinking.

One of our high problem area's is Stafford Road which is just around the corner from the World Store and therefore this again means that the acquisition of alcohol leads to people congregating in this neighbouring road to consume their drinks. This is disruptive to the local residents.

There are also a number of supported living multi-occupancy premises on this road who are vulnerable to alcohol use and this again compounds the street drinking problem in the area.

Engagement with the supported housing landlords has been completed and they are offering the relevant alcohol intervention to assist the vulnerable persons in Stafford and neighbouring roads. Their work is challenging and therefore, another outlet providing alcohol is not going assist with the long term solution of the reduction in Street drinking, Anti-social behaviour and alcohol dependency.

There are a number of multi-occupancy residences in the area and the licensed premises are often an area of congregation after work and results in a "wind down" after a busy day at work. This includes the consumption of alcohol.

A recent initiative has been completed in local residential Roads- Nightingale and Dyer Road, to address street drinking. These roads are within a close proximity of the area of concern.

St. Marks Junior School is also situated in the area being considered and they have recently been affected by drug people at their front gate when children are arriving at school.

The local safer neighbourhood engagement team have worked hard with Social Landlords, the City Council, private landlords, St Marks School, the Street Prevention and Homeless team of Southampton and local intervention key workers to reduce the street drinking in this area. The number of reported incidents has decreased over the past year due to this hard work and multi-agency approach. Work is continuing to reduce the incidents further and therefore another Licensed premise which could encourage congregation of members of the public, within an already congested area, would not improve the quality of life of local residents. Another retail outlet selling alcohol would increase the accessibility of alcohol to vulnerable persons and the general public in an area which is already amply serviced by Licensed premises. The area continues to be patrolled with a zero tolerance approach by the police and use of Legislation to deal with Anti-Social Behaviour and Street Drinking. The local safer neighbourhood engagement team would therefore not support the approval of yet another License being awarded in this locality.

To Whom it May Concern

I am the Safer Neighbourhood Team Inspector for Shirley part of my role is to ensure that my staff are deployed in the right areas to tackle crime and anti social behaviour.

By far and away the biggest issue for both Police and members of the public is anti social behaviour which is fuelled by alcohol. This is supported by the numbers of incidents we have reported through the control room and through our engagement with members of the community.

We have various ways of tackling this problem which include the alteration of staff working hours and specifically targeted operations, including educating adults regarding the purchasing of alcohol for juveniles by placing Police Officers outside licensed premises, we also mark bottles within various licensed premises to identify where alcohol is being purchased that we seize from juveniles. There have been successes in this area and this can be measured but fewer calls received from members of the public regarding anti social behaviour.

We hold priority setting meetings across the Division and time and time again one of the main issues for those attending is anti social behaviour fuelled by alcohol. This is a particular problem in this part of Shirley where we receive not only reports of ASB but of the groups involved leaving human waste is an around the area, this is not only offensive to all that either live there or pass by, but is a health and safety risk. Several joint operations have been carried out with Southampton City Council to clean up the area and following these the area remains clean for a very short period of time before being returned to it previous state.

There are already several shops in this area with alcohol licences, and local residents are able to attend these other stores close by in order to purchase alcohol. All these stores regularly report alcohol thefts, and problems with persons congregating around the store, intimidating customers and trying to obtain alcohol. There are also a number of multi-occupancy, supported living premises in the vicinity that are seeking to help those with alcohol and drug addiction. I feel that if more premises in Shirley Road do start selling alcohol, the current level of disorder and disruption to local residents will increase dramatically.
