

### **Legal Implications**

- 1. The Licensing Act 2003 specifically restricts the grounds on which the Council, as Licensing Authority (LA), may refuse an application for a new Premises Licence, or impose conditions. Where relevant representations are made, the LA may refuse on the grounds that the licensing objectives are not met or the operating schedule is inadequate. Equally, conditions may be imposed where relevant and necessary. The LA may also refuse an application in part and thereby only permit some of the licensable activities sought.
- 2. The decision making committee, in considering an application, must have regard to the adopted Statement of Licensing Policy and any relevant representations made by those directly affected.
- 3. An applicant for a new Premises Licence whose application has been refused, or who is aggrieved by conditions imposed, may appeal against the decision to the Magistrates' Court.
- 4. In considering this application the committee will sit in a quasi-judicial capacity and is thus obliged to consider applications in accordance with both the Licensing Act 2003 (Hearings) Regulations 2005, and amending secondary legislation and the rules of natural justice. The practical effect of this is that the committee must make its decision based on evidence submitted in accordance with the legislation and give adequate reasons for reaching it's decision. #### 5. Crime and Disorder Act 1998

Section 17 of the Crime and Disorder Act 1998 places the Council under a duty to exercise its various

functions with due regard to the likely effect of the exercise of those functions on, and the need to do all

#### 6. Human Rights Act 1998

The Act requires UK legislation to be interpreted in a manner consistent with the European Convention on Human Rights. On behalf of the Chief Officer of Police, I am writing to lodge a representation of the above application on the following grounds:

- 1) The prevention of Crime and Disorder
- 2) Public Safety
- 3) The Prevention of Public Nuisance
- 4) The protection of children from harm

The police have concerns over the application. These concerns are outlined below:

Should the sale of alcohol from 2000hrs to 2300hrs be implemented as a new condition this would undermine both the Premise Licence and the Crime Prevention objectives.

On 25th June, 2014 an application to vary a premises licence under the Licensing Act 2003 was received from Best One, St Mary's Street, Southampton.

Best One is a small shop/off licence located on a main street among other small retailers and a public house (Joiners) opposite. This location is very close to a large residential housing estate.

This shop is located within an area of already high antisocial behaviour, although not all of the antisocial behaviour can be attributed to this shop, this shop hasn't helped with the problem by selling to street drinkers, underaged children, selling single cans of high level alcohol to customers and to the customers of the public house adjacent (Joiners) which is all in breach of the premises licence.

It is believed that should the alcohol hours be extended then the antisocial behaviour in this area may increase and encourage more street drinking.

(attached appendix 1 covers some of the anti social incidents that have occurred at and around this location since the beginning of the year 2014)

Although Mr Khushdil is a new premises licence holder for this shop and therefore not responsible for these previous incidents, he was unable to assist with cctv which covered an

incident on the eve of his receiving the premises licence, thus not being able to adhere to his conditions on the licence. When speaking to Mr Khushdil he wasn't aware of his responsibilities as either the premise licence holder or the designated premises supervisor. Mr Khushdil further breached his licence by continuing to sell alcohol whilst having no operating cctv. The alcohol was still being displayed openly to customers which contravenes S137, and was only removed from the shelves after a Police visit and a further visit from Southampton City Licensing who attended and advised him that he was again in breach of his licence and his conditions.

Furthermore, since Mr Khushdil has taken ownership of this shop he hasn't had the fortune of electricity owing to contractural issues thus rendering his alcohol sales as nil; therefore Police have not had an opportunity to review Mr Khushdil as a designated premises supervisor and for him to prove himself as a responsible person within this role.

This area of Southampton is already in great need of regeneration, with the added problem of antisocial behaviour in this area, and an area known for street drinking, it would be beneficial at this time to keep the alcohol conditions at 2000hrs and not extend them to 2300hrs as requested. It is believed by extending the hours to sell alcohol may add to the problems and again undermine the crime and prevention objective.

Attached as Appendix A is a list of relevant incidents in the immediate area of the premises. There are 20 such incidents over a period of a 4 month time frame. Highlighted are a few examples.

16/5/14 @ 2111hrs male seen drinking on road open can of lager, PCSO removed can male became abusive, public order offence

16/4/14 @ 1804hrs female has entered shop bought 8 cans of Polish beer and a bottle of Smirnoff, left shop and handed it to a group of underaged youths

15/03/14 @ 1802hrs & 1709hrs drunk male in and outside of shop falling around being abusive and a nuisance, pestering customers

This appendix highlights some of the anti social behaviour in this area attributed to drink which can seriously undermine the premises licence and would compromise the licensing objective for the prevention of crime and disorder.

Therefore we feel that the Premise Licence Holder/Designated Premises Supervisor needs to demonstrate that he can operate as a responsible retailer before we can agree to increasing his hours for the sale of alcohol. At present he is breaching his conditions and thus adding to the anti social behaviour which the area suffers and thereby not supporting the Licensing objectives.

It is an offence, under section 158 of the Licensing Act 2003 to make a false statement in or in connection with this representation
