Legal Implications

- 1. Part 3 of the Licensing Act 2003 provides that a responsible authority of a resident or business in the vicinity (interested party) may apply for review of a premises licence.
- 2. The grounds of review applications must relate to one or more of the licensing objectives.
- 3. In such circumstances, the applicant for the review must serve a copy of the review application on the holder of the premises licences, the City Council and each of the responsible authorities.
- 4. On receipt of the application for review, the officers will consider its validity, under delegated powers. Reasons for rejection, in whole or in part, include:
 - that the grounds for review are not relevant to one of more of the licensing objectives and;
 - (in the case of an application not made by a responsible authority), that the application is frivolous, vexatious or repetitious.
- 5. The City Council must, within one day of receiving the application for review, display a prescribed notice of the review application on the outside or adjacent the premises;

- 6. Unless the applicant, licence holder, interested parties and responsible authorities agree that a hearing is unnecessary, the City Council is then required to hold a hearing to consider the review.
- 7. The sub-committee, in considering the application for review, must have regard to the adopted Statement of Licensing Policy and evidence before it at the hearing.
- 8. The Licensing Act 2003 provides that, in determining an application for review, the sub-committee may take any (or none) of the following steps, as it considers necessary:
 - · modify the conditions of the licence;
 - exclude a licensable activity from the scope of the licence;
 - remove the designated premises supervisor;
 - suspend the licence for a period not exceeding three months;
 - revoke the licence.
- 9. The Licensing Act 2003 makes provision for appeal to the Southampton Magistrates' Court against the sub-committee's decision in relation to an application for review.
- 10. In considering this application the sub-committee will sit in a quasi-judicial capacity and is thus obliged to consider applications in accordance with both the Licensing Act 2003 (Hearings) Regulations 2005, and amending secondary legislation and the rules of natural justice. The practical effect of this is that the sub-committee must makes its decision based on evidence submitted in accordance with the legislation and give adequate reasons for reaching its decision.
- 11. Copies of the application for review and the Police objection are annexed to this report.
- 12. The sub-committee must also have regard to:-
- 13. Crime and Disorder Act 1998

Section 17 of the Crime and Disorder Act 1998 places the Council under a duty to exercise its various functions with due regard to the likely effect of the exercise of those functions on, and the need to do all that it reasonably can to prevent, crime and disorder in its area.

14. Human Rights Act 1998

The Act requires UK legislation to be interpreted in a manner consistent with the European Convention on Human Rights. It is unlawful for the Council to act in a way that is incompatible (or fail to act in a way that is compatible) with the rights protected by the Act. Any action undertaken by the Council that could have an effect upon another person's Human Rights must be taken having regard to the principle of proportionality - the need to balance the rights of the individual with the rights of the community as a whole. Any action taken by the Council which affect another's rights must be no more onerous than is necessary in a democratic society. The matters set out in this report must be considered in light of the above obligations.

Please state the ground(s) for review (please read guidance note 1) The Prevention of Crime and Disorder Public Safety
On 4 th November 2010, during an inspection at Georges, 6 Athelstan Rd, Southampton I found counterfeit and non-Uk duty paid vodka in possession for sale.
Counterfeit vodka has increasingly been found by Trading Standards Officers around the country. It is often produced from industrial alcohol which is imported into the UK. It is diluted and packed in bottles which are copies of a variety of brands. Clearly controls over the quality of the product are not as strict as would be found at a distillery producing the genuine product, and issues have been reported regarding excessive levels of methanol being present, which is poisonous.
Paragraph 11.26 of the October 2010 Amended Guidance Issued Under Section 182 of the Licensing Act 2003 states that "there is certain criminal activity that may arise in connection with licensed premises, which the Secretary of State considers should be treated particularly seriously." Which includes "the use of the licensed premises for the sale of smuggled tobacco and alcohol". Appropriate duty would not have been paid on the vodka.
It is considered that the holder of the premises licence has not fufilled the duty under the Licensing Act 2003 to prevent crime and disorder and to protect public safety. We are therefore applying to revoke the licence.
In the supporting information we give more details and state the reasons for the request for revocation.

Please provide as much information as possible to support the application (please read guidance note 2)

On 4th November 2010 I conducted an inspection at Georges, 6 Athelstan Road, Southampton. I targeted Georges because I had previously found counterfeit vodka at a premises associated with the family involved in Georges, namely London Off Licence 2, 27 St Catherines Rd, Bitterne. In brief Ozgur Ekinci is the Premises Licence Holder at Georges and is the Designated Premises Supervisor at Georges and London Off Licence 2. He is also a director of the company which trades as London Off Licence 2.

During the inspection I examined five 70cl bottle of Glen's brand vodka which were displayed for sale behind the counter. I believed that they were counterfeit so I took one as a food sample, reference 012106, (exhibit LDM/1) and the remaining 4 bottles, which were identically marked (exhibit LDM/2). I found a case of 6 identically labelled bottles of Glens Vodka in the store room, which I seized (exhibit LDM/3). The public analyst subsequently confirmed that vodka sampled was not genuine Glen's Vodka (Certificate of Analysis exhibit LDM/7). I also found 4 bottles of Lithuanian Vodka, displayed for sale behind the counter, which did not bear the UK Duty Stamp. I took one bottle as exhibit LDM/6.

On 3rd December 2010 I conducted an audio recorded interview with Ozgur Ekinci (CD exhibit LDM/8). Mr Ekinci stated that he has been offered Glen's vodka by hawkers from vans, however he had not purchased any. He said that he only buys from wholesalers, such as Bookers, Eastenders Cash & Carry and Batleys. It is unlikely that these businesses would sell counterfeit vodka. Mr Ekinci stated that the counterfeit vodka had originated from 3 cases which he had inherited from the previous business owner, when he took over in January 2010. I doubt whether 3 cases of Glens would have lasted this long and would assume that Mr Ekinci had bought the counterfeit vodka since then: from the receipts which I have seen (exhibits LDM/5 and LDM/9) Glen's vodka appears to be a regular purchase, and I would therefore assume, a good seller. Mr Ekinci confirmed that he knew the potential dangers of drinking counterfeit vodka, and that I had previously advised him regarding identification of counterfeit spirits. He said that he had not started checking the stock in Georges and had not obtained a UV light to check the duty stamps. He also claimed that he had inherited the non-UK duty paid Lithuanian vodka from the previous owners of Georges. He said that he did not know that he could not sell it. This should be basic knowledge for a Premises Licence Holder, and it is extremely easy to check whether a spirit is not UK duty paid.

Incidents of poisoning following consumption of counterfeit vodka have been reported occurring across the UK. I have appended a report which appeared in the BBC News regarding counterfeit Glens Vodka which caused two people to require hospital treatment following consumption. It is not acceptable that a premises licenced by this Authority should become a market place for such goods. Sale of counterfeit and non duty paid alcohol also creates unfair competition, which has a negative impact on law abiding traders. I had given Ozgur Ekinci advice regarding the potential health problems caused by counterfeit vodka, and precautions that he could take to prevent purchase and sale of counterfeit vodka, following the problems I had found at London Off Licence 2. He failed to heed that advice. I would therefore request that the licence is revoked.



Warning over fake vodka dangers

Fake vodka found in Surrey which led to two people needing hospital treatment after drinking it, has led to warnings from trading standards officers.

Officers said the counterfeit Glen's Vodka contained higher levels of methanol than normal.

Spokesman Peter Denard said he was "extremely concerned" that it was being sold and urged anyone who found any to contact the county council immediately.

He said an excess intake of methanol could cause poisoning.

He listed the symptoms as nausea and vomiting, abdominal pain, drowsiness and dizziness, blurred vision leading to blindness, and breathing difficulties.

And he added that symptoms of methanol poisoning could take several hours to develop, so anyone who may have drunk the counterfeit vodka should seek immediate medical advice.

Embossed markings

Genuine Glen's Vodka was only in bottles from Allied Glass Containers which have a small "AGC" logo on their base.

The real Glen's bottles also read "70cl 58mm C12173", embossed in the glass close to the base.

Mr Denard said that any bottle of Glen's Vodka without the two markings was counterfeit.

Counterfeit products found so far have displayed different codes.

The fake vodka appears to have self-adhesive labels, while the genuine product has a distinctive glue pattern on the back of the label resulting in horizontal lines, he added.
