Legal Implications

- 1. Part 3 of the Licensing Act 2003 provides that a responsible authority of a resident or business in the vicinity (interested party) may apply for review of a premises licence.
- The grounds of review applications must relate to one or more of the licensing objectives.
- In such circumstances, the applicant for the review must serve a copy of the review application on the holder of the premises licences, the City Council and each of the responsible authorities.
- 4. On receipt of the application for review, the officers will consider its validity, under delegated powers. Reasons for rejection, in whole or in part, include:
 - that the grounds for review are not relevant to one of more of the licensing objectives and;
 - (in the case of an application not made by a responsible authority), that the application is frivolous, vexatious or repetitious.
- 5. The City Council must, within one day of receiving the application for review, display a prescribed notice of the review application on the outside or adjacent the premises; the notice must remain on display for 28 days and any interested party in the vicinity or the responsible authorities may make representations in that period.
- 6. Unless the applicant, licence holder, interested parties and responsible authorities agree that a hearing is unnecessary, the City Council is then required to hold a hearing to consider the review.
- 7. The sub-committee, in considering the application for review, must have regard to the adopted Statement of Licensing Policy and evidence before it at the hearing.
- 8. The Licensing Act 2003 provides that, in determining an application for review, the sub-committee may take any (or none) of the following steps, as it considers necessary:
 - modify the conditions of the licence;
 - exclude a licensable activity from the scope of the licence;
 - remove the designated premises supervisor;
 - suspend the licence for a period not exceeding three months;
 - revoke the licence.
- 9. The Licensing Act 2003 makes provision for appeal to the Southampton Magistrates' Court against the sub-committee's decision in relation to an application for review.
- 10. In considering this application the sub-committee will sit in a quasi-judicial capacity and is thus obliged to consider applications in accordance with both the Licensing Act 2003 (Hearings) Regulations 2005, and amending secondary legislation and the rules of natural justice. The practical effect of this is that the sub-committee must makes its decision based on evidence submitted in accordance with the legislation and give adequate reasons for reaching its decision.
- 11. Copies of the application for review and the Police objection are annexed to this report.
- 12. The sub-committee must also have regard to:-
- 13. Crime and Disorder Act 1998

Section 17 of the Crime and Disorder Act 1998 places the Council under a duty to exercise its various functions with due regard to the likely effect of the exercise of those functions on, and the need to do all that it reasonably can to prevent, crime and disorder in its area.

14. Human Rights Act 1998

The Act requires UK legislation to be interpreted in a manner consistent with the European Convention on Human Rights. It is unlawful for the Council to act in a way that is incompatible (or fail to act in a way that is compatible) with the rights protected by the Act. Any action undertaken by the Council that could have an effect upon another person's Human Rights must be taken having regard to the principle of proportionality - the need to balance the rights of the individual with the rights of the community as a whole. Any action taken by the Council which affect another's rights must be no more onerous than is necessary in a democratic society. The matters set out in this report must be considered in light of the above obligations.

On behalf of Hampshire Constabulary, I submit the following application for KAOS, 94-96 St Mary's Road, Southampton in order to review their license. In our opinion it not supported the licensing objectives. The review is brought to uphold three of the licensing objectives i.e. the prevention of crime and disorder, public safety and the prevention of public nuisance.

The premise in question is situated in a cumulative impact zone, which you, as the council have recognised and implemented into your policy. The cumulative impact policy was introduced by you because of the key findings and recommendations of a police report. This report identified that there were three areas in which there is a record of violent offending that is disproportionately high in terms of the city as a whole. It identified the following-

- The peak times for violence are in keeping with peak times for the night-time economy
- Each of these locations record an above average level of offences flagged as having been influenced by alcohol.
- In terms of offences where a premise is directly involved, all three locations record multiple offences.
- The overall trend with regard to these offences is either steady or upward.
- Both the Above Bar and Bedford Place/London Road areas also record a disproportionately high level of criminal damage.

Following this report, Southampton City Council took the responsible action of implementing a policy covering the three areas of concern to be used as a tool to control violent crime and alcohol related offending. As I am sure your aware your own statement of licensing policy states that under the Licensing Act 2003 you have a duty to promote the four licensing objectives which are-

- The prevention of crime and disorder
- Public safety
- The prevention of public nuisance and
- The protection of children from harm

Further to this, Section 17 of the Crime and Disorder Act 1998 imposes an obligation on every police authority and local authority to do all that it can to reasonable prevent –

- crime and disorder in its area including anti-social and other behaviour adversely affecting the local environment; and
- the misuse of drugs, alcohol and other substances in its area).

Therefore, I submit this application to review the licence of KAOS 94-96 St Mary's Road, Southampton.

Records must be made on a weekly basis and kept for inspection to show that the system is

functioning correctly and that data is being securely retained.

CCTV warning signs to be fitted in public places.

Recordings to be kept for a minimum of 28 days.

The DPS or premises manager must be able to demonstrate that the CCTV system has measured to prevent recordings being tampered with, i.e. password protected.

In the event of technical failure of the CCTV equipment the Premises Licence holder/DPS MUST report the failure to the Police on contact number 023-80674768 immediately .

Incident book

An incident book will be provided and maintained at the premises and there will be a daily debrief of door staff (where used) at the close of business which will be evidenced in writing by the Manager on duty. Should there be no incidents then this will also be recorded at the end of the shift in the incident book.

The incident book will remain on the premises at all times and will be available to police upon request.

The book shall detail in brief, incident of injury/ejection/refusals/drug misuse/ i.d seizure/age challenge. Where there is an injury, ejection of physical altercation the entry shall be timed, dated and signed by the author. If the member of staff involved has difficulties reading or writing then the entry may be written by another party. This should however be read back to the person involved and counter signed. Should there be any physical interaction by members of staff and public the entry will include what physical action occurred between each party.

Staff Training

Staff are trained regarding appropriate precautions to prevent the sale of alcohol to persons under the age of 18; signs and symptoms of drunk persons, refusal of sale due to intoxication and that records are kept of such training, which are signed and dated by the member of staff who has received the training; that staff receive refresher training every six months as a minimum and that records are signed and dated by the member of staff are kept of this refresher training. Records will be available for inspection by Hampshire Constabulary and the licensing Authority.

Dispersal Policy Condition

A dispersal procedure will be adopted during the last trading hour to ensure minimal disturbance to neighbours and to tackle the problem of anti-social behaviour and crime. This will include:

- during the last 30 minutes of trading the service points at the bar will be reduced and certain staff reallocated to collect glasses
- music volume will be reduced during the last 30 minutes of trading. Lighting levels will be raised to encourage the gradual dispersal of customers

- DJ announcements will be used to encourage gradual dispersal and to remind customers to leave quietly.
- door supervisors will remove all bottles and glasses from any customer who attempts to leave the venue carrying one.

All areas of the premises will be checked at the end of each evening to ensure all customers have left safely and a signed record of these checks to kept on the premises at all times and to be made available to the Police upon request.

Door staff wearing High Visibility fluorescant Upper Clothing will patrol the outside perimeter of the front of the premises at the end of each evening (for at least an additional 15 minutes or until persons are dispersed from the immediate area) to ensure the safe and quiet dispersal of customers. Any customers congregating or loitering outside after leaving the premises will be asked to depart quickly and quietly.

Notices will be displayed in prominent positions at the exit of the premises requesting customers to leave quickly and quietly.

In summary the Police evidence to support this application is as follows:-

On the 27th April 2010 at 0030 hrs Police attended the premise as a male was alleging that excessive force had been used by Door Staff at the premises in order to eject him and his friends.

Occurrence - 44100169085 refers.

On arrival the attending officers found appx 7 males all drunk.

A male had been asked to leave as he was drunk and becoming a problem to other persons

One of his friends had then become aggressive towards door staff and swung a punch at him.

This resulted in all of them being ejected from the premises from the rear entrance. The CCTV covering this area was not recording images and therefore could not be used by officers to establish if any excessive force had been used or not.

PC Sullivan from the Southampton Police Licensing Unit subsequently attended the premises and spoke with the DPS Chris Brady.

The CCTV Cameras covering this rear exit and the front door are monitored by a Door Supervisor in the front entrance lobby but wasn't recording.

It was pointed out that these areas are important as they are both areas of potential conflict and currently no evidence is being recorded should such allegations be made against staff. The DPS stated that steps would be taken to resolve this issue.

Following this visit a letter was sent to the DPS by PC Sullivan.

This incident demonstrated that the Licensing Objectives were not being supported as persons were being allowed to become drunk in the premises and the CCTV system was not capturing images from a key area within.

On the 2nd May 2010 a further issue involving a drunken person occurred at the premises when a male was ejected from KAOS for being drunk.

Occurrence 44100177431 refers.

Once outside this man tried to push a delivery rider from a nearby Pizza Take - Away off of his moped and swung a punch at the Take - Away's manager.

He was detained by the Door Staff from KAOS and was subsequently arrested for drunk and disorderly behaviour by the Police.

On his arrest he was found to be in possession of controlled drugs namely Amphetamine Powder.

This incident further highlights the need for staff training with regards to due diligence concerning drunkeness on the premises.

On the 1st October 2010 PC Sullivan spoke with Mr Robert White the co- premises licence holder of KAOS.

A letter of complaint from residents of Bellevue Road had been received by Insp Bates concerning Anti Social Behaviour issues in the road that they allege peak when the premises is open (i.e.during student term times).

Mr White was advised to keep an eye on the levels of drunkeness of his customers as this often determines the levels of Anti Social Behaviour displayed.

His attention was drawn to the letter sent to the outgoing DPS Chris Brady regarding the lack of recording capability for the cameras covering the entrance and exit of his premises, he was advised to ensure that these key areas are covered by a recording system as soon as possible and to let me know when this had been is done.

No correspondence concerning this has been received.

On the 7th November 2010 a female customer was racially abused as she left the premises.

Occurrence 44100472427 refers.

As the female left the club a drunk male standing outside the entrance close to the doorstaff and who had been drinking in the premises previously racially abused her, and then followed her across the road continuing to do so, causing her to become distressed. He was detained by the Door Staff from KAOS and upon Police arrival was arrested, he was very drunk.

This is another incident involving a drunken person only 6 months later that once again

highlights the need for due diligence staff training with regards to drunkeness on the premises.
On the 20 th November 2010 a male and his girlfriend were assaulted outside the premises, causing actual bodily harm.
Occurrence numbers 44100491446 and 44100491671 refer.
The two aggrieveds had been in the premises and on leaving were stood in the road opposite the club. Following a verbal altercation a female punched both the aggrieveds causing ABH injuries.
The offender was arrested and she stated in interview that she had been very drunk and was unable to remember much and doesn't remember getting into a fight.
CCTV footage was provided by the premises but this could not be played on Police systems and was therefore of no use.
This highlights the need for the CCTV system at the premises to be able to produce footage on a format compatible with Police requirements, and once again highlights the need for staff training with regards to drunkeness on premises.
On the 29 th December 2010 PC Harris and PS Marshman from the Police Licensing Unit attended a meeting at the premises with Mr & Mrs White and the manager Mr Eiken.
During this meeting the issue of incident books was raised, the manager stated that the premises had one but couldn't produce one for inspection.
It was agreed that they would now operate with one, recording end of night debrief with Door Staff at the end of each night, all incidents recorded and if no incidents occur then this too will be recorded and also drunks refused entry. The manager was advised that any drunks of particular concern that hang around likely to cause more problems should be brought to police attention for consideration fo S27 dispersal/ yellow card. He undertook to remind Door Staff and Bar Staff to be vigilant regarding drunks, as he accepted that persons are coming to the premises having "Pre- Loaded" with alcohol.
Concerns regarding CCTV were discussed, the issue whereby the cameras covering the entrance and exits were not recording has been addressed, but there is more than one operating system and the manager was not sure how to use a number of them. He was able to review footage from cameras 1 to 4 on the new system but could not do so on the older systems.



He undertook to refresh himself on the operation of the system and recontact the Police in

the new year when the business re opens. At this time the following cameras were operating correctly: Cam 1 - front door (Left) Cam 2 - Car park Cam 3- Front door (right) Cam 4 - Back garden Therefore, even after 6 months of Police trying to resolve the CCTV issues at the premises it was still inadequate. On th 6th January 2011 the Manager Mr Eiken sent an e mail to PC Harris detailing how the premises intend to upgrade the CCTV system with new hard drives, and asking for an opinon as to whether what they proposes would be satisfactory. PC Harris replied by querying why they intended to have 4 small hard drives instead of 1 larger one and sent a CCTV Condition wording recommending that it be used as a guideline. The subsequent reply explained that they were going to replace the existing hard drives that currently do not work.

On the 13th February 2011 PC Sullivan visited the premises and spoke to Mr Eiken who by now was the DPS, the Hard Drives required to ensure that all images viewable on the CCTV system are captured had not been delivered by one of the clubs owners Mr White as was promised.

He didn't know why but was asked to impress upon him the need for them.

On the 4th March 2011 PC Sullivan visited the premises with PC Prior and spoke to the DPS Mr Eiken regarding the CCTV system.

PC Sullivan noted that the CCTV system at the premises is quite complex in that it has evolved and therefore there are several monitors each one covering a different area of the premises and each one having its own hard drive as opposed to one large screen and one large hard drive covering them all.

The cameras that cover the step down to the rear garden area, the entrance lobby, an upstairs seating area, upstairs bar area and upstairs dance floor weren't able to record the images they showed.

These are key areas where conflict can occur and need to be covered.

Mr Eiken was advised of the polices concerns regarding the inability to record footage from
the cameras.
Not having these key areas covered by recordable CCTV highlights once more that the
licensing objectives were not being fully supported.
On the 16 th March 2011 & 25 th of March 2011 PC Sullivan visited the premises to further
check on any progress with the CCTV upgrade, he spoke to Mr Eiken the DPS and there
had been no progress. This would indicate the lack of support for the licensing objectives by
the venue.
On the 19 th March 2011 Sgt Marshman from Police Licensing visited the premises. The
dispersal of customers at the end of the evening was very poor. Sgt Marshman had to step
in and move people out of the road and once he did this they themselves started to take
steps to disperse customers.

I write as promised concerning the discussion we had during my visit to KAOS on Friday 11th June 2010 regarding the above.

This was in response to a report from a colleague who attended following an incident on 27/04/2010, where persons who had been ejected from the premises initially alleged that your door staff had used excessive force.

These individuals were all in drink at the time and in the end no subsequent substantive allegations were made.

However, when making enquires at the premises they have reported to me that they could not obtained CCTV images to assist them in their enquiries as the images were not being captured.

On speaking with you I now understand that you do have the capability of recording and storing images at the premises but not currently from the cameras covering the front and rear entrance and exit.

In our view the entrance and exit points of late night licensed premises are key points of potential conflict and in are areas that should be covered by a recordable CCTV system.

The Police believe that CCTV provides invaluable assistance in our joint effort to reduce incidents of crime and disorder and thus assists to promote one of the four licensing objectives, it can be of great help in protecting staff from assaults and spurious allegations and in aiding identification of individuals should there be a need.

I would therefore be obliged if you would take the necessary steps to enable those cameras to be connected to your recording systems.







I understand that you are now closed for the summer but would appreciate it if you could update with any progress in this matter.

Thank you for your support with regard to enforcing the licensing objectives.





PS MARSHMAN and i attended a meeting at Kaos today with the DPS irene White, Bob White, Harry Eiken (manager) and Jon Wallsgrove (solicitor) to discuss their potential request to extend their hours.

A number of matters were discussed around this request and the obvious hurdle is the location of the premise where it falls under the CIP. The fact that the venue would have to prove that its alteration in hours would not have an adverse impact on the area will be very difficult. We highlighted that there are already a number of complaints from residents, including one addressed to the Chief Superintendant about noise, damage to vehicles, persons urinating on premises/front doors which can be linked with their premise and other night time venues in Bevois Valley.

Harry was spoken to about an incident book and although he did say that he had one, he was not able to show one to us so we could compare the incidents we have recorded on RMS. It was agreed that they would now operate with an incident book, Harry will debrief all door staff at the end of each night, all incidents recorded and if no incidents this will be clearly marked. Refusals will also be added detailing drunks refused entry. Harry was told that any drunks of particular concern that hang around likely to cause more problems should be brought to police attention for consideration fo S27 dispersal/ yellow card.

CCTV was of concern, although the previous problem where the entrance and exits was not being recorded has been addressed, there is more than one operating system and Harry was not clear and how to use a number of them. He could only revview footage from camera 1 to 4 on the new system but could not do so on the older systems. He has my contact details and said he will have a refresher course and then get back to me. This will be after new year when the business reopens. So far the following cameras were operating sufficiently:

Cam 1 - front door (Left)

Cam 2 - Car park

Cam 3- Front door (right)

Cam 4 - Back garden

Hi Harry

Thanks for your email. I do remember the issues with the CCTV and that there is a mixture of old and new. I think changing / updating the hard drives would make sense on the basis it should ensure that you are always able to download footage and it will retain footage for up to 30 days. This is generally what we expect of all venues as a minimum and some even have particular wording on their licence. I do not think I would have any issue with the hard drive as it only records what the cameras see. The only issues that could arise are with the cameras and if they provide poor images. It is of course up to you if you spend the money on the hard drives. I am confused as to why you need 4 though. Can they just not give you one to cover all the cameras?

I have included the wording below for your information to give you some idea of what we expect from venues CCTV. If you use this as a guideline you should not go too far wrong.

(I) The premises shall have sufficient cameras located within the premises to cover all public areas including outside of the premises covering the entrance and exit. The system should be able to cope with strobe lighting and all levels of illumination throughout the premises as well as outside areas.

Not been able to get in touch via phone, I must keep missing you, so I thought I would send an e-mail.

Last week during our meeting regarding an extension of the trading hours for Kaos we agreed that you could come and take a second look at the C.C.T.V and check it is all in acceptable working order.

I don't know if you remember the system here but there are four different hard drives with different methods of downloading the software from each. What we have decided to do now is remove the three older hard drives and replace them with the newer style so we have four identical hard drives recording all the cameras, leaving us with just one simple method of getting the data off. The hard drive that I gave you a demponstration of when you were here is the one that we will be using for all. It is a month long loop recording, data is taken off with a memory pen and then put onto C.D/D.V.D via a laptop.

If you think this will be a good step for us we will put the order in for the hard drives and they should be ready to go in a week or so, once they have been delivered. Did you want to come round and view the system as it is, obviously with the view that the old ones will be replaced with new? Or would it be more sensible to view the system once the new gear has turned up? The only foreseeable downside to this second option is that if we order the new hard drives and then you view them and say for some reason they are not good enough we will be left with three brand new but useless hard drives.

If you could let me know your thoughts then we can arrange either a suitable time for you to come and look at the cameras, or I can put the order in for the new hard drives and you can have a look when it is all done.

Dear Licensing team,

Having reviewed the information available on your website regarding the review of Kaos Nightclub's premises licence, I am writing on behalf of myself and my husband, Anthony Beardsmore, as interested people who live in the vicinity of Kaos Nightclub. Although the majority of incidents have been reported to the local police force, to date the occurence of incidents of drunken and disruptive behaviour has been so frequent and the responses of the local police force so dismissive that we have ceased to keep a log. PS Marshman's report summarises the majority of recent incidents which have been linked to Kaos. Unfortunately, we are unable to directly link every incident to the opening hours of Kaos, but since moving to Bellevue Road in November 2009 we have noticed a far greater rate of incidents, noise, disruption and damage to property during the period of the year which Kaos has opened than over the period it is not trading. In general, Bellevue Road suffers from high levels of noise, disruption and damage to property and we believe that a large proportion of this can be attributed to Kaos's poor dispersal practices. As the club opens both during the week and at weekends, the amount of noise and disruption is disturbing on an almost daily basis. Additionally, the recent increase of drink-fuelled violent assaults in the area is worrying and makes residents feel unsafe.

On another note, we were very disappointed to find that whilst PS Marshman has very sensibly raised our concerns in his notice of review document, he neglected to notify the Residents' Association of his review thereby seriously reducing our ability to comment on these matters. I am sure that many other of the local residents would have been willing to contribute to this review if they had been made aware it was happening.



The Residents Association was only informed of this review on the evening of 30th August giving us extremely little time to put together our comments. I have attempted to do the best I can below in the very limited time available.

Bellevue Road is regularly used as a shortcut between the bars on London Road and Bedford Place and the clubs on St Marys Rd and Onslow Rd. Because of this residents are subjected to noise from shouting, chanting and screaming, cars are damaged, residents doorways are urinated and vomited in, residents are verbally abused, houses are grafitti-ed and on several occasions the balconies of houses are climbed up.

Our concerns regarding this license are on the grounds of the prevention of crime and disorder and the prevention of public nuisance.

These problems occur on every night of the week from approximately 9pm til 4am, the early incidents being people already drunk coming from the bars to the clubs and the later incidents being them leaving the clubs and returning home. The fact that issues occur before people enter the clubs suggests that people are being allowed in who are already too drunk.

Residents have recorded an increase in incidents on the nights that Kaos is open (Monday, Wednesday, Friday and Saturday) with a particular increase just after 2am when Kaos closes. Around this time there are regularly large groups travelling up Bellevue Road from St Marys/Onslow Road waking up residents by shouting and knocking over bins. Groups have been seen by residents leaving Kaos before reaching Bellevue Road. Several months ago we had a positive meeting with the owners of Kaos in which they agreed to position door staff on Bellevue Road just before the club empties out at 2am. We hope that this will reduce the 2am issues when the club reopens although the lack of compliance highlighted in PS Marshman's report is a concern.

The issues above have been ongoing for several years and have been reported previously (specifically mentioning Kaos) to Richard Black at the licensing department, the ASB team at Southampton City Council and Inspector Bates and others in the police.

I have today handed in to the civic centre a DVD of CCTV footage taken from two cameras on the front of my house at 25 Bellevue Road. One camera points down the road towards St Marys and Onslow Rd and the other points up towards London Rd. There are two sets of recordings on the disk; Misc shows a selection of incidents and 2am shows groups of people travelling up Bellevue Road from St Marys/Onslow Road at 2am. This disk is an example selection of recordings and is in no way an exhaustive list.

For periods of time residents have listed incidents and passed these to the police but as the incidents have continued without signs of any action we have stopped doing this. We would be happy to provide these lists.

Below is the content of the CCTV:

Misc

- -7 examples of people urinating on driveway, coming from both ends of Bellevue Road. This occurs several times a week at several houses. As can be seen in the recording this is right beside or in front of residents front doors and on their property.
- -person banging on door in the early hours of the morning -person kicking garage door at around 2am -examples of a group who repeated came around the same time late on wednesday nights over 2 months. group came up steps on to front door to have their picture taken causing noise and waking me up. Presumably because one of them had been told to get off the driveway after causing a disturbance on a previous occasion. The Residents Association was only informed of this review on the evening of 30th August giving us extremely little time to put together our comments. I have attempted to do the best I can below in the very limited time available.

Bellevue Road is regularly used as a shortcut between the bars on London Road and Bedford Place and the clubs on St Marys Rd and Onslow Rd. Because of this residents are subjected to noise from shouting, chanting and screaming, cars are damaged, residents doorways are urinated and vomited in, residents are verbally abused, houses are grafitti-ed and on several occasions the balconies of houses are climbed up.

Our concerns regarding this license are on the grounds of the prevention of crime and disorder and the prevention of public nuisance.

These problems occur on every night of the week from approximately 9pm til 4am, the early incidents being people already drunk coming from the bars to the clubs and the later incidents being them leaving the clubs and returning home. The fact that issues occur before people enter the clubs suggests that people are being allowed in who are already too drunk.

Residents have recorded an increase in incidents on the nights that Kaos is open (Monday, Wednesday, Friday and Saturday) with a particular increase just after 2am when Kaos closes. Around this time there are regularly large groups traveling up Bellevue Road from St Marys/Onslow Road waking up residents by shouting and knocking over bins. Groups have been seen by residents leaving Kaos before reaching Bellevue Road. Several months ago we had a positive meeting with the owners of Kaos in which they agreed to position door staff on Bellevue Road just before the club empties out at 2am. We hope that this will reduce the 2am issues when the club reopens although the lack of compliance highlighted in PS Marshman's report is a concern.

The issues above have been ongoing for several years and have been reported previously (specifically mentioning Kaos) to Richard Black at the licensing department, the ASB team at Southampton City Council and Inspector Bates and others in the police.

I have today handed in to the civic centre a DVD of CCTV footage taken from two cameras on the front of my house at 25 Bellevue Road. One camera points down the road towards St Marys and Onslow Rd and the other points up towards London Rd. There are two sets of recordings on the disk; Misc shows a selection of incidents and 2am shows groups of people traveling up Bellevue Road from St Marys/Onslow Road at 2am. This disk is an example selection of recordings and is in no way an exhaustive list.

For periods of time residents have listed incidents and passed these to the police but as the incidents have continued without signs of any action we have stopped doing this. We would be happy to provide these lists.

Below is the content of the CCTV:

Misc

- -7 examples of people urinating on driveway, coming from both ends of Bellevue Road. This occurs several times a week at several houses. As can be seen in the recording this is right beside or in front of residents front doors and on their property.
- -person banging on door in the early hours of the morning -person kicking garage door at around 2am -examples of a group who repeated came around the same time late on wednesday nights over 2 months. group came up steps on to front door to have their picture taken causing noise and waking me up. Presumably because one of them had been told to get off the driveway after causing a disturbance on a previous occasion.
