

Legal Implications

1. The Licensing Act 2003 specifically restricts the grounds on which the Council, as Licensing Authority (LA), may refuse an application for a new Premises Licence, or impose conditions. Where relevant representations are made, the LA may refuse on the grounds that the licensing objectives are not met or the operating schedule is inadequate. Equally, conditions may be imposed where relevant and necessary. The LA may also refuse an application in part and thereby only permit some of the licensable activities sought.

- The decision making committee, in considering an application, must have regard to the adopted Statement of Licensing Policy and any relevant representations made by those directly affected.
- 3. An applicant for a new Premises Licence whose application has been refused, or who is aggrieved by conditions imposed, may appeal against the decision to the Magistrates' Court.
- 4. In considering this application the committee will sit in a quasi-judicial capacity and is thus obliged to consider applications in accordance with both the Licensing Act 2003 (Hearings) Regulations 2005, and amending secondary legislation and the rules of natural justice. The practical effect of this is that the committee must makes its decision based on evidence submitted in accordance with the legislation and give adequate reasons for reaching it's decision.

The committee must also have regard to:-

5. Crime and Disorder Act 1998

Section 17 of the Crime and Disorder Act 1998 places the Council under a duty to exercise its various functions with due regard to the likely effect of the exercise of those functions on, and the need to do all that it reasonably can to prevent, crime and disorder in its area.

6. Human Rights Act 1998

The Act requires UK legislation to be interpreted in a manner consistent with the European Convention on Human Rights. It is unlawful for the Council to act in a way that is incompatible (or fail to act in a way that is compatible) with the rights protected by the Act. Any action undertaken by the Council that could have an effect upon another persons Human Rights must be taken having regard to the principle of Proportionality - the need to balance the rights of the individual with the rights of the community as a whole. Any action taken by the Council which affect another's rights must be no more onerous than is necessary in a democratic society. The matter set out in this report must be considered in light of the above obligations.

P Describe the steps you intend to take to promote the four licensing objectives:

a) General - all four licensing objectives (b,c,d,e) (please read guidance note 9)

We are a national retailer that sells alcohol as part of a broad offering of goods and services. We have held off-licences in our stores for many years and are an approved British Institute of Inn-keeping examination centre. We have written training policies and formal training programmes are in place, which ensure our people are equipped to meet all licensing objectives. All training and revision/refresher materials are reviewed regularly. All stores currently comply with our 'Think 25' policy, this is brought to customer's attention through point of sale material within the store. We take legal compliance very seriously and in addition to local training we employ a central alcohol licensing compliance manager and have a compliance committee.

b) The prevention of crime and disorder

The premises will have digital CCTV system that covers many areas of the shop floor, including the proposed area which will be used for beer and wine, should we be successful with our application. Images will be retained for a minimum of 21 days and made available on enforcement request. Ordinarily, a member of the Management team will be on the premises all the time the store is open. A person will have responsibility for the premises whilst the premises are open.

c) Public safety

A person will have responsibility for the premises whilst the premises are open. Management will be trained to support the running of the premises including looking after our customers and staff. The store will adhere to all rules and regulations relating to public safety.

d) The prevention of public nuisance

We intend to be an active member of the community.

We welcome the opportunity to liaise with Police and enforcement authorities should the need arise.

e) The protection of children from harm

All staff will be trained and regularly refreshed in the corporate 'Think 25' Policy. Staff will be trained to look at the customer and 'Think 25' when selling alcohol.

A till prompt will appear on the initial sale of alcohol that will remind the seller of their responsibilities including not to sell alcohol to anyone under the age of 18.

The store will display signage around the premises informing both staff and customers of our 'Think 25' policy on alcohol.



My name is Kevin John Haines I am 57 years of age and lived in the area for a long time and used to use the pub as a regular, I live 100 yards away from this new tesco's. I am sorry to say that if this new Tesco's was to open with a alcohol licence it will have a big impact on the area with anti social behaviour purely because I have noticed in the past kids smashing cars and windows of flats because of alcohol and they tend to congregate in that area and the subway which is very close to the site were Tesco is being built. Kids tend to intermediate people that use the subway. Youths use that subway as a shelter to drink inn. I have noticed trouble from youths hanging about outside the pub when I used to use it when it was a public house. I also noticed fights with drunken youth in the pub and outside the pub. There for I strongly recommend you consider this very carfully because it will cause allot of danger in the area and as you would know there are allot of elderly residents that live near this pub. Recently there has been a alcohol licence refused at three stores in that area due to crime and disorder and anti social behaviour. And the protection of children from harm. Two of these stores are 200 yards away from the new tesco's site which have recently been refused. One was a Best Buy store in aldermoor road and another was Premier Store in Aldermoor road. The third store was in aldermoor avenue which got refused. If this tesco store was to get granted a licence it will only bring youths out of there hole and get them doing bear runs from tesco's which is known around the area from previous shops that have been opened there. Also there is a children's home near this tecos's site and a rose road centre which holds disabled people there as a rest home and a school. We would not like to see these people put at danger.

The new site were tesco's is in, is on the corner junction of coxford Rd and Lordswood road which is on a major busy road that leads to the general hospital and I know from previous problem in the area with youth stealing bear from shops and causing problem for the public when they are drunk they will be running into tesco's and taken the bear which will cause them to run on the major busy road and get run over. Please as a resident I would not want to have sleepless nights and fear in living in my own home. I know there was a youth that got murdered in the area called Daniel loader who got stabbed due to getting so drunk when he was under age and got himself involved in a fight and got killed. I would strongly recommend you refuse this application for an alcohol licence to Tesco's Express. Also I would like to mention I know tesco's will say that they will have a security guard on site but youths this day and age will even put the security guard at risk because there was a co op store in Aldermoor road a few years ago who had to close down due to anti social behaviour and this Daniel loader getting stabbed. This co op had a security guard when is was running and youths still managed to get passed him and put him in danger and still caused theft and alcohol problem which caused the store to close down. On behalf of the Chief Officer of Police I am writing to lodge a representation of the above application on the following grounds:

- 1) The prevention of Crime and Disorder
- 2) Public Safety
- 3) The Prevention of Public Nuisance
- 4) Protection of Children from Harm

The police have concerns over the application. These concerns are outlined below:

The Tesco application is proposed for the site which used to be the Woodman Public House on the corner of a large junction where Lordshill Way becomes Lordswood Road and Coxford Road crosses at this junction. There is a nearby 'One Stop' which is on Coxford Road and has an alcohol licence between 0800 and 2300 hours which staff state is due to shut on the opening of the Tesco with staff transferring to that premises. There have been numerous thefts at the One Stop; there are fifteen which are detailed in the incident report attached with this objection, then another incident which is on page 5, dated 24/12/10 where someone tried to leave the premises with alcohol and when a member of staff stopped the person they were assaulted.

The One Stop closing means that the youth nuisance that they have suffered outside the premises is likely to transfer to the Tesco site. An example of the types of problems that the 'One Stop' have suffered can be seen on page 4 of the incident sheets, dated the 02/03/11 details that large group of youths were hanging around outside the shop being abusive to the customers. Further examples of these problems can be seen on page 5, dated 23/10/10 which shows that youths have been running in and out of the premises being abusive to staff, with about ten youths in total.

The Woodman Public House which shut in the middle of 2011 has suffered youth nuisance problems before closing and some incidents have been reported since. The most recent incidents of youth nuisance can be seen on Page 2, dated 10/08/11 and 08/08/11 refer to youths taking bottles out of the bottle bank on the site and throwing them.

There are other incidents of youth nuisance reported in the area, an example on page 3 of the incident sheets, dated 16/06/11 and 07/05/11 there are youths congregating and throwing items at passing cars and also youths throwing stones at elderly persons windows. On that last incident at the bottom it can be seen that part of the safer neighbourhood (SNT) priorities are "underage drinking and the acquisition of alcohol by juveniles" The youth nuisance is a concern with regards to public nuisance but also where youths are loitering around licensed premises they are often attempting to persuade customers to buy alcohol on their behalf, an example of this is on page 9, dated 12/03/10, there is a report of youths outside the One Stop requesting alcohol from customers. This causes concern under the licensing objective of the protection of children from harm.

The applicant has already put on the application schedule CCTV, staff training, challenge 25 with signage and a till prompt for age related sales. In discussion with the applicant before a decision to object was made they agreed to our wording for those conditions. In that discussion with them it was requested that they consider taking on a refusal book and incident book. Their response, as seen on their e-mail, was that they record incidents on their own system and did not feel a specified incident book was required and neither was a refusal log book. The request that they consider a security guard in place was not answered in their response and if a licence were to be granted by the panel then security staff is strongly recommended to be able to deal with youth nuisance issues and theft concerns. It would also be advisable that there be full CCTV coverage externally be in place as a deterrent for youths and to support the security staff when dealing with incidents outside.

It is felt by Hampshire Constabulary that the granting of a licence may increase the anti-social behaviour in the area. There are concerns that there would be an increase in theft incidents and staff putting themselves at risk when challenging shop lifters. This would all lead to an impact under crime and disorder, public nuisance and public safety with the concerns about youths and proxy sales or thefts causing a concern under the protection of children from harm. The additional conditions suggested with the conditions already agreed would assist in minimising the impact on the community.

To address the Police concerns regarding our proposed store at Lordswood Road, Southampton we would request the following conditions be added, if granted.

- Staff are trained regarding appropriate precautions to prevent the sale of alcohol to persons under the age of 18; signs and symptoms of drunk persons, refusal of sale due to intoxication and that records are kept of such training, which are signed and dated by the member of staff who has received the training; that staff receive refresher training and that records are signed and dated by the member of staff who undertakes the training. Records will be available for inspection by Hampshire Constabulary and the licensing Authority. Records will be kept for a minimum period of two years.
- There will be a Challenge 25 policy operated at the premises. All staff will be trained on the policy to challenge any one who appears to be under 25 years of age seeking to purchase or be supplied with alcohol at or from the premises. The customer shall produce means of identification acceptable to the licensing authority proving that individual to be 18 years of age or older. If the person seeking alcohol is unable to produce acceptable means of identification, no sale or supply of alcohol will be made to or for that person.
- CCTV
 - The premises shall have sufficient cameras located within the premises to many areas of the premises including the entrance and exit, checkouts and main alcohol display area. The system should be able to cope with strobe lighting and all levels of illumination throughout the premises as well as outside areas CCTV warning signs to be fitted in public places.
 - The CCTV system must be operating at all times whilst the premises are open for licensable activity. All equipment shall have a constant and accurate time and date generation.
 - The recording system will be able to capture a minimum of 4 frames per second and all recorded footage must be securely retained for a minimum of 28 days.
 - There shall be sufficient members of trained staff at the premises during operating hours to be able to provide viewable copies to police on request when investigating allegations of offences or criminal activity. Any images recovered must be in a viewable format on either disc or VHS. Footage supplied in a digital format on CD or DVD will also have a copy of the CCTV system software enabled on the disc to allow playback.

We do not operate a refusal register as standard within Tesco. We believe neither us or any responsible authority gain any benefit from the operation. We currently have conditions regarding refusal registers on around 15 licences out of the 2000+ we operate.

Regarding an incident log. We have our own internal recording procedures to capture incidents as described below. I also note that I try and agree to conditions that relate to the licensable activities that are being carried out at the premises and not the general running of the premises

As discussed please see the below in relation to the new premises application for Tesco Stores Ltd on Lordswood Road, Southampton, SO16 6LN

I am dealing with the application and have asked the Sgt responsible for the area to let me know of any concerns about a licensed premises in that area and his response and any evidence he provides will guide me in whether any objections are made

Whilst awaiting that response there are a few things I would like to discuss with you. I have looked through the application and note that you are putting forward the following in the schedule:

Staff Training Challenge 25

CCTV

Please see the conditions below as this is the wording that we would expect on a current licence, these may be more detailed than previous conditions that you have seen. This is because the home office have advised that "to the satisfaction of hampshire constabulary" is unfair on the licensee as how are they to know what is to the satisfaction, so we have detailed exactly what we expect and this wording reflects that. Please have a look at the condition wording and let me know what response you have to it.

Training (you've put forward)

Staff are trained regarding appropriate precautions to prevent the sale of alcohol to persons under the age of 18; signs and symptoms of drunk persons, refusal of sale due to intoxication and that records are kept of such training, which are signed and dated by the member of staff who has received the training; that staff receive refresher training every six months as a minimum and that records are signed and dated by the member of staff who undertakes the training. Records will be available for inspection by Hampshire Constabulary and the licensing Authority. Records will be kept for a minimum period of two years.

Challenge 25 (you've put forward)

There will be a Challenge 25 policy operated at the premises. Challenge 25 meaning that the holder of the premises licence shall ensure that every individual who appears to be under 25 years of age seeking to purchase or be supplied with alcohol at or from the premises shall produce means of identification acceptable to the licensing authority proving that individual to be 18 years of age or older. If the person seeking alcohol is unable to produce acceptable means of identification, no sale or supply of alcohol will be made to or for that person.

CCTV (you've put forward)

The premises shall have sufficient cameras located within the premises to cover all public areas including outside of the premises covering the entrance and exit. The system should be able to cope with strobe lighting and all levels of illumination throughout the premises as well as outside areas

CCTV warning signs to be fitted in public places.

The CCTV system must be operating at all times whilst the premises are open for licensable activity. All equipment shall have a constant and accurate time and date generation. The recording system will be able to capture a minimum of 4 frames per second and all

recorded footage must be securely retained for a minimum of 28 days.

Records must be made on a weekly basis and kept for inspection to show that the system is functioning correctly and that data is being securely retained.

The DPS or premises manager must be able to demonstrate that the CCTV system has measures to prevent recordings being tampered with, i.e. password protected.

There shall be sufficient members of trained staff at the premises during operating hours to be able to provide viewable copies to police on request when investigating allegations of offences or criminal activity. Any images recovered must be in a viewable format on either disc or VHS. Footage supplied in a digital format on CD or DVD will also have a copy of the CCTV system software enabled on the disc to allow playback.

In the event of technical failure of the CCTV equipment the Premises Licence holder/DPS MUST report the failure to the Southampton Police Licensing Unit.

I would ask that you also consider the following conditions to support the licensing objectives **Refusals book**

A refusals book to be kept detailing numbers, dates and times of incident and description of people refused service of alcohol with reasons why(Including incidents relating to disorder) to the reasonable satisfaction of Hampshire constabulary. The refusals book will remain on the premises at all times and will be available to police upon request.

Incident book (this can be combined with the refusals book)

An incident book will be provided and maintained at the premises. It will remain on the premises at all times and will be available to police for inspection upon request.

Any incidents that include physical altercation or disorder, physical ejection, injury, id seizure or drug misuse will be recorded in the incident book. The entry is to include an account of the incident and the identity of all person(s) involved (or descriptions of those involved if identity is not known). Should there be any physical interaction by members of staff and the public the entry will include what physical action occurred between each party. The entry shall be timed, dated and signed by the author.

If the member of staff creating the entry has difficulties reading or writing then the entry may be written by another staff member. This should however be read back to the person creating the entry and counter signed by the person who wrote the entry.

At the close of business on each day the incident book will be checked by the manager on duty where any entries will be reviewed and signed. If incidents have occurred the duty manager will de-brief door staff at the close of business. Should there be no incidents then this will also be recorded at the close of business in the incident book.

I know that in the wider area of Aldermoor & Lordshill there have been concerns in the past about anti-social behaviour issues and also youths with alcohol and therefore do request that you consider security staff as part of your application
