

## **Appendix 1**

### **Proposal to expand Springwell School**

The Local Authority are proposing to expand Springwell School by 8 places from November 2012. An initial six week consultation period on this proposal begins on 22 June 2012. Further information on the proposal and the consultation, as well as details on how you can comment, can be found in this document.

#### **Reasons for the proposal**

There is currently a high demand for places at Springwell and, at present, the demand exceeds the number of places currently available at the school. The increased demand can be attributed to:

- An increase in the birth rate and consequently the total number of children living in the city
- Advances in child health and maternity services which means an increase in the numbers of children surviving with more complex needs

In order to ensure that the City can cater for the needs of all its children it is proposed that the Number on Roll at Springwell school be increased by 8 (one class group) to accommodate the additional children whose needs have been assessed and who would be appropriately placed at Springwell.

Springwell School currently has 64 places available and offers support to children with Learning Difficulties (including severe learning difficulties and autism). There are no plans to change the type of SEN provision available at the school. This consultation is about the possibility of expanding the number of places available at Springwell.

#### **Why is Springwell the only school that is being proposed to expand?**

This proposal is being put forward as a result of the detailed assessment of the special educational needs of each of the children that require additional educational support. Springwell provides support for children with learning difficulties (including severe learning difficulties and autism) and is the school best suited to supporting the needs of the additional children. If the proposal were approved, it will enable the City Council to offer a place to all of the children for whom Springwell is considered to be the appropriate provision. The Local Authority are required to ensure that provision is in place to meet the assessed special educational needs of individuals, whilst also taking into consideration any preference expressed by a parent.

There is no other school in the City that could offer the same level and quality of support for these children, and as a result, the expansion of Springwell is the preferred option that is being put forward in response to the rise in pupil numbers.

The only alternatives to expanding Springwell would be to direct mainstream schools to admit these pupils or to seek to secure placements outside of Southampton. However, mainstream schools may not have the specialist

staff and facilities or be able to meet the additional costs associated with supporting these children and provision of places outside of the City will involve significantly higher costs both to the Council and parents in relation to travel and transport costs and cost of securing places in other settings. It is unfair to expect young children to travel long distances on a daily basis to access education. Furthermore, it is considered that such an option would not meet the Council's duties to provide adequate provision to meet assessed need within the City and would result in practical difficulties for families with children attending other city schools. Either of these options could lead to a number of SEN Tribunals if these placements were challenged by parents. The expansion of Springwell, if approved, would mitigate these risks and is the preferred option for accommodating additional children. It would also meet the requirements of the SEN Improvement Test.

### **How will the extra children be accommodated?**

If the additional children joined the school in November, an extra classroom, similar to those that already exist at the school (i.e. fully DDA compliant with accessible toilets) would be required. Given the short timescales, it is proposed that the new pupils would occupy teaching space in the existing school building and Year 6 pupils will be relocated to a modular classroom which would be located on the school site. The school would also need an extra teacher and 3 special school assistants to support the extra pupils.

The expansion of the school across all year groups will be subject to a review of the future demand for places at the school. If the school expanded further, additional teaching space and staff would be required.

### **Timescales**

#### Pre-Statutory Consultation: 22 June 2012 – 3 August 2012

This first stage of consultation will give staff, pupils, parents and members of the community an opportunity to find out further information and comment on the proposals.

#### Statutory Consultation: August – September/October 2012

If the Local Authority (after reviewing any responses to the first stage of consultation) decide to proceed with the proposal, a formal notice will be published at the school and in the local newspaper and there will be another 6 week consultation period for people to comment.

#### Final Decision: October / November 2012

The final decision will be made by the Local Authority in October / November 2012.

#### Implementation: November 2012

If the proposals are approved by Cabinet, the additional places will be available at the school from November 2012.
