BRIEF SUMMARY

The Health and Social Care Act 2012 introduces the requirement for Health and Wellbeing Boards to develop a Joint Health and Wellbeing Strategy and for upper tier local authorities and clinical commissioning groups to adopt them. Southampton's shadow Health and Wellbeing Board has been developing a Joint Health and Wellbeing Strategy (JHWS), and the Strategy now requires adoption by both the Cabinet and Southampton City Clinical Commissioning Group.

The shadow Health and Wellbeing Board was constituted by the Council in November 2011 and its current representation following the annual meeting of the Council in May 2012 comprises:

- The Cabinet Member for Communities
- The Cabinet Member for Health and Adult Social Care
- The Cabinet Member for Children's Services and Learning
- 2 elected councillors opposition political groups
- The Director of Public Health
- The Director of Health and Adult Social Care
- The Director of Children's Services and Learning
- A representative from the Southampton Clinical Commissioning Steering Group
- A representative from Southampton LINk
- A representative from the SHIP PCT cluster

RECOMMENDATIONS:

- (i) That the Joint Health and Wellbeing Strategy be adopted
- (ii) That authority be delegated to the Director of Public Health, following consultation with the Cabinet Member for Communities to make any minor drafting or other amendments required following consideration of the strategy by Southampton City Clinical Commissioning Group.

REASONS FOR REPORT RECOMMENDATIONS

1. To complete the process of producing a Joint Health and Wellbeing Strategy for Southampton.

ALTERNATIVE OPTIONS CONSIDERED AND REJECTED

2. None. It is a duty under the Health and Social Care Act 2012 to produce a Joint Health and Wellbeing Strategy.

DETAIL (Including consultation carried out)

- 3. The Joint Health and Wellbeing Strategy (JHWS) is a strategy for meeting needs identified in the Joint Strategic Needs Assessment. It identifies the priorities the Health and Wellbeing Board has identified for meeting those needs. The Health and Social Care Act 2012 places a duty on Health and Wellbeing Boards to produce the JHWS, which must be adopted by the local authority and each clinical commissioning group in the local authority area, and which the local authority must publish.
- 4. Following agreement to a draft consultation strategy in June 2012 a 3 month period of consultation and engagement was undertaken with stakeholders and the general public. The shadow Health and Wellbeing Board then considered a summary of the comments from the consultation exercise, and concluded the strategy should be structured around the following themes:
 - Building resilience and prevention to achieve better health and wellbeing
 - · Best start in life
 - Ageing and living well
- 5. The strategy was subsequently re-drafted around these themes. Each theme then had a number of actions identified to deliver improvements to health and wellbeing and reduce health inequalities. Measures were identified, mainly from the national outcomes frameworks, against which progress will be tracked, and these are also set out in the strategy document.
- 6. A series of briefings have been held to provide information to key stakeholders on the content of the revised strategy. The text has been submitted to a lay reading panel co-ordinated through Southampton LINk. The updated strategy text is now attached as Appendix 1 to this report and is being presented to both the Cabinet and the Southampton City Clinical Commissioning Group for formal adoption.
