The document is due to be published as local, informal guidance in the new year. This will provide an opportunity to test and develop the principles which will later be adopted as a Supplementary Planning Document. We are planning for this document to form part of the evidence base for the new Southampton City Vision Local Plan and for it to be published in line with relevant timescales. The timetable for the Local Plan's development will be published in the Council's updated Local Development Scheme once Cabinet approval has been received. In the interim, even as informal guidance the document will be able to start influencing how we manage air quality issues within our local planning processes.</p>

It is proposed that the Council instead adopts a single Social Value and Sustainability Procurement Policy and an associated framework to help drive improved social and local economic value through its buying and procurement activities. A new approach to sustainability will more directly align with the Green City Charter. The proposed content is still under development prior to recommendations being submitted to Cabinet for consideration.</p>
