#### How can we contribute to addressing these issues through the Local Plan?

A Local Plan must demonstrate that sufficient land has been allocated to deliver new homes, workspaces and infrastructure. It must also show that these sites are the most suitable and that proposals are sustainable and deliverable. Southampton aspires to develop a city that is child-friendly and is a space that children, young people and families will want to play, stay and work in for most, if not all, of their lives.

#### But how are we going to do this?

Whilst we know there are things that we must include in our new plan, you now have the opportunity to influence how we do this and ensure we create places that reflect your needs and you are proud to call home. Firstly, we need to understand what facilities matter most to you so that we can ensure we are maintaining and improving what you really value.

## Neighbourhood and city pride, a sense of community.

We want residents to be proud of where they live and work and enable them to influence what can and cannot be built in the coming decades. The playability and movability of the space, particularly for children, is vital to how we want the city to grow and develop. Homes for a growing and ageing population						

## growing and ageing popi

By 2040 the total population of Southampton will have increased by around 26,000. Over half of this increase will be in people aged 65 and over. Southampton City Council (like all planning authorities) has a target for the number of new homes it must build each year. This is set by central government and is based on how much the population is expected to grow and how affordable it is to buy a home in the area. The government's target for Southampton is to build over 20,000 new homes by 2040, equivalent to just over 1,000 per year. Southampton City Council has also committed to provide 1000 new Council owned homes by 2025, which will contribute to the overall target. Our new plan will have to show how we will meet this target and we need to understand what types of homes we will require to meet the needs of our population, including children, so that every child born and living in Southampton has the best possible start in life.

#### More homes

The target of 1000 new homes per year (around 20,000 more homes by 2040) is challenging as space is limited so we need to think about how we can deliver the new homes we need.

## **Technology**

Southampton has a long history of leading the way in technology and design. How could technology change the way we live, work and engage with the world around us in the future? Whilst there are lots of positive benefits of new technology, we must also consider the fact that there may be negative impacts as a result of introducing them within our city. For example, although technology connects us, it can sometimes replace human interaction. As such, there may be possible social impacts from introducing new technologies such as the loss of jobs or some businesses. However, it is just as important to consider the fact that this new technology may give the opportunity for new jobs and businesses to be created, which could in turn help our city thrive.

## Getting around the city

As one of the largest cities on the south coast, Southampton is a popular visitor and cultural destination. This city has an excellent educational offering from its two universities which currently have around 35,000 students enrolled between them. On top of this, one quarter of the population is under 16 and we want children who grow up in the city to have access to the best the city has to offer.

We need to make sure that development is designed in a way that enables people to get around with ease, have equal opportunity to access all of the great facilities we have and to feel safe and welcome across all of our neighbourhoods.

Southampton is also a port city and a regionally important employment and retail centre which means it is reliant on good transport links by sea, road and rail. As the city grows and changes we need to invest in more sustainable ways of getting around and use road space more efficiently. Last year a new Local Transport Plan, Connected Southampton, was approved and published after a period of consultation. The Transport Strategy sets out the long-term vision and approach for transport planning and investment through to 2040. ## Growth and investment in the city

Following the launch of the city's Master Plan in 2012, Southampton has attracted £3bn of investment and 6 out of the 7 major projects are now completed or underway. Forecasts produced by the Solent Local Enterprise Partnership (LEP) indicate that Southampton has the potential to be the key focus of jobs growth in South Hampshire over the next 20 years. This is based upon its key assets of the port, the city centre, higher education, and the opportunities presented by new technologies – digital, artificial intelligence (AI), and autonomy. The challenge for the city is to attract, accommodate and manage the growth that will come with the expansion in these industries in a way that is environmentally and socially sustainable and brings benefits to our residents.

The city will also need to apply positive solutions to the challenges that face our key shopping areas across the city, which have been brought about by changes in consumer behaviour. It is vital that everyone, including children and families, feels able to access and interact with the resources they need and that we, as a city, have an exciting and vibrant cultural offer.
