# What you need to know about what is happening to you





This guide has been put together by the Young People in Care Council or (YPiCC) for short. YPiCC are children from the Southampton area who are unable to live with their parents and live either with a friend, a family member or in foster care. This booklet was put together by these children in order to help you to understand WHAT IS GOING ON.

# **YPiCC Top Tip**

You are probably really scared. But don't worry, you're not alone, there are lots of people in your shoes. There are people who will help you, other children who are just like you and people who will listen to you.



# 2. What the law says

You're probably asking why this has happened to you and when you can go home. We thought it would be helpful to include some information about how you come into care and what the law says. Speak to your Social Worker to gain an understanding of why you came into care and Jot it here:

### Somewhere to Jot & Doodle...

#### Accommodation Section 20

This is when the parents ask Children's Services to look after their child. The courts do not need to be involved.

#### Interim Care Order

This is a temporary order so that the social worker can check if the child is safe. If there are dangers to the child, a full care order can be made.

#### Care Order Section 31

This is where Southampton City Council shares parental responsibilities. The courts must be involved.

The Court will also ask a Cafcass Worker to meet with you and speak to you about how you feel about plans. Remember to be open and honest.





# **3: Where I Live**

When you are 'looked after' by Southampton Social Services you might live with friends, family members or foster carers. Despite whether you may or may not know your carers they have all put themselves forward to look after children.

# Although you will be part of a new family, your foster family will not replace your biological family

# 4. Questions....questions..... so many questions going round and round and round in my head!

Do you have any other children living in the home? Are these foster/adopted or birth children?

Will I be able to have contact with my family?

What are the house rules?

# **YPiCC Top Tip**

If you don't know what the rules are ask your carer or someone else living in the home.



When you come into care there are lots of people that you are likely to come into contact with. It can be a bit confusing so here are some brief details to help you sort out what everyone does and who they all are.

You will have your own, named social worker. He or she will visit you within the first week of moving to your new foster home, then every 6 weeks.

#### My Social Workers name is:

Just like you, your foster carer has a social worker too. They are responsible for making sure that your foster carers are doing a good job and are looking after you.

# **6. All those people** all those meetings, all that paperwork!

## **Health Meetings**

When you come into care a Doctor will contact you within 28 days and you will have an appointment to check your weight, height and physical and mental health. This appointment is called a medical or health assessment.

## Looked After Children Meetings also called LAC Reviews.

This is organised by someone independently.

## Personal Education Plans also called PEP

A Personal Education Plan (P.E.P) is held at your school and focuses on education.

# **YPiCC Top Tip**

If you don't want to attend your meeting. You could ask someone you trust to talk on your behalf. REMEMBER if the meeting is about you, it is best to attend so you can share your views.

# 7. Sometimes I just need someone to listen



No Limits is a charity which offers free and confidential information, advice, counselling, support and advocacy for children and young people under 26 who live in Southampton and Hampshire. If you are in foster care, No Limits Just 4U service could provide you with an Independent Advocate to help you get your point across at meetings and find out about your rights, or an Independent Visitor who can meet with you once a month and do fun activities.

If you are leaving care No Limits, Next Steps service can support you to make decisions about your life and make positive transitions.
