To :

TAKE NOTICE that THE MAYOR ALDERMEN AND BURGESSES OF THE BOROUGH OF SOUTHAMPTON in pursuance of the provisions of Article 4 of the Town and Country Planning General Development Order 1950 on the Fourteenth day of January One thousand nine hundred and fifty two submitted to the Minister of Housing and Local Government a Direction that the provisions of paragraph (1) of Article 3 of the said Order should not apply to the rebuilding restoration or replacement of buildings works or plant which have sustained war damage on the land described in the Schedule hereto. The said Direction was approved by the Minister on the Twenty second day of March One thousand nine hundred and fifty two subject to the following modification :-

The words "on the said land of the dwellinghouses referred to in the Schedule hereto, being development comprised in Class XI of the First Schedule to the said Order and not being development of any other Class" shall be substituted for the words, "of buildings, works or plant which have sustained war damage on the said land."

In accordance with paragraph (4) of Article 4 of the said Order the said Direction shall come into force on the date of the service upon you of this Notice.

- (v) ✓ Number 35 Spring Crescent at Portswood in the County Borough of Southampton

W H E R E A S the Council of the County Borough of Southampton being the local planning authority for the said County Borough are satisfied that it is expedient that development of Class XI in the First Schedule to the General Development Order in respect of the land described in the Schedule hereto should not be carried out unless permission is granted on an application in that behalf under the said Order

NOW THEREFORE the said Council in pursuance of the powers conferred upon them by Article 4 of the Town and Country Planning General Development Order 1950 hereby direct that the provisions of paragraph (1) of Article 3 of the said Order shall not apply to the rebuilding restoration or replacement of buildings works or plant which have sustained war damage on the said land
