


# **Policies Map changes**








Portswood - Proposed Extension to District Centre




Portswood - Possible Extension to District Centre








Bevois Valley - Proposed Extension to Local Centre



Bitterne Park Triangle - Proposed Extension to Local Centre






St Mary's Road - Proposed Extension to Local Centre








Flood Defence Search Zone







