5.	The Policing and Crime Act 2009 amended the Local Government (Miscellaneous Provisions) Act 1982 with effect from 6 th April 2010, by introducing a new category of sex establishment called Sexual entertainment venues (SEVs) enabling local licensing authorities to adopt provisions for the regulation of lap dancing clubs and similar venues under Schedule 3 of the 1982 Act. Previously the power was limited to sex shops and sex cinemas.			

	On 11th July 2012, Council resolved to adopt the provisions of schedule 3 to the Local Government (Miscellaneous Provisions) Act 1982 which relate to the licensing of SEVs. The new regime came into force in Southampton on 20 th August 2012 (known as the "first appointed day"), after which a 12 month transition period has been in effect. The effect of the transitional period is that existing operators, who, immediately before the first appointed day, had a Licensing Act 2003 premises licence and lawfully used the premises as a sexual entertainment venue under that licence (or were undertaking preparatory work to use the venue in that way), were allowed to continue to provide relevant entertainment until the 20 th August 2013 (the "third appointed day") or the determination of any application they have submitted before the 20 th February 2013 (the "second appointed day"), whichever is later.
	The Legislation – Definitions
	Paragraph 2A of Schedule 3 as inserted by section 27 sets out the meaning of a "sexual entertainment venue" and "relevant entertainment" for the purposes of the statutory provisions.
	A sexual entertainment venue is defined as:
	"Any premises at which relevant entertainment is provided before a live audience for the financial gain of the organiser or entertainer."
	Relevant entertainment is defined as:
	"Any live performance or live display of nudity which is of such a nature that, ignoring financial gain, it must reasonably be assumed to be provided solely or principally for the purpose of sexually stimulating any member of an audience (whether by verbal or other means)."
	It should be noted that an audience can consist of just one person e.g. when the entertainment takes place in private booths.
	Relevant entertainment is therefore different from regulated entertainment as defined in the Licensing Act 2003.
6.	Hampshire Restaurants Limited has held a sexual entertainment venue (SEV) licence in Southampton since 22 nd October 2015 following a transfer application issued with delegated powers, with the licence to be renewed annually.
	Hampshire Restaurants Limited operate another Sexual Entertainment Venue in Bournemouth.
7.	On 26 th April 2023 an application was made by Hampshire Restaurants Limited to vary the Sexual Entertainment Venue licence in respect of 135 -136 High Street, Southampton.
