The Mazars report was published on NHS England's website on 17 December 2015 and highlights a number of actions for the Trust, commissioners and regulators.

At the 1 February 2016 meeting of the Health Overview and Scrutiny Panel (HOSP) the Panel considered the Mazars report with invited representatives and recommended that Southern Health, at an appropriate meeting, updates the Panel on progress implementing the improvement plan and feedback from regulators.
