## **BRIEF SUMMARY**

The first Southampton Council Tax Reduction Scheme was agreed by the Council on 16th January 2013 after it was announced that the Government's Council Tax Benefit (CTB) scheme would be replaced by individual schemes run by local authorities from April 2013. Subsequently the Southampton Council Tax Reduction Scheme has been approved each year under delegated authority by the Chief Financial Officer.

Section 13A of the Local Government Finance Act 1992 ("the 1992 Act") requires each billing authority in England to make a scheme specifying the reductions which are to apply to amounts of council tax payable by persons, or classes of person, whom the authority considers are in financial need ("a council tax reduction scheme").

The Council Tax Reduction Schemes (Prescribed Requirements) (England) Regulations 2012 ("the 2012 Regulations") prescribe matters which must be included in such a scheme in addition to matters set out in paragraph 2 of Schedule 1A to the 1992 Act. Each year regulations amending the 2012 Regulations are made in November/December. This ensures that pensioners are no worse off under any local council reduction scheme compared to CTB.

This report recommends changes to that agreed scheme to implement legislative changes and to take account of the annual benefits uprating which come into effect in April 2019.
