# Name or Brief Description of Proposal

## TCF City Centre - Albion Place Bus Hub

The Albion Place Hub scheme will deliver a new consolidated bus hub and interchange on the site of the Albion Place car park and a new landscaped open space area on the Castle Way car park. This will provide 10 new bus stops, increasing from current 6, at the Albion Place car park and on Castle Way (road) to provide for 10 new bus stop locations.

The aim of this assessment is to assess the impact the project will have on protected characteristic groups and the safety of the general public. If any negative impacts are identified, mitigations will be proposed to minimise them as far as reasonably practicable.

## **Brief Service Profile (including number of customers)**

Transport Highways and Parking services is responsible for the policy and strategy relating to all transport activities in the City. It is also responsible for strategic direction of the maintenance and management of the highway network including maintenance and enforcement of all parking related functions.
