COUNTY BOROUGH OF SOUTHAMPTON.

**BYE-LAW**

WITH RESPECT TO MUSIC IN THE STREETS.

WHEREAS, by the Municipal Corporations Act, 1882, it is enacted "that the Council may from "time to time make such Bye-Laws as to them "seem meet, for the good rule and government of "the borough, and for the prevention and sup- "pression of nuisances not already punishable in a "summary manner by virtue of any Act in force "throughout the borough, and may thereby appoint "such fines, not exceeding in any case five pounds, "as they deem necessary for the prevention and "suppression of offences against the same."

Now, therefore, the Council of the County Borough of Southampton, in pursuance of the powers aforesaid, at a meeting duly held on the 22nd day of November, 1899, at which meeting 36 members of the Council (being more than two-thirds of the whole number of the Council) were present, do hereby make the following Bye-Law, viz. :—

Any Person who shall sound or play upon any musical instrument, or sing in any public place or highway within fifty yards of any dwelling house after being required to desist by an inmate of such house, personally or through his or her servant or through a Constable, shall be liable to a penalty not exceeding Five Pounds, provided always that this Bye-Law shall not apply to any properly conducted Religious Service.
