WEIGHTS AND MEASURES ACT, 1963

BYELAW RELATING TO THE SALE OF WOOD FUEL

The Mayor Aldermen and Citizens of the City of Southampton do hereby in pursuance of paragraph 2 of Part IV of Schedule 7 to the Weights and Measures Act, 1963 make the following Byelaw:-

Paragraph 1 of Part IV of Schedule 7 to the Weights and Measures Act, 1963 relating to the sale of Wood Fuel shall have effect throughout the City of Southampton.

The Byelaw may be cited as "The City of Southampton Sale of Wood Fuel Byelaw, 1966".

EXPLANATORY NOTE: (This Note is not part of the Byelaw)

The above Byelaw imposes in the City of Southampton and subject to the penalties laid down in the Weights and Measures Act, 1963, the following requirements in relation to the sale of wood fuel in quantities exceeding fourteen pounds and not exceeding ten hundredweights:-

- (i) wood fuel which is not made up in a container for sale shall be sold by retail only by net weight;
- (ii) in the case of a sale by retail of wood fuel made up in a container for sale, the quantity by net weight of the fuel sold shall be made known to the buyer before he pays for or takes possession of it.
