CITY OF SOUTHAMPTON

B Y E L A W S

made by the Mayor, Aldermen and Citizens of the City of Southampton acting by the Council under Sections 12 and 15 of the Open Spaces Act 1906.

- (a) Throughout these byelaws the expression "the Council" means Southampton City Council and the expression "the Green" means the open space at Bassett Green in the said City known as Bassett Green.
- (b) A person who has attained the age of twelve years shall not on the Green play or take part in any ball game:  
Provided that this byelaw shall not apply to any person who, being bona fide in charge of a child under the age of twelve years, plays or takes part in any ball game with that child.
- (c) Every person who shall offend against the foregoing byelaw shall be liable on summary conviction to a fine not exceeding twenty pounds.
- (d) Every person who shall infringe any byelaw for the regulation of the Green may be removed therefrom by any officer of the Council or by any constable, in any one of the several cases hereinafter specified: that is to say -
  - (i) where the infraction of the byelaw is committed within the view of such officer or constable, and the name and residence of the person infringing the byelaw are unknown to and cannot be readily ascertained by such officer or constable;
  - (ii) where the infraction of the byelaw is committed within the view of such officer or constable and, from the nature of such infraction, or from any other fact of which such officer or constable may have knowledge, or of which he may be credibly informed, there may be reasonable ground for belief that the continuance on the Green of the person infringing the byelaw may result in another infraction of a byelaw, or that the removal of such person from the Green is otherwise necessary as a security for the proper use and regulation thereof.
