CHILDREN AND YOUNG PERSONS ACTS 1933 TO 1963

(As amended by the Education Acts 1944 to 1962)

BYELAWS WITH RESPECT TO THE EMPLOYMENT OF CHILDREN

The Byelaws with respect to the employment of children made by the Mayor, Aldermen and Citizens of the City of Southampton on 26th August 1969, and confirmed by the Secretary of State on 4th November 1969, are hereby amended as follows:-

For Byelaw 5 there shall be substituted:-

" 5. WEEK DAYS ON WHICH A CHILD IS NOT REQUIRED TO ATTEND SCHOOL.

- (a) No child under the age of 15 years shall be employed on a Saturday or other school holiday for more than 5 hours or before 7.0 a.m. in the delivery of newspapers and other light goods or before 8.0 a.m. in other occupations or after 6.30 p.m. provided that the employment shall be so arranged that the child shall be free for rest and recreation for a continuous period of not less than 4 hours.
- (b) No child who has attained the age of 15 years shall be employed on a Saturday or other school holiday for more than 8 hours or before 7.0 a.m. or after 7.0 p.m. provided that the employment shall be so arranged that the child shall be free for rest and recreation for a period of not less than 1 hour between 12 noon and 2.0 p.m.
- (c) No child under the age of 15 years shall be employed for more than 25 hours in any week in which the school is not open.
- (d) No child who has attained the age of 15 years shall be employed for more than 35 hours in any week in which the school is not open."

For Byelaw 9 there shall be substituted:-

"A young person who has ceased to be of compulsory school age may be employed by his/her parent in street trading if in the parent's company and under the parent's supervision."
