BYELAW

Made under Section 164 of the Public Health Act 1875 and Section 87 of the Southampton Corporation Act, 1910, and Section 15 of the Open Spaces Act, 1906 and Section 10 of the Commons Act, 1899 by Southampton City Council.

1. The series of byelaws made under Section 164 of the Public Health Act, 1875, and Section 87 of the Southampton Corporation Act, 1910, and Section 15 of the Open Spaces Act, 1906, and Section 10 of the Common Act, 1899, by the Mayor, Aldermen and Citizens of the City of Southampton, acting by the Council with respect to PLEASURE GROUNDS, is hereby amended and extended as follows:

1. Paragraph B16 of the Schedule referred to in Byelaw 6(iii) of the aforesaid series is hereby repealed and the following paragraph substituted therefore

"(16) The path commencing on the east side of Hill Lane opposite its junction with Bellemoor Road and proceeding in a general east-north-easterly direction crossing the path described in paragraph (14) of this Schedule to meet the west side of The Avenue then passing beneath The Avenue by way of the subway cycle track and then from the east side of The Avenue proceeding in an easterly direction to the west side of Highfield Road by the junction with Khartoum Road."

2. This Byelaw may be cited as the City of Southampton Pleasure Grounds (Avenue Subway) Amendment Byelaw 1977.
