BYELAWS

Made under Section 164 of the Public Health Act 1875, Sections 12 and 15 of the Open Spaces Act 1906, Section 87 of the Southampton Corporation Act 1910 (as amended by Section 57 of the Hampshire Act 1983) and Section 10 of the Commons Act 1899 by Southampton City Council with respect of Pleasure Grounds.

1. The Series of Byelaws with respect of Pleasure Grounds made by the Council on 12th April 1967 and confirmed by the Secretary of State on 31st July 1967 as amended by Byelaws respectively made by the Council on 26th July 1977 and 22nd June 1981 and 3rd May 1985 and confirmed by the Secretary of State on 6th October 1977 and 28th July 1981 and the 9th October 1985 is hereby further amended and extended as follows:-

- (1) Paragraphs 6(ii) and (iii) shall be deleted and the following provisions substituted therefor:

6(iii) a person shall not except in the exercise of any lawful right or privilege ride any bicycle, tricycle or other similar machine in any part of the Pleasure Ground. Provided that paragraphs (i) and (ii) of this Byelaw shall not apply to The Common and provided that paragraph (ii) of this Byelaw shall not apply to any path, road or track in the Pleasure Grounds which, by notice conspicuously displayed, is designated by the Council as a path, road or track on which cycling is permitted.

6(iii) no person shall, except in the exercise of any lawful right or privilege, on any part of The Common:-

- (a) bring or cause to be brought any truck or barrow
- (b) drive or cause to be driven any vehicle other than a wheelchair or perambulator drawn or propelled by hand and used solely for the conveyance of a child or children or an invalid

- (c) ride any bicycle, tricycle or other similar machine

provided that paragraph 6(iii)(c) of this Byelaw shall not apply to any path, road or track on The Common, which by notice conspicuously displayed, is designated by the Council as a path, road or track on which cycling is permitted.

- (2) Part B of the Schedule to the Byelaw shall be deleted
- (3) These Byelaws may be cited as the City of Southampton Pleasure Grounds (Cycle Provisions) Byelaws 1986.
